ARTICLES OF INCORPORATION*

These articles of incorporation are submitted to the Crow Tribal LLC for the purpose of creating a corporation under the laws of the Apsaalooke (Crow) Nation.

ARTICLE I: NAME 1

1.1 The name of the corporation is: <u>Indigenous Medicine Institutional Review Board, LLC</u> (the Company).

ARTICLE II: DURATION

2.1 The duration of the Company will be perpetual.

ARTICLE III: PURPOSES

- 3.1 <u>Indigenous Medicine Institutional Review Board, LLC</u> is ✓a general for profit corporation, OR ☐a general for profit **close** corporation which will operate ☐with OR ?without Directors, and shall be organized under the laws of the Apsaalooke (Crow) Nation.
- **3.2** This Company is organized for the purposes of transacting any and all lawful business permitted under the laws of jurisdictions in which it may operate and specifically under the laws of the Apsaalooke (Crow) Nation.

ARTICLES OF INCORPORATION



ARTICLE IV: SHARES

- **4.1** The Company shall have authority to issue up to 100000000 shares of capital stock which shall all be common stock, each share without par value.
- 4.2 If this Company is organized as a close corporation pursuant to Article 3.1, the Company may include no more than twenty-five (25) shareholders.

ARTICLE V: DIRECTORS

- **5.1** Number of Directors. Unless this Company is established as a **close** corporation operating without Directors under provisions of Title 18, Chapter 3, Part 8 of the Crow Law and Order Code, the number and terms of directors of this Company shall be fixed by the bylaws and may be increased or decreased from time to time in the manner specified therein.
- **5.2** Initial Directors. The directors constituting the initial board of directors, who will serve as directors until the first annual meeting of shareholders or until their successors shall be elected and qualify are:

5.3 Close Corporation Without Directors. The shareholders of the Company have entered into or will enter into a shareholder agreement which establishes that it will operate without a board of directors.

ARTICLE VI: SPECIAL PROVISIONS FOR CLOSE CORPORATIONS

6.1 This corporation is a statutory close corporation which restricts the transfer of shares.
