XII. GENERAL PROVISIONS

Provided, however, that:

(c) Developer specifically reserves the absolute and unconditional right (subject only to VA approval as set forth above, if required), so long as it owns any of the Property, to amend this Declaration without the consent or joinder of any party: (i) to conform to the requirements of any holder of a Mortgage, (ii) to conform to the requirements of title insurance companies; (iii) to conform to the requirements of any governmental entity having control or jurisdiction over the Property; (iv) to clarify the provisions of this Declaration; or (v) in such other manner as Developer may deem necessary or convenient. In addition, Developer may amend the Articles, Bylaws, and Rules and Regulations, and Architectural Guidelines unilaterally before Turnover without consent or joinder of any party.
