PLEASE, PLEASE, PLEASE UNDERSTAND THIS IS FOR THE SAFETY OF THE CHILDREN. IT MAY BE AN CONVIENENCE FOR A PARENT, BUT THE CHILDREN ARE OUR MAJOR CONCERN AS THEY ARE FOR YOU AS WELL.

PLEASE INFORM PARENTS THAT THEY CANNOT GRAB THEIR CHILD OFF THE FLOAT AS IT IS MOVING. WE WILL HAVE POLICE OFFICERS WATCHING FOR THIS DURING THE PARADE.

AT THE END OF THE PARADE, ALL ENTRIES THAT HAVE CHILDREN WHO NEED PICKED UP BY PARENTS WILL END AT THE JUNIOR HIGH. ABSOLUTELY NO EXCEPTIONS!!!! THIS IS FOR THE SAFETY OF THEIR CHILD.

FOR THE PUBLIC'S SAFETY, PARENTS WILL NOT BE ALLOWED TO PASS THRU PARADE ROUTES. PARENTS MAY GO AROUND THE ROUTE TO GET TO THE JUNIOR HIGH TO PICK UP CHILDREN, OR THEY MAY USE THE ROADS AFTER THE PARADE IS OVER. WE WILL ENFORCE
