

## **New Agri System Gains Ground in Provinces**

A national program that hands more control over farming and fishing programs to provincial governments is seeing widespread adoption, with nearly all provinces now on board.

According to the Agricultural Training Institute, 74 out of 76 provinces have signed agreements for the Province Led Agriculture and Fisheries Extension System (PAFES). The data also shows 73 provinces have set up their own extension committees, and 55 have finished crafting their local agricultural plans.

Senator Francis Pangilinan voiced strong support for the initiative during a recent senate hearing. He described PAFES as a vital move for strengthening local agricultural governance.

Pangilinan shared a personal story from Alfonso, Cavite, where a farmers' cooperative he helped form later fell apart. He attributed this to a lack of sustained support and personnel from agricultural agencies.

"That experience showed me that if the Department of Agriculture is not given a wider role and more personnel, from the regional level down to the municipalities, this is what happens," the senator explained. He emphasized that without proper support for organizing and sustaining cooperatives, farmers struggle to stay organized.

He pointed to his own proposed legislation, including the National Agriculture and Fisheries Extension System Act and bills to strengthen agricultural cooperatives, as the next steps to ensure these local programs have lasting

The ATI stated that the PAFES model improves coordination between national agencies, local governments, and colleges to make sure support actually reaches farmers and fishers in their communities.

Atty. Aimee Torrefranca-Neri, led the discussions with partners from PH1 Developer and Megawide Construction Corporation.

The presented plans detailed two key sites. In Salinas, Strike Tower 2 will be a 16-floor building offering 2,000 housing units. Meanwhile, a larger complex in Dulong Bayan

will feature six towers, each 12 floors high, providing a total of 2,375 units. All buildings will include amenities like clubhouses, courts, and vehicle parking.

In a statement, Mayor Revilla reinforced the city's dedication to the project.

"We will elevate the lives of our constituents," he said. He also assured that the City would manage the properties and cover any potential shortfalls in dues to maintain the housing properly.

According to the contractors, construction is projected to take 14 to 15 months for each building. The plan is to start a new tower every six months, targeting full

completion before 2028. Officials reported that site permits and preparations are finished. The area is already secured, and work on a materials warehouse is underway.

On the beneficiary side, the HUDRD has submitted a list of nearly 5,000 potential applicants.

Qualification screenings with Pag-IBIG are ongoing, with 1,800 applications already preapproved.

## **Cavite LGUs Receive** Vital Local Data from **2024 CBMS**

GENERAL TRIAS, Cavite - Local government units (LGUs) in Cavite are now equipped with precise, community-level data to guide their planning and projects. This follows the recent 2024 Community-Based Monitoring System (CBMS) Presentation of Results and Data Turnover Ceremony led by the Philippine Statistics Authority (PSA).

Held at the Bayleaf Hotel, the event gathered Local Chief Executives, planning coordinators, and barangay officials from across the province. The gathering served as a platform to officially hand over the latest CBMS findings to the LGUs.

Ms. Raquel C. Ronario, Officer-in-Charge of PSA Cavite, welcomed participants to the significant event.

Key officials, including former Provincial Statistics Officer Ms. Lucia Iraida A. Soneja and 7th District Board Member Camille Del Rosario, delivered messages of support. Board Member Del Rosario, representing Governor Francisco Gabriel Remulla, extended the provincial government's gratitude to the PSA and participants for their commitment to datadriven development.

During the program, PSA specialists Ms. Liberty Q. Jacob and Mr. Gerald L. Amoroso presented the 2024 CBMS highlights for Cavite. The data revealed impressive provincial accomplishments, including a 98.68 percent household electrification rate, 99.63 percent access to basic drinking water, and 99.67 percent of residents with secure housing tenure.

A standout presentation came from Engr. Mildred M. Purificacion, the City Planning and Development Coordinator of Carmona. She shared her city's practical experience in "Harnessing CBMS Data for Responsive Multi-Sectoral Planning and Decision-Making," offering a real-world model for other LGUs.

An open forum allowed local officials to ask questions and discuss how to best use the new data for community projects. Ms. Beverly V. Villaruel of the Department of the Interior and Local Government (DILG) Cavite underscored the event's core message, relaying OIC-Provincial Director Marcial A. Juanco's statement that, "Good governance begins with good data." The ceremony concluded with the distribution of certificates to all participating municipal representatives. Ms. Liberty Q. ## **CHIZ REMINDS HEIs: NO COLLECTION OF STUDENT LOANS IN CALAMITY AREAS**

Senator Francis "Chiz" Escudero reminded all higher education institutions (HEIs) about the moratorium on the collection of student loans in all areas where a state of calamity has been declared. With several parts of the country still dealing with the devastating effects of earthquakes and typhoons over the past month, Escudero said families had to deal with "getting their lives back in order, first and foremost." "Pinapaalala natin sa ating mga unibersidad, kolehiyo, at pati na din ang mga techvoc (technical-vocational) institutions na may batas tayo na nagbabawal sa pagkolekta ng mga utang ng kanilang mga estudyante. Sa panahon na may sakuna, ang pinakamahalaga ay ang muling makabangon ang mga nasalanta," Escudero said.

Under Republic Act 12077, or the Student Loan Payment Moratorium During Disasters and Emergencies Act, payment of all fees and charges by HEIs and technical-vocational institutions (TVIs) is suspended for the duration of the state of emergency or calamity and 30 days after this is lifted. As one of the authors and sponsors of the law, Escudero said the education of students should never be affected whenever disaster strikes because in many instances, recovering from this is even more challenging than rebuilding lost property.

"Hindi dapat maging dahilan ang kawalan ng pambayad ng matrikula para matigil ang pag-aral ng ating mga estudyante lalo na pag sila rin mismo ay biktima ng bagyo, lindol o anumang sakuna," he said. The law states that the availment of the moratorium shall not in any way adversely affect the eligibility of the students concerned for re-enrolment in the succeeding semesters.

Escudero noted that the law encourages the HEIs and TVIs to offer payment relief or assistance programs for the affected students to make it easier for them to pay off their loans. Any waiver on the benefit of the moratorium on student loan payments or the availment of assistance or subsidies from the government is prohibited. Escudero was head of the Senate Committee on Higher, Technical and Vocational Education in the 19th Congress and was a co-chairperson of the Second Congressional Commission on Education (EDCOM 2).

He also sponsored and was one of the authors of Republic Act 11984 or the No Permit, No Exam Prohibition Act that paved the way for disadvantaged students to take their periodic and final examinations even if they are unable to pay their tuition or other fees. "Students affected by calamities are classified as 'disadvantaged' upon the certification by the Department of Social Welfare and Development. So the inability to pay their tuition should not be an obstacle to the completion of their educational requirements. They can find a way to pay for their loans later," Escudero said.

# Free Health Services **Reach Cavite Community**



A recent health mission in General Mariano Alvarez provided vital care to local residents, according to a report from the Provincial Government of Cavite.

On October 17, the provincial government organized a medical and dental outreach in Barangay Nicolas Virata. The event offered residents free consultations and procedures. Official data from the report, credited to R. Dones, shows that 422 people received services. These included 334 medical check ups, 43 dental procedures, 19 ECG tests, and 26 X ray services. The provincial governor's office also facilitated the distribution of free medicines. Medical staff from General Emilio Aguinaldo Memorial Hospital and CARSIGMA District Hospital provided their expertise for the medical consultations. A dedicated dental team from GEAMH was also present to serve the community. The initiative is part of the provincial government's ongoing effort to make essential healthcare more accessible to residents across Cavite.
