# Gov't caravan to provide over P824-M aid, services to 100K Caviteños

Kawit, Cavite - The 24th Bagong Pilipinas Serbisyo Fair (BPSF) is set to deliver over PHP824 million worth of various assistance programs to the province of Cavite. This amount includes PHP276 >> P2 million earmarked for cash assistance and PHP548 million for in-kind support, aside from 255,500 kilograms of rice to be distributed to beneficiaries in several areas across the province.

### Hundreds receive free medical care in Ternate

On September 13, 2024, the people of Ternate were the beneficiaries of a large-scale medical mission held at the Municipal Town Plaza in Poblacion 1. The event which was part of the Handog ng Pangulo, Serbisyong Sapat Para sa Lahat program, provided free healthcare services to a remarkable 435 patients in celebration of President Bongbong Marcos' birthday.

A total of 1,667 struggling individuals, including PWDs, Parents of SPED, Women, Solo Parents, and Senior Citizens gathered at the Dasmariñas Arena received additional support from Go, such as food packs, snacks, vitamins, masks, shirts, foldable fans, and basketballs and volleyballs. Some beneficiaries also received shoes, a mobile phone, bicycles, and a watch.

Being an adopted son of CALABARZON region, Go also partnered with the local government of Dasmariñas City led by Mayor Bargaza in providing financial support to the identified indigent sectors present.

Apart from supporting vulnerable sectors during his visit, Go also led the inauguration of one of establishment of its own Super Health Center. He emphasized the significance of building such healthcare facilities as part of his continued commitment to enhancing healthcare accessibility across

Go reiterated commitment to support the establishment of more Super Health Centers across the country considering how they can significantly help reduce hospital occupancy rates while bringing primary medical services closer to the grassroots. Super Health Centers can offer primary care, medical consultation, and early disease detection, further strengthening the healthcare sector at the community-level.

Through the concerted efforts of Go, fellow lawmakers, the Department of Health (DOH) led Secretary Teodoro "Ted" Herbosa, and local government units, adequate funding was allocated for establishing more than Cavite.

Meanwhile, in support of community health front liners, Go also gave grocery packs, snacks, shirts, and basketballs and volleyballs to 205 barangay health workers (BHWs) and Barangay Nutrition Scholars (BNS) present.

Responding to the earnest pleas of health workers, Go mentioned that he has been urging the DOH and the Department of Budget and Management (DBM) to act swiftly on releasing the longoverdue Health Emergency Allowance (HEA) qualified health workers.

Go also expressed gratitude to the local government for their diligent efforts in making the Super Health Center a reality. He specifically thanked Mayor Austria-Barzaga, Members Jun dela Cuesta, and Nickol Austria, and local councilors, among others.

Mayor Bargaza then expressed her deep gratitude to Go for his unwavering support to the city, particularly in health services and infrastructure projects.

> Meanwhile, Go offered additional aid to individuals with medical needs and advised them to avail themselves of the assistance provided by nearby Malasakit Centers located at the Southern Tagalog Regional Hospital in Bacoor City and Gen. Emilio Aguinaldo Memorial Hospital in Trece Martires City.

> Malasakit Centers are one-stop shops for medical assistance programs aimed at helping impoverished patients reduce their hospital costs to the least possible amount.

Go is the principal author and sponsor of Republic Act No. 11463, or the Malasakit Centers Act of 2019, which institutionalized the Malasakit Centers program.

As of now, 166 Malasakit Centers are operational nationwide, poised to assist with patient's medical expenses. The DOH reports that the Malasakit Centers program has already provided aid to nearly 12

#### caravan to provide << P1

During conference on Wednesday at the Emilio Aguinaldo Shrine in Kawit, Cavite, lawyer Shawn Capucion of the BPSF National Secretariat announced that the convergence caravan, scheduled for Sept. 27 and 28, will directly serve 100,000 residents of the province.

Of this number, 50,000 will be recipients of the "Ayuda sa Kapos ang Kita Program" (AKAP) administered by the Department of Social Welfare and Development (DSWD). Capucion underscored the government's commitment to providing efficient services

to the public, noting that the BPSF in Cavite will feature 61 participating agencies organized into clusters, offering a total of 235 different services.

In addition to the DSWD's AKAP program, the Department of Labor and Employment (DOLE) will facilitate payouts for its Tulong Panghanapbuhay sa Ating Disadvantaged/ Displaced Workers (TUPAD) program.

Officials of the Commission on Higher Education (CHED) and Technical Education and Skills Development Authority (TESDA) will also be present to distribute scholarship programs.

Various livelihood assistance and opportunities will be available to preidentified eligible clients from different sectors within the province.

Capucion highlighted that in just one year since its inception, the BPSF has provided PHP13 billion in assistance to 2.8 million families during 23 previous fairs nationwide.

He said the Cavite BPSF marks the third event in the Calabarzon region, following those in Laguna province

in November 2023 and Batangas province in August 2024. The BPSF aims to reach all 82 provinces nationwide, advocating for "Mabilis, Maayos, Maginhawa, at Masayang Serbisyo Publiko."

"The BPSF embodies a convergence mechanism that reflects a whole-ofgovernment and whole-ofnation approach to nationbuilding and national pride," Capucion said. "This initiative is a testament to President Ferdinand R. Marcos Jr.'s vision of ensuring that in a Bagong Pilipinas, no Filipino is left behind." (PNA)

The LTFRB chief said photos circulating on social media showing a throng of commuters waiting for public transport were regular situations on a Monday morning.

The two transport groups are protesting the Public Transport Modernization Program (PTMP) and are calling for the renewal of franchises and registrations for all public utility vehicle (PUV) operators, including those who choose not to consolidate in with the modernization program.

Transportation Secretary Jaime Bautista said the call of Piston and Manilbela to scrap the program is "non-negotiable."

"We cannot turn our back on the vast majority of transport groups that understand and subscribe to the public transport modernization program," Bautista said.

According to the Department of Transportation, 87 percent of PUVs have already consolidated their franchises.

The consolidation requires PUV operators to

form cooperatives or corporations to access business financing in acquiring modern jeepney units.

It is part of the government's PUV modernization program that started in 2017, then known as the Public Utility Vehicle Modernization Program.

Failure to meet the consolidation deadline will result in the revocation of franchises of non-compliant operators, essentially barring them from operating.

Despite no reports of stranded commuters in most parts of the metropolis, the Quezon City government deployed 94 "Q City" bus to give free rides to those who may be affected.

The Quezon City Police District and the Traffic and Transport Management Department are also on standby to guide motorists and passengers.

"Nakahanda rin ang e-trikes, QC-owned vehicles, at barangay vehicles ng lungsod para alalayan ang mga commuter (E-trikes, QCowned vehicles and barangay vehicles are also ready to assist commuters)," the city government posted on social

The QC buses were deployed to eight major routes: QC Hall to Cubao; QC Hall to Litex Road/IBP Road; Mabuhay Rotonda to Aurora Boulevard-Katipunan Avenue; QC Hall to General Luis Street, Valenzuela-Caloocan; QC Hall to Mindanao Avenue via Visayas Avenue; QC Hall to Gilmore Avenue; QC Hall to C5 Road/ Ortigas Avenue Extension; and QC Hall to Muñoz.

The Office of the Vice President (OVP) likewise provided "Libreng Sakay" (free rides) in eight routes in Metro Manila, Cavite, Cebu, Bacolod and Davao.

For Metro Manila, two OVP buses each were dispatched for the Quiapo, Manila to Commonwealth, Quezon City route; and Parañaque Integrated Exchange Terminal to Monumento, Caloocan via the EDSA bus carousel, and vice versa. ### TORRE APPOINTE HIEF OF CIDG

A reshuffle has been carried out among the ranks of some senior officers of the Philippine National Police (PNP) to lead the new job placed on their shoulders.

Those who were given new appointments include Police Regional Office 11 chief Police Brigadier General Nicolas Torre III who was appointed by PNP Chief, PGen. Rommel Francisco Marbil as the promoted new chief of the Criminal Investigation and Detection Group (CIDG) replacing PMGen. Leo Francisco who was also transferred as director of the Civil Security Group (CSG) in Camp Crame.

Torre belongs to PNPA Class 93, which led the intensive search and pursuit operation for the fugitive preacher of the Word of God, Pastor Apollo Carreon Quiboloy inside the Kingdom of Jesus Christ (KOJC) compound in Davao City which resulted in the surrender of leader of the religious organization, along with its four co-accused.

The new Acting Regional Director of PNP Region 11 was appointed to replace Torre, P/Brig. Gen. Leon Victor Z Rosete from the Southern Police District (SPD) District Director who led the maintenance of Peace and Order in Southern Metro, and he belongs to PNP Class 95.

Torre led the Police Regional Office 11 for more than three months in the search operation for Quiboloy in the 30-hectare KOJC compound building premises.

Later according to the report, the fugitive church leader



surrendered on September 8, 2024 after 16 days or more than two Sundays that Pastor Quiboloy tortured the police in searching for him.

According to speculative news, Torre was transferred to the CIDG office because the agency was allegedly tasked to find and hunt down former president Rodrigo Duterte's fugitive former presidential spokesperson, Attorney Harry Roque, because he was allegedly involved in the Philippine Offshore Gaming Operators (POGO) that the operation is illegal. The said list of officials of the authorities is effective on September 25, 2024 according to the order of PNP Chief Marbil. Congratulations to our brave, and hardworking police! # 120K indigents aided under Bagong Pilipinas Serbisyo Fair in Cavite

For the ISIP for the Youth - another program crafted by Speaker Romualdez - a total of 5,000 students received PHP5,000 in financial aid and five kilograms of rice in a distribution ceremony held at the Bacoor Elementary School. Beneficiaries from this program receive financial assistance as they pursue tertiary and vocational education, to aid them in their continued education.

The funds used for this came from the Assistance to

Individuals in Crisis Situations (AICS) of the DSWD.

Benefits for students enrolled in this program include enrollment under CHED's Tulong Dunong Program (TDP) where students can get scholarship assistance per year amounting to a total of P15,000; priority slots under the Government Internship Program (GIP); and enrollment of their unemployed parents or guardians to the DOLE-TUPAD Program.

The distribution ceremony for the SIBOL Program took place at the Maple Grove in General Trias and saw 10,000

MSME beneficiaries each receiving PHP5,000 in financial assistance and five kilograms of rice. The funds used for this program also came from AKAP.
