As part of its ongoing commitment to strengthening disaster preparedness and response, the Provincial Government of Cavite, through the Office of the Provincial Disaster Risk Reduction and Management Officer (PDRRMO), conducted successfully a Tabletop Exercise on June 19, 2025 held at the Carmona Operations Center in Barangay Maduya, City of Carmona. The exercise simulated a Magnitude 7.2 earthquake with Intensity 8 ground shaking, carried out

in line with the 2nd Quarter Silang and General Mariano Coast Guard (PCG). Also Simultaneous Earthquake Drill, reinforcing province's proactive approach to disaster risk management.

The activity brought together key responders and stakeholders from various government agencies, including the Office of Civil Defense (OCD), City Disaster Risk Reduction Management Office (CDRRMO) of Carmona and Municipal Disaster Risk Reduction and Management Offices (MDRRMO) of Alvarez (GMA), as well as representatives from the Office of the Provincial Engineer (OPE), Office of the Provincial Health Officer (OPHO), Office of the Provincial Social Welfare and Development Officer (OPSWDO), Department Education (DepEd), of Department of Social Welfare and Development - IVA, Bureau of Fire Protection (BFP), Armed Forces of Philippines (AFP), the Philippine National Police (PNP), and the Philippine present during the activity was OCD Region IV-A Regional Director Carlos Eduardo Q. Alvarez III, who delivered an inspirational message underscoring the importance of preparedness, collaboration, learning continuous in the minimizing impact disasters. He of natural commended the Provincial Government of Cavite and all participating agencies their dedication to for strengthening local disaster response mechanisms. The exercise was structured into three key modules. The first module, Initial Response and Guidelines, focused activating emergency facilitating protocols, information flow, and rapidly assessing initial damages and casualties immediately after the earthquake. The second module, Response, emphasized inter-agency coordination, deployment maintaining of resources, lines, communication real-time situational and reporting in a dynamic emergency environment.

The final module, Review, provided a platform to evaluate the activity, identify operational gaps, share best practices, and recommend strategies to enhance the province's earthquake preparedness and response systems. Through the simulation, participants assessed the effectiveness current contingency

plans and strengthened coordination among response units in the event of a major seismic event. The TTX also served as a vital step in enhancing Cavite's overall disaster resilience by identifying challenges and crafting proactive solutions to mitigate the impacts of large-scale earthquakes.---JDP

issued by a single authority, replacing the current patchwork of local IDs that make it hard to distinguish real from fake.

The new PWD ID will come in both physical and digital formats.

The physical card, which will be delivered within three months, includes an RFID tag and is designed with forgery-resistant materials.

The system will be linked with the National ID and e-verifier platforms for

seamless authentication. The initiative, backed by agencies like DSWD, DOH, DICT, PSA, and DILG, addresses the PHP88.2 billion tax revenue loss in 2023 from the use of fake PWD IDs.

Strict medical validation will be required registration—visible disabilities may be assessed person, while nonapparent conditions need certification from licensed specialists.

The DOH is also set to

release updated disability categories and certifying experts. Digital registration will be supported by LGU-based Persons with Disability Affairs Offices for those unfamiliar with online systems.

NCDA is also preparing training modules to guide frontliners during the rollout. PWDs in pilot areas are urged to register and participate in the program to help ensure a smooth transition.

Establishments also encouraged to continue honoring existing PWD IDs while the new system is being phased in.

CvSU's techno demo farm to strengthen agri innovation in Cavite

INDANG, Cavite (PIA) — The Cavite State University (CvSU) reaffirmed its commitment to agricultural innovation and education by partnering with the Department of Agriculture (DA) Calabarzon to establish an integrated Techno Demo Farm for research, training, and sustainable farming.

According to CvSU, the farm to be developed on a 1.3-hectare portion of Cv-SU's STAR Farm in Indang, is expected to strengthen agricultural innovation and education by promoting sustainable farming practices, advancing research, and empowering local farmers and students with modern technologies and skills.

"The initiative also seeks to address pressing issues related to food security, climate-resilient agriculture, and the competitiveness of local farmers in an evolving agribusiness landscape," CvSU said in a statement.

Under the partnership, CvSU and DA Calabarzon will collaborate in sharing knowledge and resources while implementing programs that promote sustainable farming technologies and agribusiness development.

These efforts will include instruction, research, extension services, and the monitoring and evaluation of activities, policies, and technologies related to the project.

"This partnership with DA Calabarzon aligns with CvSU's mandate to conduct research and extension services, and to provide progressive leadership in agriculture, science and technology, education, and other related fields," CvSU added.

Representatives from various national and local agencies, including the Bureau of Plant Industry, Bureau of Agricultural Research, Department of Science and Technology -Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development, local agricultural offices, and farmer cooperatives, were present at the launch held recently, underscoring strong multi-sectoral



support for agricultural development.

DA Calabarzon officials expressed optimism that the

partnership will facilitate the transfer of modern farming technologies and business

DENR: More infrastructure needed to curb plastic pollution

The country needs more infrastructure for segregation, recovery, and recycling to properly address the growing plastic waste problem, the Department of Environment and Natural Resources (DENR) said Thursday.

"We need more support, public funds, and private sector's resources and technical capacity to cover whole waste management services at the local government (LGU) level," DENR Secretary Maria Antonia Yulo Loyzaga said during the Environment and Natural Resources (ENR) Day 2025 celebration in Makati City. Yulo-Loyzaga she issued a strong call for a united and urgent action against plastic pollution, citing the Philippines' critical role in the global fight against environmental degradation. She emphasized



that strong cooperation across sectors and communities is the key to solving the plastic crisis. "The rapidly increasing levels of plastic pollution represent a serious global environmental issue that has grave consequences to the environmental, social, economic, and health dimensions of our quest towards sustainable development," Loyzaga said. She added that tackling plastic pollution demands a unified, bold, and science-based action, as it has also become a climate change issue, as most of the plastics used today are derived from fossil fuels.

Loyzaga said plastics release greenhouse gases (GHG) into the atmosphere, which degrade the environment when unmanaged. Based on studies, she said that by 2050, the GHG emissions from plastic could reach 56 gigatons, which she said is equivalent to 10-13 percent of the entire remaining carbon budget.

According to the UN Environment Programme (UNEP), plastic production has risen exponentially in the last decades, estimated to be at around 400 million tons per year, and this figure is set to double by 2040.

Loyzaga said the Philippines currently produces around 61,000 metric tons of solid waste daily, of which 12 to 24 percent comprises plastic. "Filipinos utilize, take note, 163 million plastic sachet packets, 48 million shopping bags, and 45 million thin-film bags daily. 33 percent of that waste finds its way into landfills and dumpsites, and around 35 percent is leaked into the open environment and into our oceans," she said. Loyzaga stressed that the Philippines is one of the world's reported highest contributors to plastic waste. Yulo-Loyzaga said the DENR is now working with concerned stakeholders, including multilateral development banks such as the Asian Development Bank (ADB) and non-government organizations (NGO) partners such as Clean Rivers of the UAE's Zayed Foundation (Erth Zayed Philanthropies) to rehabilitate important historical, cultural and economic areas such as the Pasig River, Laguna de Bay and Manila Bay.

Moreover, she said the DENR is enforcing the Extended Producer Responsibility (EPR) Law, which requires companies to collect and recycle 80 percent of their plastic packaging by 2028. Loyzaga highlighted the daily efforts of the more than 2,300 Estero Rangers and River Warriors who clean up plastic waste from waterways in flood-prone areas of Metro Manila and neighboring provinces. "We all know that waste management as a whole stems from the heart, which is the home. It also reflects a social and economic structure in our society that must be addressed by knowledge-driven institutional change," she said. She then called for a deeper engagement at the local level, including support for microenterprises and waste workers. "We hope you will join us in this call for swift, bold, and impactful action to combat not just the roots and drivers of plastic pollution," Loyzaga said. "Let's continue to work together to re-imagine, recreate, and regenerate our only home," she added. (PNA)

CJ Gesmundo: Promote love of country, selflessness, justice

Chief Justice Alexander Gesmundo on Thursday urged Filipinos to celebrate Independence Day by rekindling the lessons of the revolution that led to Philippine independence -- love of country, placing the welfare of others above one's self and justice.

In his keynote address during the celebration of the 127th year of Philippine Independence at the Emilio Aguinaldo Shrine in Kawit, Cavite, Gesmundo urged Filipinos to honor the country's heroes not just through symbolisms but through principled action.

"Hindi natatapos ang kuwento ng ating kalayaan sa kasaysay---ito ay nagpapatuloy sa kasalukuyan, at hinuhubog natin para sa kinabuksan. Ipagdiwang natin ang ating kalayaan, hindi lamang sa pamamagitan ng pagwagayway ng ating bandila at pag-alala sa nakaraan, ngunit sa pamamagitan din ng pagkilos (The story of our freedom does not end with history --it continues to the present and we shape it for the future. Let us celebrate our freedom not merely by waving our flag and remembering the past, but through action), Gesmundo said.

He said Filipinos should reaffirm the ideals that gave impetus to their freedom.

"Ituro natin sa ating mga anak hindi lamang ang pangalan ng ating mga bayani, ngunit ang mga prinsipyo na isinapuso nila: ang pagmamahal sa bayan, ang pagsasakripisyo ng sariling interes para sa ikabubuti ng nakararami, at ang walang humpay na pagpupursigi upang patuloy na mapabuti ang bansa (Let us teach our children not just our heroes' names but the principles they lived by: love of country, sacrificing one's interests for the greater good, and tireless dedication for the continuous development of our country)," he added.

To give meaning to independence, Gesmundo said every Filipino must take an active role in building a just and humane society.

"Dapat mapagtanto natin na ang tunay na kasarinlan ay may kaakibat na pananagutan sa taong bayan. Ang makabuluhang kalayaan ay hindi natatapos dahil tayo na ang namumuno sa ating bansa --ito ay dapat mag-udyok sa atin na magsumikap upang magkaroon ng mas makatarungang lipunan (We should realize that true independence comes with a corresponding responsibility to the people. Meaningful freedom does not end because we are now leading our country –this should push us to strive for a more inclusive society)."

While most Filipinos are no longer called to risk their lives in war. Gesmundo said they are nonetheless called to show courage and unwavering dedication in helping the vulnerable and addressing the nation's enemies today: corruption, apathy, and abuse from within.

The country's first president, Emilio Aguinaldo, proclaimed the Philippine independence from the Spanish colonial rule in Kawit, Cavite on June 12, 1898.

Aguinaldo's proclamation of independence made the Philippines Asia's first free nation from the clout of Western powers.

Samantala, gagamitin ng CSWD ang kanilang database upang matukoy ang mga karapat-dapat makinabang, at sila rin ang tutulong sa pagproseso ng mga kinakailangang

dokumento sa PhilHealth. Bukod dito, may plano rin ang lungsod na i-upgrade ang mga Rural Health Units (RHUs) upang mas maging episyente at modernong maglingkod sa mas maraming pasyente. Binigyang-diin ni Mayor Strike na ang inisyatibang ito ay bahagi ng kanyang pangakong pagaanin ang pasanin ng mga Bacooreño sa aspeto ng kalusugan, lalo na ng mga

kapus-palad. "Hindi dapat maging hadlang ang kakulangan sa pera sa pagkuha ng serbisyong medikal," aniya. "Layunin natin na mailapit sa tao ang serbisyong medikal – libre, maayos, at mabilis." Sa nalalapit na implementasyon ng programang ito, inaasahang makikinabang ang libu-libong mamamayan sa Bacoor na nangangailangan ng dekalidad ngunit libreng serbisyong medikal.

Cavite town forms multisectoral alliance for child protection

— The local government of General Mariano Alvarez has entered into a partnership with Save the Children Philippines and the Frere Saint Benilde Romancon Education Foundation of De La Salle University — Dasmariñas to strengthen child protection measures in the municipality.

The partnership aims to implement programs focused on combatting online sexual abuse and exploitation of children (OSAEC), a growing concern in communities nationwide.

The DLSU-D also lauded the initiative saying that the partnership will reinforce local gov-

ernment and stakeholders' commitment to creating a safer online environment for children and serving as a model for other communities.

This initiative aligns with Republic Act No. 11930, the "Anti-Online Sexual Abuse or Exploitation of Children (OSAEC) and Anti-Child Sexual Abuse or Exploitation Materials (CSAEM) Act." (RBF, PIA Cavite)
