DOTr approves LRT-1 fare hike effective April 2

The Department Transportation (DOTr) has approved the fare hike for the Light Rail Transit Line 1 (LRT-1), which will be implemented starting April

In a statement on Tuesday, Light Rail Manila (LRMC) Corporation president Enrico Benipayo announced the new fare scheme following the notice of approval issued by the DOTr last Feb 14.

"The newly approved fare scheme is lower than

DA speeds up NFA rice sale to free warehouse spaces

Two weeks after the declaration of a food security emergency, the Department of Agriculture (DA) on Wednesday started the release of the first batch of rice stocks from the National Food Authority (NFA) to select local government units (LGUs).

In a press conference at the NFA warehouse in Valenzuela City, Agriculture Secretary Francisco Tiu Laurel Jr. said the NFA rice stocks must be unloaded as "fast as possible" to free up spaces in warehouses nationwide and fast-track the buying of palay from local

"Since we are rushing na ma-dispose, kita niyo naman iyong warehouse na ito, medyo puno. At mas puno pa iyong mga ibang warehouse all over the country... Race to finish ito (to dispose of these, as you can see this warehouse is somewhat filled. And other warehouses in

more loaded... This is a race to finish)," he said.

He was referring to the target immediate disposal of 150,000 metric tons (MT) of rice nationwide in the next six months. "The sooner we can finish the stock, the sooner we can buy a lot from our farmers para makatake advantage sa PHP23 na sinasabi nating buying price ngayon ng dry (so that they can take advantage of the PHP23 buying price for dry

other parts of the country are palay)," Tiu Laurel said, as the country approaches the peak harvest season of local palay (unhusked rice).

> He said the LGUs can request the volume they need through purchase orders (PO) to the Food Terminal Incorporated (FTI). To date, initial participating LGUs include San Juan, Valenzuela, Navotas, and Camarines Sur.

At least 67 LGUs have expressed their intent to procure NFA rice stocks, according to the NFA.

For his part, Metro Manila council president and San Juan Mayor Francis Zamora expressed optimism in rolling out the program to provide consumers with more affordable rice options.

"Definitely. excited po ang lahat ng mayors sa Metro Manila sapagkat ang hinahanap sa atin ng ating mga kababayan ay murang bigas (all Metro Manila mayors are excited because our constituents have been looking for cheaper rice),"

he said. The DA earlier said the NFA rice will be sold at PHP33 per kilogram to LGUs, government agencies, and government-owned and controlled corporations, which can then be sold at PHP35/kg to consumers.

Zamora, however, said the San Juan LGU will shoulder the logistics cost to make NFA rice available to its residents at the minimum price level. "That is a total of PHP1,650 kada sako. Kami po sa lungsod ng San ng palugit na dalawang piso para mabayaran ang mga gastusin sa hauling, sa pagbuhat, sa trucking at pagdistribute sa LGUs ay hindi na kami magpapatong (In San Juan City, even though we're given PHP2 margin to cover the hauling, carrying, trucking, and distribution in LGUs, we will no longer put a markup)," he said.

He added they will conduct a pre-registration among their residents to make it organized and available to more citizens, at a PHP33/kg price level.

Camarines Sur 2nd District Rep. Luis Raymund Villafuerte said at least 250,000 families out of the 1.2 million population will benefit from the NFA rice sale in their area.

"Malaking bagay na po ito. So kami (This will help a lot. So, we), we can start as early as next week, Monday," he said.

According to the initial targets set by the NFA, participating LGUs

nationwide will be given around 625,600 monthly allocation.

LGUs in Metro Manila, Cavite, and Rizal will receive a monthly allocation of 293,000 bags.

Other LGUs Calabarzon and Mimaropa were given a monthly allocation of 47,000 bags; Bicol, 38,600 bags; Western Visayas, 58,000 bags; Central Visayas, particularly Cebu, 50,000 bags: Eastern Visayas, 18,000 bags; Zamboanga Peninsula, 21,000 bags; Northern Mindanao, 20,000 bags; Davao, 19,000 bags; Soccsksargen, 36,000; Caraga 20,000; and Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), 5,000 bags.

For LGUs to participate, Tiu Laurel said they need to submit a letter of intent to the FTI attached with the PO (purchase order); as well as secure a "simple" memorandum of agreement (MOA) with the DA to seal

PEZA expects to lure more investors with CREATE **MORE IRR signing**

Philippine Economic Zone Authority (PEZA) Director General Tereso Panga is expecting more investors to put up their businesses in economic zones across the country following the signing of the implementing rules and regulations (IRR) of the Corporate Recovery and Tax Incentives for Enterprises to Maximize Opportunities for Reinvigorating the Economy (CREATE MORE) Act. Panga said the IRR provides clarity for the smooth implementation of the law. "It is a product of conjoined efforts that will surely attract more interest in the Philippines and paves the way for future investment growth," Panga said in a statement Wednesday. On Feb. 17, Finance

Secretary Ralph Recto and Trade Secretary Ma. Cristina Roque led the signing of the CREATE MORE's IRR. The IRR supports PEZA's mandate of driving investment growth into the country, promote sustainable development in the countryside, and create more jobs.

"The CREATE MORE Act refines the investment landscape of the Philippines to be at parity with other countries," he said. "With these new policies in place, coupled with the positive attributes already presented by our country and the various advantages like a communications-ready skilled workforce, a conducive business environment and a whole-of-government approach, it is without doubt that new investors will come in and old investors will choose to stay for the long haul," he added. Even before the signing of the CREATE MORE IRR, PEZA signed a registration agreement (RA) with Japanese manufacturer P.Imes Corp. and a memorandum of understanding (MOU) with Karl Group Holdings Corp. (KGHC) as its partner in attracting developers of and locators in pharmaceutical ecozones, a new type of ecozone of the investment promotion agency (IPA). With the signing of RA with P.Imes Corp., the Japanese company will expand its manufacturing of high-technology products for various industries, such as electronics, automotive, medical, and semiconductor in the Cavite Economic Zone. The MOU with KGHC will help PEZA to lure investors, manufacturers, and research institutions in PEZA pharma ecozones, which will become strategic investment hubs for medical innovation, pharmaceutical production, and healthcare-related industries. "This partnership aligns with PEZA's initiative to integrate ecozone domestic production into the value chain, reducing import dependence—particularly in the medical and pharmaceutical sectors. As a leading provider of innovative healthcare solutions, KGHC plays a crucial role in producing cutting-edge medical equipment and simulation technologies," the IPA added. (PNA)

the 2024 rates applied for by LRMC and is only equal to the 2022 LRMC application as provided for in the concession agreement," Benipayo said.

Based on the decision of the DOTr's Rail Regulatory Unit (RRU), the LRT-1 boarding fare has increased to PHP16.25 with a distance

fare of PHP1.47 per kilometer.

The minimum fare for a single journey ticket will soon become PHP20 from PHP15; the fare from Dr. Santos Station to United Nations Station will cost PHP35 from PHP30; and from Dr. Santos Station to Fernando Poe Jr. Station to PHP55 from PHP45. Fare for passengers using stored value 'Beep' cards will be slightly lower at PHP19, PHP34, and PHP52, respectively.

Benipayo noted that the fare increase is the second time the LRMC has been granted a fare adjustment in the past 10 years despite the opening of the LRT-1 Cavite Extension. "Public transport is a service that requires continuous investment in maintenance, upgrades, and expansion. Countries with world-class transport systems such as Singapore and Japan adjust fares regularly to keep services efficient and safe," he said. (PNA)
