accountability in public service. "Public office is a public trust. Our government officials are in their positions because the people trust them. People will trust them if these public officials govern with accountability and integrity," he said

Taking off from the university's Sustainable Barangay Leadership and Governance (BALAG) and the ongoing implementation of the Barangay Peace and Conflict Transformation (B-PACT) Executive Programs, B-LEAD provides barangay and Sangguniang Kabataan officials the skills and knowledge on the principles of ethical and sustainable governance and their role in upholding ethical and accountable public service. "[Government] Positions are public property. We run for office because we believe that we can contribute to national and local development. We are there because the people trust us. Remember that running for a position and occupying a position is always for public service, not personal interest." Thelma Vecina, executive director of the Local Government Academy (LGA), emphasized the shared responsibility local government units in upholding accountability at the grassroots level.

"Governance should be shared. The barangay captain cannot do it alone, the Sangguniang and

Barangay cannot manage the barangay by themselves. They need partners and allies in governance." Nencita Costelo, Local

Government Operations Officer of the Department of the Interior and Local Government (DILG) emphasized the importance of ethical leadership in ushering in developments in barangays.

"When you serve the barangay with your heart, your compassion for the people naturally follows. You cannot truly serve the barangay and prioritize the welfare of the people if you do not have the heart for it."

Costelo added that the DILG determines the level of ethical leadership by barangay officials through the effectiveness of services at the grassroots level.

"We have barangays that excel because of ethical leadership. The DILG has created parameters to determine how barangays perform," Costelo added, citing the Seal of Good Local Governance for Barangay (SGLGB) as an example.

The B-LEAD Executive Program is aligned with the United Nation's Sustainable Development Goals (SDG) in ensuring transparent, inclusive, and sustainable governance, as well as the AmbisyonNation2040, the country's long-term vision for a prosperous, inclusive, and resilient society by 2040. This strategy is seen as an essential tool in ensuring prompt action and preventing localized outbreaks.

The program concluded with closing remarks from Dr. Armand Dotollo, who commended the unwavering dedication of Cavite's health workers.

He urged continued vigilance, active surveillance, and community

engagement as cornerstones in the sustained elimination of malaria.

Dr. Dotollo reaffirmed the provincial government's support in empowering local health units through capacity building, training, and access to timely resources.

World Malaria Day serwves as a powerful reminder of the ongoing battle against preventable diseases and the collective responsibility to safeguard public health.
