Justice Villanueva is the first appointee to the Supreme Court by President Ferdinand Marcos, Jr.

One of the top producers of socialized housing in the country has committed more than 35,000 units to the government's Pambansang Pabahay Para sa Pilipino Housing (4PH) Program.

This comes after Department of Human Settlements and Urban Development (DHSUD) Secretary Jose Ramon Aliling's announcement to include horizontal developments in the recalibrated housing program. In a news release on Thursday, Aliling said Raemulan Lands Inc. (RLI) chief executive officer Eileen Uy Doyle has sent a letter of commitment to deliver 35,656 housing

Villanueva's family and colleagues. They were joined by Supreme Court Senior Associate Justice Marvic M.V.F. Leonen and Associate Justices Alfredo Benjamin S. Caguioa, Ramon Paul L. Hernando, Henri Jean Paul B. Inting, Rodil V. Zalameda, Samuel H. Gaerlan, Jhosep Y. Lopez, and Japar B. Dimaampao. Justice Villanueva brings with him over 20 years of experience in the Judiciary. He began his judicial career in 2002 as Presiding Judge of the Regional Trial Court (RTC), Branch 255, Las Piñas City. He also served concurrently as Acting Presiding Judge in two other courts: a drugs court in Taguig City and a family court in Manila.

In 2009, he was appointed Executive Judge of the RTC in Las Piñas. A year later, he became Deputy Court Administrator, supervising courts across Judicial Regions 1 to 12. He rose to the position of Court Administrator in 2022, managing over 2,000 judges and 26,000 court personnel nationwide. A native of Narvacan, Ilocos Sur, he was the first Court Administrator from Region I.

Under his leadership, the Office of the Court Administrator (OCA) implemented key reforms, including the creation of the Office of the Regional Court Manager. This initiative helped decentralize administrative functions, allowing judges to concentrate more on resolving cases. During his term, case disposition rates in the first- and second-level courts improved from 40% in 2021 to 49% in 2024.

He also issued several important OCA circulars to help and guide the trial courts. These include OCA Circular No. 43-2022, which provided protocols for videoconferencing hearings the during COVID-19 pandemic; OCA Circular 106-2022, which established procedures for videoconferencing hearings involving deaf litigants and witnesses; and OCA Circular No. 201-2022, which aimed to expedite the release of persons deprived of liberty who have completed service outstanding contributions to of their sentence. In addition to these initiatives, he signed 11,493 appointments of court personnel in the and second-level courts, accounting for about 41.3% of all currently filled positions in the lower courts.

Before joining the Judiciary, Justice Villanueva worked in Congress, the Department of the Interior and Local Government, Privatization and Management Office, and in private legal practice. He also held leadership roles in the Philippine Judges Association, where advocated for better pay and benefits for judges.

A dedicated educator, he has taught various subjects at the New Era University College of Law, the University of the Philippines Law Center, and Philippine Judicial Academy.

In 2023, the University of the Philippines Alumni Association honored him with the Distinguished Alumni Award for Court Administration and Public Service, in recognition of his


the Judiciary. More recently, he was commended by the Presidential and National Anti-Money Laundering, Counter-Terrorism Financing and Counter-Proliferation Financing Coordinating Committee for his invaluable contributions, dedication, exemplary proven expertise, and utmost professionalism—qualities that were instrumental in the Philippines' successful removal from the Financial Action Task Force Grey List.

Justice Villanueva graduated valedictorian from the Narvacan South Central School. He finished high school with honors at Lourdes School of Quezon City and earned his Economics degree in 1985, and Law degree in 1990both from the University of the Philippines.

Bacoor Named High-Performing Child Protection Council by DILG Cavite

the Protection of Children (LCPCs), including the Provincial Government of Cavite, achieved an IDEAL Functionality Level following the LCPC Functionality Assessment for Fiscal Year 2024. The Department of the Interior and Local Government (DILG) Cavite extends its warmest congratulations to the high-performing LCPCs for their dedication to upholding child protection and welfare. The LCPC

Local Councils for Functionality Assessment was conducted pursuant to DILG Memorandum Circular No. 2021-039, titled "Comprehensive Guidelines for the Establishment, Strengthening, and Monitoring of the LCPC at All Levels and for Other Purposes." Local government units (LGUs) were evaluated based on the performance of their respective LCPCs, focusing on four key areas: (1) Organizational Sustainability; (2) Policies and Plans for Children; (3)

Budget for LCPC; and (4) Service Delivery Monitoring and Management for Children Engr. Danilo A. Nobleza, CESE, Provincial Director of DILG Cavite and Chairperson of the Cavite Provincial Inter-Agency Monitoring Task Force (PIMTF), expressed his gratitude for the remarkable performance of the LCPCs. He also conveyed his optimism that more LGUs will attain IDEAL Functionality in future assessments.

Revilla to MMDA: Fix Roads Before Fines

Cavite 1st District Representative Jolo Revilla has called on the Metropolitan Manila Development (MMDA) Authority suspend its imposition of fines under the No Contact Apprehension (NCAP) until all existing traffic management issues are resolved, slamming what he described as "NCAP traps" that unfairly penalize motorists.

In a statement on Friday, June 6, Revilla highlighted growing concerns over defective traffic infrastructure, particularly malfunctioning

stoplights, unclear signage, and faded road markings that he said put drivers at a disadvantage and contribute to unjust apprehensions. His remarks come amid public outrage over a viral video circulating on social media showing a traffic light along Abad Santos Avenue in Manila abruptly changing from green to red before its countdown timer had even finished—an example, Revilla said, of how flawed systems can lead to unfair citations under NCAP.

We should not punish drivers for the government's shortcomings," Revilla emphasized. "Before imposing fines under NCAP, the MMDA must first ensure that all traffic lights, signages, and especially road markings are clear, working, and visible at all times.'

Revilla, who recently secured another term in Congress, stressed the need for fairness in implementing traffic policies, pointing out that many motorists are fined not due to negligence or recklessness but because of confusing or poorly maintained infrastructure.

The lawmaker argued that the current state of some NCAP-monitored intersections creates scenarios akin to "entrapment" rather than genuine traffic enforcement.

"Let's be fair. Drivers want to follow the law, but if they can't see lane dividers or are misled by faulty traffic lights, that's not a violation — that's entrapment," he said.

Revilla urged the MMDA to conduct an immediate audit of all areas covered by the NCAP, identify and repair malfunctioning traffic lights, replace old or missing signages, and repaint essential road markings such as stop lines, pedestrian crossings, and lane dividers.

To complement these efforts, he also proposed the establishment of a public reporting system that would allow motorists to safely and efficiently report traffic infrastructure issues without fear of retaliation. "If NCAP is meant to make roads safer, let's start by making them clearer," Revilla stated. "Let's not allow technology to punish people unfairly due to negligence in basic traffic management." The MMDA has yet to respond to Revilla's statement or address the video showing the faulty traffic light, which has reignited debate on the fairness and readiness of automated traffic enforcement systems in the Philippines.
