province of Cavite. This amount includes PHP276 million earmarked for cash assistance and PHP548 million for in-kind support, aside from 255,500 kilograms of rice to be distributed to beneficiaries in several areas across the province.

During press conference on Wednesday at the Emilio Aguinaldo Shrine in Kawit, Cavite, lawyer Shawn Capucion of the BPSF National Secretariat announced that the convergence caravan, scheduled for Sept. 27 and 28, will directly serve 100,000 residents of the province.

Of this number, 50,000 will be recipients of the "Ayuda sa Kapos ang Kita Program"

(AKAP) administered by the Department of Social Welfare and Development (DSWD)

Capucion underscored government's commitment to providing efficient services to the public, noting that the BPSF in Cavite will feature 61 participating agencies organized into clusters, offering a total of 235 different services.

In addition to the DSWD's AKAP program, the Department of Labor and Employment (DOLE) will facilitate payouts for its Tulong Panghanapbuhay sa Ating Disadvantaged/ Displaced Workers (TUPAD) program.

Officials Commission on Higher Education (CHED) and Technical Education and Skills Development Authority (TESDA) will also be present to distribute scholarship programs.

Various livelihood assistance and opportunities will be available to preidentified eligible clients from different sectors within the province.

Capucion highlighted that in just one year since its inception, the BPSF has provided PHP13 billion in assistance to 2.8 million families during 23 previous fairs nationwide.

He said the Cavite BPSF marks the third event in the

Calabarzon region, following those in Laguna province in November 2023 and Batangas province in August 2024.

The BPSF aims to reach all 82 provinces nationwide, advocating for "Mabilis, Maayos, Maginhawa, at Masayang Serbisyo Publiko."

"The BPSF embodies a convergence mechanism that reflects a whole-ofgovernment and whole-ofnation approach to nationbuilding and national pride," Capucion said.

"This initiative is a testament to President Ferdinand R. Marcos Jr.'s vision of ensuring that in a Bagong Pilipinas, no Filipino is left behind." (PNA)

New bike lanes to address vehicular congestion in Bacoor - DOTr

BACOOR, Cavite Transportation Secretary Jaime Bautista said Wednesday the new bike lanes being constructed in Bacoor, Cavite would help address the worsening vehicular congestion in the city.

During the groundbreaking ceremony for the bike lanes here, Bautista said the bike lanes would have an immediate impact on residents and encourage more cyclists to participate in the Department of Transportation's (DOTr) Active Transport Program.

"With the construction of bike lanes, kahit papaano makakatulong tayo na

mabawasan ang traffic dito sa Bacoor (we will be able to reduce some vehicle congestion in Bacoor)," he said.

He also called on the project's contractor, Metro Land Builders Corp., to finish construction before Christmas.

"Sana ay tapusin ang project na ito bago mag Pasko para regalo natin sa mga taga-Bacoor (We hope this gets completed before Christmas as a gift to Bacoor residents)," he said.

The project includes the construction of about 18.96 km. of bike lanes in the city with an estimated 664,000 active transport users, including cyclists, students,

The bike lanes and other active transport facilities will be constructed along segments of Bacoor Boulevard, Bacoor-Imus Diversion Road, and Emilio Aguinaldo Highway.

To date, the DOTr under Bautista has established almost 800 km. of bike lanes in 32 localities nationwide. (PNA)
