SC Upholds P65-B Deal for LRT-1 Cavite Extension

The Supreme Court has affirmed the validity of the \$\mathbb{P}65\text{-billion concession}\$ agreement between the Philippine government and Light Rail Manila Corporation (LRMC) for the extension of Light Rail Transit Line 1 (LRT-1) to Cavite.

In a decision written by Associate Justice Marvic Leonen, the Court en banc dismissed the petition filed by activist groups Bagong Alyansang Makabayan (Bayan) and Train Riders Network (TREN), which

Career Fest 2025 Prepares Cavite Graduates for the Workforce



On May 28-29, 2025, the Provincial Government of Cavite thru the Office of the Provincial Public Employment Service Manager (OPPESM) held the Career Fest 2025 at De La Salle University - Dasmariñas (DLSU-D) High School Complex. In partnership with the DLSU-D administration, the event brought together graduating college students and alumni of the school for a two-day event focused on career preparation, employment opportunities, and

sought to declare the 2014 agreement unconstitutional. Awarded by the then-DOTC (now DOTr) and the LRTA, the deal was granted to LRMC—the sole bidder and a consortium of Metro Pacific, Ayala, and Macquarieon May 28, 2014.

The agreement, signed in October 2014, includes mainteoperation, nance, and extension of LRT-1's 20.7-kilometer line by an additional 11.7 kilometers to Bacoor, Cavite. LRMC will operate the expanded line for 32 years. The petitioners raised concerns over fare increases, labor rights, and lack of transparency. They claimed the public was denied access to the full agreement and that LRMC's control jeopardized the job security of LRTA employees. The Court disagreed, stating

that fare-setting authority lies with the LRTA under Executive Order No. 603 and that any fare hikes are subject to regulatory oversight. It also ruled that the concession agreement is not an employment contract and that labor laws still protect transferred workers. On the issue of transparency, the justices found that bidding documents and project details were publicly disclosed as required by law.

The Court also rejected the argument that the deal was a legislative franchise, affirming the DO-Tr's authority under Executive Order No. 125-A. The ruling marks a significant legal win for the government and paves the way for the continued development of one of Metro Manila's most important mass transit projects.

A total of 1,773 students and alumni participated in Career Fest 2025, making it a successful initiative in preparing young professionals for the competitive labor market. heritage advocates for a daylong formation session focused on preserving the historical, architectural and spiritual identity of local parishes.

The initiative was led by the Fr. Virgilio Saenz Mendoza, priest-animator of the diocesan cultural heritage ministry, emphasized the urgency of protecting Cavite's Catholic legacy.

"Cavite is very rich in terms of its history, church architecture, and even intangible heritage," Mendoza said. "We should do something to protect and promote them."

Mendoza, who has served in the clergy for more than 40 years, said he has witnessed the gradual

loss of historical character in Cavite's churches, citing structural alterations and the fading of pious traditions and sacred artifacts.

Through the program, he said, lay volunteers can take an active role safeguarding parish in heritage.

Resource speakers offered insights on heritage preservation from a variety of perspectives.
