OWWA Aids OFW Families in Calabarzon



he Overseas Workers Welfare Administration (OWWA) Calabarzon has provided aid and medical support to families of overseas Filipino workers (OFWs) affected by recent severe weather in the region.

Around 5,800 OFW dependents received relief packs, hygiene kits, and other essential supplies across Calabarzon provinces, the agency reported.

In partnership with the Philippine Red Cross, OWWA also offered free medical consultations and medicines to ensure that families received both immediate relief and health services.

The initiative forms part of OWWA's Crisis Assistance Program, which prioritizes OFWs and their families during calamities. "Patuloy na ipinapakita ng OWWA IV-A ang

he United States has donated PHP1.9 million (USD34,500) worth of equipment to the Philippine Coast Guard's (PCG) Fleet Maintenance and Repair Group (MRG) Workshop in Sangley Point, Cavite, reaffirming its commitment to strengthen Philippine maritime security.

The donation, turned over on Aug. 18 through the US Department of State's Bureau of International Narcotics and Law Enforcement Affairs (INL), is expected to enhance the PCG's capacity to maintain and repair its vessels.

"This activity is another important step in our capability buildup to provide the necessary equipment for our MRG," said PCG Fleet Commander Rear Admiral Rommel Supangan, adding that the assistance underscores strong US-Philippine maritime cooperation.

INL Director Kate Richie said the support will allow the PCG to sustain its fleet more effectively. "This transfer of essential equipment and backup power supply will enable a broader and more effective repair program," she noted.

The Sangley Point facility, inaugurated in May 2024 with PHP54 million (USD950,000) in US funding and Coast Guard technical support, complements an existing MRG workshop in the Manila Port Area. Both aim to strengthen maintenance capability for small boats and large patrol vessels vital to law enforcement and maritime defense.

INL and other US agencies are also preparing further assistance, including technical training, logistics planning,

He also requested direct intervention from the Department of Public Works and Highways, the National Irrigation Administration, and the Department of Environment and Natural Resources for large-scale dredging.

"The dams and rivers that once protected us are

now clogged with silt and debris. Without immediate support from the national government, thousands of lives and homes remain at risk," Revilla said.

The city's appeal also includes the desilting of rivers and canals in floodprone barangays, based recommendations

from the City Engineering Office. Bacoor's Drainage Plan incorporates the 2022 JICA Master Plan, a supplementary plan from DPWH, and a feasibility study for the Bacoor River Improvement Project. However, Revilla noted delays in responses to longstanding requests, such as the transfer of the Molino dams from NIA, which have hampered progress.

Revilla assured that the city is ready to implement and manage assistance from the national government in coordination with concerned agencies. He stressed the urgency of immediate action, warning that prolonged delays only heighten risks to residents and property.

PGC's Medical and Dental Mission Serves Tanza Residents

he Provincial Government of Cavite (PGC) extended free healthcare services to residents of Springtown Phase 1 Main Subdivision, Barangay Bucal, through a medical and dental mission aimed at strengthening access to essential health services.

A total of 668 patients benefited from free medical consultations, while 90 individuals availed of dental care services. The mission also provided 31 X-ray examinations and 18 ECG tests, alongside the distribution of free prescribed medicines and vitamins to support patient recovery and wellness.

The activity was attended by Tanza Councilors Ryan Mintu and Derek Matro, as well as 7th District Board Member Aldrin Anacan, who expressed their support for the initiative.

The program aimed to strengthening cooperatives

equip cooperative leaders and members with practical mediation skills to promote harmony, collaboration, and effective conflict resolution within their organizations.

The seminar opened with message from Ms. Rizalie Pinpin-Enero, Provincial Public Employment Service Manager, who welcomed the participants on behalf of Governor Abeng Remulla. She emphasized importance of alternative dispute resolution in and acknowledged the resource speakers' expertise.

Rep. Poe Seeks Lower Terminal Fees for Pinoy Travelers

FPJ Panday Bayanihan Party-list Rep. Brian Poe has called on the Department of Transportation (DOTr) to explore ways to reduce or remove terminal fees for Filipino passengers, saying the revenues should provide direct relief to the public. "Every peso counts for our kababayans. If the government is already taking 82 percent of terminal fee revenues, then a portion of that should go back to the passengers through subsidies or reductions," Poe said Friday. During a recent budget hearing, Acting Transportation Secretary Giovanni Lopez explained that 82 percent of terminal fee collections go to the national treasury, while only 18 percent remains with concessionaires for operations. Poe noted that terminal charges have sharply increased, with domestic fees now at P390 and international terminal fees rising from P550 to P950. He also cited the planned 233-percent hike in Batangas Port fees that was scrapped following public backlash. The lawmaker said Congress could mandate that part of terminal fee revenues be reallocated as subsidies to ease costs for travelers. "Transportation is a basic necessity. If we can remove or at least subsidize terminal fees, even just for domestic travel, it will already be a big help," he stressed. Poe added that modernization efforts should focus on making travel more convenient and affordable, not more expensive.
