TRECE MARTIRES, Cavite — In response to the recent declaration of a state of calamity in Cavite due to the severe effects of the southwest monsoon intensified by Tropical Storm Crising, the Department of Trade and Industry (DTI) - Cavite has launched a provincewide price monitoring initiative focused on basic necessities.

Citing Section 6 of Republic Act 7581, or the Price Act, the DTI reminded the public that prices of all basic goods are automatically frozen at their prevailing

Nano Forge to Open P30-M **Ecozone Plant in Cavite**

The Philippine Economic Zone Authority (PEZA) has signed a registration agreement with Nano Forge Solutions, Inc. for the establishment of a manufacturing facility at the Golden Mile Business Park-Special Economic Zone in Carmona, Cavite.

"We are confident this industry-aligned venture will strengthen local manufacturing, elevate export potential, and generate new employment opportunities in Cavite," said PEZA Director General Tereso O. Panga.

With an estimated cost exceeding P30 million, the Nano Forge facility is slated to begin commercial operations next month, aiming to create over 100 jobs.

CITY, Cavite - Despite the return to full in-person classes in most of the country, one public school in Cavite is continuing with a blended learning setup due to a serious lack of classrooms.

of face-to-face instruction with two days of online or asynchronous learning. The shift comes as the school struggles to accommodate nearly 4,000 students with fewer than 40 available instructional rooms.

Xaris Llorente, a teacher at LYFJSHS since 2016, explained that while the blended system helps keep class sizes from becoming unmanageable, it still falls short of providing an ideal learning environment.

"If we push for a full five-day face-to-face schedule, we might end up with as many as 100 students an interview. "Right now, it's more manageable, but the quality of learning is still affected."

Students echo the concern. A Grade 12 student who asked to remain anonymous shared that in-person classes provide

per classroom," she said in better clarity, interaction, and motivation. "Classroom discussions are engaging and effective," the student said. learn better when you're physically present with your classmates.'

continues to grapple with a classroom shortage that now stands at around 165,000, a backlog worsened by years of underinvestment and the impacts of the COVID-19 pandemic.

The ongoing reliance blended learning LYFJSHS mirrors a broader challenge. A recent report from the Second Congressional Commission Education found that learning gaps in the Philippines have worsened since the pandemic, with some students behind by up to three years.

Though teachers like Llorente acknowledge that some students continue to perform well, she believes deeper engagement and consistent face-to-face interaction are key to closing the widening educational divide. Nano forge to open P30-M

The plant will produce highefficiency air filters for air purifiers and is expected support innovations sustainable clean-air technology in the Philippines.

Once completed, the bridge will cut travel time between Cavite and Bataan from approximately five hours to just 45 minutes.

Other components include land and marine viaducts, two major navigational bridges — the 400-meter North Channel Bridge and the 900-meter South Channel Bridge and additional ancillary works. Notably, about 80% of the bridge will span over Manila Bay, crossing near Corregidor Island.

P20/kilo rice achievable without hurting farmers – PBBM

By Stephanie Sevillano

President Ferdinand R. Marcos Jr. on Monday highlighted the fulfillment of one of his key promises for Filipinos – the PHP20 per kilogram of rice under the "Benteng Bigas Meron (BBM) Na" during his fourth State of the Nation Address (SONA).

"Napatunayan natin na kaya na natin ang bente pesos sa bawat kilo ng bigas, nang hindi malulugi ang mga magsasaka (We have proven that we can fulfill the PHP20 per kilogram rice without hurting our farmers' income)," the President said.

Dubbed "Benteng Bigas Meron (BBM) Na," the program has been launched in areas across Luzon, Visayas, and Mindanao. "Kamakailan lamang ay matagumpay nating nailunsad ito sa (Recently, we have successfully launched this in) Luzon, Visayas at (and) Mindanao kagaya sa (like in) San Juan, Pangasinan, Cavite, Occidental Mindoro, Cebu, Bacolod, Guimaras, Siquijor, at (and) Davao Del Sur," he added. The rice is sourced from aging but good-quality stocks of the National Food Authority (NFA), purchased



from local farmers. NFA's buying price has been higher than some of the traders' prices, set at PHP17 per kg for fresh and wet palay and up to PHP24 per kg for clean and dry palay, under the Price Range Scheme (PRICERS).

At least 94,483 farmers have benefited from PRICERS since April 2024, according to the NFA.

Marcos assured the public that the rice program would be expanded to reach more Filipinos, backed by billions of pesos in government funding. "At dahil sa ilalaan nating

isandaan at labintatlong bilyong piso upang palakasin ang mga programa ng DA, ilulunsad na natin ito sa buong bansa, sa pamamagitan ng daandaang KADIWA Stores at Centers sa iba't ibang lokal na pamahalaan (And because of the PHP113 billion funds to be allocated to boost the program of DA, we will launch this nationwide through hundreds of Kadiwa Stores and Centers and various local government [partnerships])," he said.

The Marcos administration aims to expand the PHP20 per kilogram rice program in 1,500 Kadiwa ng Pangulo (KNP) sites in the country before the end of his term. To date, the DA said the BBM Na is available in 757 KNP centers, pop-up stores, and accredited sites.

Since its launch in May, the DA reported almost a million Filipinos or about 217,000 household beneficiaries, including senior citizens, persons with disabilities, solo parents, beneficiaries of the Pantawid Pamilyang Pilipino Program (4Ps) and the Walang Gutom Program, and minimum wage earners. GSIS expands emergency loan coverage in Luzon, Metro Manila

The Government Ser-Insurance System (GSIS) is expanding its emergency loan program to cover more areas in Luzon and Metro Manila that have been placed under a state of calamity.

The state pension fund is also urging members and pensioners to file their applications digitally for faster

"As more local government units (LGUs) declare a state of calamity, we are prepared to extend our emergency loan assistance to ensure that no member is left behind in times of need," GSIS officer-in-charge Juliet Bautista said in a news release on

"This expanded coverage is part of our continuing commitment to provide immediate relief to our members and pensioners affected by [Severe] Tropical Storm Crising, habagat, and related calamities," she added.

Starting July 25, GSIS members and pensioners residing in Cainta, San Mateo, and Montalban in Rizal; and the cities of Malabon, Marikina, Las Piñas, Navotas, and Valenzuela, may apply for the emergency loan until



Oct. 24, 2025. Earlier, GSIS also opened the facility to those residing or working in Agoncillo in Batangas, Balagtas in Bulacan, Malasiqui in Pangasinan, Roxas in Palawan, the provinces of Bataan and Pampanga, and Dagupan City in Pangasinan. Applications for these areas are accepted until Aug. 24,

These areas are in addition to Cavite, Quezon City, Umingan in Pangasinan, Calumpit in Bulacan, and the City of Manila, which were among the first to be covered.

"Sa mga lugar na ito, puwede nang mag-apply sa pamamagitan ng GSIS Touch mobile app. Sa tulong nito, mabilis at ligtas na proseso ang aming naibibigay (In these areas, members may already apply through the GSIS Touch mobile app. With this, we offer a fast and secure process)," Bautista

During an interview with Bagong Pilipinas Ngayon, GSIS NCR Operations Group Senior Vice President Joseph Phillip Andres said an emergency loan is available to active members who either reside in or are working within an area declared under a state of calamity. Pensioners living in these areas may also apply.

"Para sa mga miyembro, dapat sila ay aktibo, walang pending administrative case, may hulog ng tatlong buwan sa GSIS, at may net takehome pay na hindi bababa sa PHP5,000 pagkatapos ng loan deduction (For members, they must be in active service, with no pending administrative case, have made at least three months of contributions, and must have a net take-home pay of not less than PHP5,000 after loan deductions)," Andres said.

"For pensioners, at least 25 percent of their gross monthly pension must remain after the loan deduction," he added.

may avail of a PHP20,000 emergency loan, while those with an existing emergency loan balance may borrow up to PHP40,000, with the outstanding balance deducted from the new loan.

"To illustrate, kung may natitirang PHP10,000 sa luma nilang loan, ang bagong loan na PHP30,000 ay babawasan nito, kaya PHP20,000 ang makukuha nila ngayon (To illustrate, if they have PHP10,000 left from their previous loan, a

new loan of PHP30,000 will pay off the old one, and they will receive PHP20,000 as net proceeds)," Andres said.

The loan is payable in 36 monthly installments with an interest rate of 6 percent per annum and no processing fee. A PHP20,000 loan, for instance, has a monthly amortization of PHP655.56.

Andres also emphasized the effectiveness of the GSIS Touch app, saying that 99.9 percent of emergency loan applications on the first day

were filed through the mobile platform.

"Halos lahat ng miyembro ay naka-transact gamit ang GSIS Touch. Hindi na kailangang pumunta sa opisina, lalo na sa panahon ng sakuna (Almost all members transacted using GSIS Touch. There's no need to visit our offices, especially during times of disaster)," he
