#### **JUDGMENT**

This case arose out of the Complaint filed by Phoenix Ready Mix Concrete Development and Construction, Incorporated, for collection of sum of money, seeking the judgment be rendered directing defendant One Mega Builders Construction Corporation to pay the following: Nine Hundred Forty Seven Thousand Five Hundred Sixty Pesos and Ninety Centavos (Php 947,560.90), representing the total outstanding obligation for the purchases, as of 16 February 2017, and interest of eighteen percent (18%) per annum, as stipulated in the Contract Proposal and Agreement, from 20 April 2016 until full payment; twenty-five percent (25%) of the total amount due, as attorney's fees, and appearance fee of Three Thousand Pesos (Php3,000.00), for every hearing attended by counsel, and; cost of suit.

It was originally assigned to the Regional Trial Court of Imus City, Cavite Branch 20, but pursuant to Administrative Order Number 180-2019, dated 2 September 2019, it was re-assigned to this court. The case was initially dismissed, for failure to prosecute.

With the plaintiff's filing of its Motion for Reconsideration of the Order, dated 12 November 2019 with Motion for Leave of Court to serve Summons by publication, the dismissal of the case was set aside and leave was granted to serve summons on defendant, by

The case was subsequently dismissed, upon plaintiff's noncompliance with the Order, dated 22 June 2022. The dismissal was set aside, with the plaintiff's filing of the Omnibus Motion With Sincerest Apologies.

Upon plaintiff's presentation of proof of compliance with the requirements of the service of summons by publication, and upon its motion, the defendant was declared in default and plaintiff was allowed to present its evidence.

The plaintiff presented its witnesses Michael Nolasco and

Michael Nolasco testified through his Judicial Affidavit, dated 13 October 2023 and in court.

He identified himself, as the marketing sales representative, and authorized representative of the plaintiff, for the purpose of the herein case, as shown by the Secretary's Certificate, dated 5 October 2017. He declared that the plaintiff is a corporation registered under the Securities and Exchange Commission, as shown by the corresponding Certificate of Incorporation, dated 19 September 2000 and Articles of Incorporation, dated 18 August 2000. He further declared that the defendant One Mega Builders Construction Corporation is a corporation registered under the Securities and Exchange Commission, as shown by the Certificate of Incorporation, dated 6 December 2010, and Articles of Incorporation, dated 28 October 2010.

The defendant through its owner/president Ma. Czarina Lagman, entered into Contract Proposals and Agreement Nos. 10542 and 10636 dated 17 March 2016 and 23 April 2016, respectively, for plaintiff to supply it with various quantities of ready mix concrete cements. Pursuant to the said contracts, plaintiff sold and delivered to the defendant, various quantities of ready mixed concrete cement, as shown by the following:

2. Sales Invoice No. 63320 and corresponding Delivery 304093 304087, 304086, 304072, 304068 304067 304061 304060 304059 304056 304051 304050 304049 304044 304043 304041 304040 304037 304036 304026 304025 and 304024, all dated 20 April 2016:

3. Sales Invoice No. 63372 and corresponding Delivery Receipt No. 304351, both dated 23 April 2016;

4. Billing statement numbers 1486 and 1575, dated 22 March 2016 and 20 April 2016.

Nolasco subsequently identified the signatures of the defendant's representative Kim Orbase in the delivery receipts, sales invoices and billing statements. He also identified the signatures of plaintiff's employees/dispatchers Alvin Alvarez, Arnel Vilan and Tzaddi Valdellon, and defendant's employees Engr. J. Pacios, Aizalyn Ubaldo and Maurice Jade Paragos, on the delivery

Defendant thereafter failed to pay for cements it purchased, and plaintiffs counsel served it with the final demand letter, dated 21 February 2017, seeking the settlement of its obligations, which amounted to Php 947,560.90, as shown by the Statement of Account, as of 16 February 2017. Defendant refused to comply with the said demand, resulting in the filing of the hearing case.

Nolasco added that he dealt with the plaintiff's clients, once they give the purchase order, and he monitored the deliveries. In defendant's case, he dealt with its project manager on site and its purchasing manager Kim Orbase in the office. He accompanied the deliveries made and the Delivery Receipts were signed by the defendant's staff. The sales invoices were received at the Accounting Department of the defendant's office. The plaintiff's accounting head subsequently took custody of the signed delivery receipts and signed sales invoices.

On clarificatory questioning, Nolasco stated that the sales invoices are prepared, two to three days after each delivery.

The plaintiff's next witness Pepito C. Taas, Jr., testified through his Judicial Affidavit, and in court.

In his testimony, he identified himself as part of the accounting

staff of plaintiff's counsel Corpuz Ejercito Macasaet Rivera & Corpuz Law Offices, and he is familiar with plaintiff, since he has encountered its account while reviewing billing statements and monitoring payments, in the course of performance of his duties at said law office. He stated that pursuant to the Engagement Fee Agreement, dated 18 June 2009, the plaintiff has incurred costs and expenses for the legal services rendered by their law office pursuant to this case, as shown by the Statement of Account for the Unpaid Services, as of 11 March 2024, in the total amount of Php 8,565.00, in unpaid expenses and Statement of Account for the Paid Services, in the total amount of Php 32,923.50, as shown by Official Receipt No. 0010480.

The sole issue for resolution is whether the defendant is liable to pay plaintiff, the following: Nine Hundred Forty Seven Thousand Five Hundred Sixty Pesos and Ninety Centayos (Php 947.560.90), as the total outstanding obligation for the purchases, as of 16 February 2017; interest of 18% per annum on the amount, from 20 April 2016 until full payment; 25% of the total amount due, as attorney's fees, and appearance fee of Three Thousand Pesos (Php3,000.00), for every hearing attended by counsel. and: cost of suit.

The rights and obligations of the parties herein shall be determined by the contract/s that they executed between them. Jurisprudence has decreed, thus:

It is well-established that a contract is the law between the parties. Obligations arising from contracts have the force of law between the contracting parties and should be complied with in good faith. "Unless the stipulations in a contract are contrary to law, morals, good customs, public order, or public policy, the same are binding as between the parties." From the moment the contract is perfected, the parties are bound not only to the fulfillment of its stipulations, but also the consequences which, according to their nature, may be in keeping with good faith, usage, and law.

The parties executed Contract Proposal and Agreement Contract

Nos. 10542 and 10636, dated 17 March 2016 and 23 April 2016, respectively. Pursuant to the said agreement, the plaintiff undertook to supply all labor materials and equipment supervision, for the work described, in the said contracts, to the defendant.

Based on the Statement of Account, as of February 16, 2017, the defendant has outstanding obligations for nonpayment of the following: Php 615,600.00, under Sales Invoice No. 63320; Php 30,780.00, under Billing Statement No. 1575, and; Php16,250.00, under Sales Invoice No. 63372, or all in the total amount of Php662,630.00.

The proof of receipt of the items and service were shown by the signatures of employees of both plaintiff and defendant, on the corresponding Delivery Receipts, Sales Invoices and Billing Statement. Defendant's receipt of the demand letter, on 23 February 2017, was shown by the signature of its authorized representative Adrian Forfeida.

Hence, the plaintiff sufficiently established that it is entitled to the payment of the value of the goods and services delivered, in the total amount of Php 662,630.00. In Isla v. Estorga, the Supreme Court gave the following discussion on monetary interest and compensatory interest, thus Case law states that there are two (2) types of interest, namely, monetary interest and compensatory interest. Monetary interest is the compensation fixed by the parties for the use or forbearance of money. On the other hand, compensatory interest is that imposed by law or by the courts as penalty or indemnity for damages. Accordingly, the right to recover interest arises only either by virtue of a contract (monetary interest) or as damages for delay or failure to pay the principal loan on which the interest is demanded (compensatory interest).

In the herein case, the submitted copies of the contracts between the parties, failed to reflect the provision on the imposition of the monetary interest. However, said contracts were supplemented by Sales Invoices, containing the following common provision:

TERMS: All sales other than Cash or C.O.D. are understood to be payable upon presentation of invoice, and or not later than ten (10) days after date of invoice, unless otherwise agreed upon. Interest of 12% per annum is to be charged on all overdue accounts. An additional sum equal to 25% of the amount will be charged by the Vendor for Attorney's fees and cost of collection in case of suit "

The Billing Statement, on the other hand, contained the following common provision, thus: Interest annum is to be charged on all accounts overdue plus 25% of said amount for Attorney's fees and cost of collection in case of suit. xxx

Under the Sales Invoices and Billing Statements, an interest of 12 % per annum shall thus, be charged on all overdue accounts and it is considered the monetary interest for which defendant is liable, in contemplation of the abovecited jurisprudence.

As previously discussed, the grant of compensatory interest is also mandated by law, thus:

In addition, not only the principal amount but also the monetary interest due to respondent as discussed above shall itself earn compensatory interest at the legal rate, pursuant to Article 2212 of the Civil Code, which states that "[i]nterest due shall earn legal interest from the time it is judicially demanded, although the obligation may be silent upon this point." To be sure, Article 2212 contemplates the presence of stipulated or conventional interest, i.e., monetary interest, which has accrued when demand was judicially made. In cases where no monetary interest had been stipulated by the parties, no accrued monetary interest could further earn compensatory interest upon judicial demand. Thus, the principal amount and monetary interest due to respondent shall earn compensatory interest of twelve percent (12%) per annum from judicial demand, i.e., the date of the filing of the complaint on July 24, 2007, to June 30, 2013, and thereafter, at the rate of six

percent (6%) per annum from July 1, 2013 until fully paid. Hence, plaintiff is entitled to compensatory interest of 6 % per annum, from the judicial demand or from the filing of the complaint in court, on 28 February 2018.

It appearing that the under the abovequoted provisions of the Sales Invoice and Billing Statements, attorney's fees and costs of suit equivalent to 25 % of the unpaid amount shall be paid, then defendant is additionally liable for such fees, pursuant to Article 2208 of the Civil Code.

Wherefore, premises considered, Judgment is hereby rendered GRANTING the Complaint, and defendant One Mega Builders Construction Corporation is ORDERED to pay plaintiff Phoenix Ready Mix Concrete Development & Construction, Inc.,

(a) Six Hundred Sixty-Two Thousand Six Hundred Thirty Pesos (Php 662,630.00), representing the unpaid obligation; (b) Monetary interest at the rate of twelve percent (12%) per annum, from the date of extraiudicial demand made on 23 February 2017, until fully paid;

(c) Compensatory interest on the monetary interest as stated in letter (b) at the rate of six percent (6%) per annum from judicial demand or the date of filing of this Complaint, on 28 February 2018, until fully paid; and

(d) Legal interest at the rate of six percent (6%) per annum imposed on the sums due in letters (a), (b), and (c) from finality of this Judgment, until full payment.

Let this Judgment be published twice, for two (2) consecutive weeks, in a newspaper of general circulation, as may be chosen by raffle, pursuant to Rule 13, Section 13 of the Rules of Court.

# Concio gains share of lead in Asian Juniors chess

Filipino International Master (IM) Michael Concio Jr. defeated FIDE Master (FM) Arjun Adireddy of India to gain a share of the lead in the sixth round of the 2024 Asian Juniors and Girls Chess Championships at the Knights Templar Hotel in Tagaytay City, Cavite on Thursday.

Concio, who reached the World Chess Cup in 2021 after placing second to compatriot Grandmaster (GM) Daniel Quizon in the Asian Zonals the World Chess Cup in 2021, prevailed after 32 moves of the Ruy Lopez.

With four wins in six games, Concio has five points to join top seed GM Aleksey Grebnev of Russia, and No. 7 IM Munkhdalai Amilal of Mongolia on top of the standings.

His two draws were against Grebnev and No. 4 IM Artem Uskov, also from Russia

Grebnev beat Uskov after 51 moves of the Catalan, while Amilal conquered Candidate Master (CM) Yash Bharadia of India in 40 moves of the Sicilian.

Uskov is in solo second with 4.5 points, followed by No. 3 IM S. Aswath of India, Concio's seventh-round opponents, and No. 12 Filipino FM Gian Karlo Arca with four points.

Aswath prevailed over David Sean Romualdez of the Philippines, while Arca settled for a draw with compatriot Andrei Ainsley Dolo-

In the girls' division, defending champion and top seed WIM G. Tejawisni of India outplayed unbeaten

Despite the loss, Shukhman kept the lead with five points.

Tejaswinji is second with 4.5 points in a tie with her compatriot, No. 6 H. Sneha, who trounced ACM Ainul Afif Mohd of Malaysia.

WFM Kristina Popandopalu of Kazakhstan defeated WFM V. Rindhiya of India for joint third with Mohd at four points.

In the operation of the Philippine National Police (PNP) there are innocent people who are affected, and some of them are minors (menor de edad) who died because of "Operation Tokhang" thus becoming Extra-Judicial Killings (EJK's.

The NCCP with various religious members who are church affiliated publicly expressed concern, in relation to what former PCSO chief and police colonel Garma revealed in the hearing of the House Quad Committee involving the former administration in EJK's in OPLAN Tokhang

In the hearing of the House quad committee, Garma revealed that there is a reward system that will reach P20,000 to P1 million for policemen who kill a suspect who is a "drug personality" due to illegal drug activity. The pursuit of the operation includes the involved "drug suspects" that they can kill depending on the level, there is also a reward during the war on drugs operation throughout the country.

The NCCP is dismayed at the issue of killings during the war on drugs campaigns, so they fully support and hope that the International Criminal Court (ICC) will be allowed to intervene to investigate and hold accountable those responsible involved in the drug war EJKs so that the victims can get justice.

The NCCP statement, "Considering the extensive scope of Colonel Garma's revelations, which includes the fact that perpetrators continue to hold significant influential positions within government and the system and connections in place, the National Council of Churches in the Philippines supports the call to permit the International Criminal Court (ICC) to undertake its investigation in the Philippines."

The prayer of the whole church is that the government will notice and give justice to the victims and families of extrajudicial killings due to the country's war on drugs. The NCCP further urged the lawmakers to investigate the loopholes in the laws that those in power in the government continue to use to justify the alleged syndicated killings in Operation Tokhang.

Under the agreement for KaSSSangga Sa Coverage

Program, JOW and COS workers of both city and municipality government, as well as the Barangay workers will be having access to SSS coverage by becoming self-employed members thus entitled to various SSS bene9ts in times of contingencies such as sickness, maternity, disability, retirement, funeral, and death, as well as to qualify for SSS loan programs like salary and calamity loans. Moreover, they would also get additional bene9ts from the Employees' Compensation (EC) Program for work-related sickness, injuries, and death. The program will ensure the social security coverage of about 773 job order (JO) /casuals workers and at least 410 barangay workers from the said city and municipality.

The "E-Center Program", is also another program that has been entered into MOA simultaneously with the KaSSSangga Sa Coverage Program, which aim to bring the SSS services closer to the people at their very own barangay or municipality.

# New MTP South Roads to Aid Cavite, Laguna Motorists

TRECE **MARTIRES** CITY, Cavite (PIA) - Motorists from Cavite and Laguna will soon benefit from the completion of several key segments of the Cavite-Laguna Expressway (CALAX) and CAVITEX C5 Link, currently being developed by Metro Pacific Tollways Corporation (MPT South). In a statement released by MPT South, these segments include the CALAX Governor's Drive Interchange, Open Canal Interchange, and Kawit Interchange, as well as the C5 Link Segment 3B, which will connect the current Sucat Interchange to the C5 Link Flyover Extension, spanning from SLEX-Taguig to E. Rodriguez in C5. The CAVI-

TEX-CALAX Link, currently under construction, will integrate these two major toll roads, creating a more seamless travel route for motorists. According to MPT South, traffic growth of more than 30% is expected by the end of 2025, translating to over 340,000 daily motorists, a significant increase from the current 259,815. These road segments are set to be operational before the end of 2025, expanding MPT South's total road network to 67 km.

MPT South anticipates that the new segments, designed to reduce travel time and improve accessibility, will encourage more motorists to utilize the expanded network, boosting traffic flow across the region.

The enhanced expressway network is expected to support regional economic growth by facilitating faster, more efficient transport of goods and services between key industrial and commercial hubs in Southern Luzon.

"Aside from providing an enhanced driving experience for our motorists, our projects also aim to contribute to the region's economic development by improving accessibility and connectivity," said MPT South President and General Manager, Mr. Raul L. Ignacio.

Shortened travel times will bring additional benefits, such as reduced fuel consumption and lower vehicle emissions, contributing to nation-building and



enhancing the quality of life for Filipinos. MPT South announced it will allocate Php14 billion in capital expenditures in 2025 to support the construction and

maintenance of its infrastructure projects. "Despite the challenges we face in construction, such as the timely delivery of right-of-way and the recent typhoons, we are

working around the clock to ensure the completion of these vital infrastructure projects by the end of 2025," Ignacio added. (PIA-Cavite/
