indexes in several areas in Cavite, Metro Manila, Batangas, Pangasinan, Bulacan, Isabela, Mindoro, and Zamboanga del Norte.

"Lahat naman po ay tinututukan natin kasi dahil po sa init ng panahon, lahat po ng ating agricultural commodity maaari po siyang maapektuhan but lalunglalong na po iyong ating mga (We are focusing on all commodities because of the dry season, all of our agricultural commodities may be affected but most especially the) high value crops (HVC), iyong mga gulay (the vegetables)," DA deputy spokesperson Assistant Secretary Joycel Panlilio said in an interview.

She said most HVCs are sourced from the Cordillera Administrative Region (CAR), Ilocos and Cagayan Valley. Panlilio assured preventive actions against potential agricultural damage due to extreme heat.

"We make sure po na meron tayong mga interventions na binibigay para maiwasan po itong effect ng pag-init ng ating panahon (that we have interventions being implemented to prevent the effects of the hot weather)," Panlilio said.

She said the preventive measures include utilization of plastic mulch as vegetable beds, a small pump irrigation system, drip water fertigation technology, and adequate rainwater reserve in rainwater shelters.

poultry Panlilio animals must be protected from extreme heat exposure.

"Iyong mga animals sisiguruduhin po natin nasa tamang mga shelter sila para hindi naman po sila masyadong ma-expose sa heat na maaaring mag-cause din po sa kanila ng sakit (We will ensure that our animals are in proper shelters so they will not be exposed to heat which can cause them disease)," she said.

Aid to Kanlaon-affected

Panlilio, meanwhile, assured aid for farmers affected by the eruption of Mt. Kanlaon in Negros Occidental.

"We give our usual interventions kapag kaya na po nila ulit na magtanim ay iyong mga agricultural inputs natin like 'yung mga seed po and meron naman kasi kaming (if they can already replant, including agricultural inputs like seeds and we also have a) quick response fund for this," she said. Besides the distribution of seedlings, drugs, and biologics, the DA also prepared a PHP25,000 loanable amount under the Survival and Recovery loan program, payable in three years at zero interest; as well as the indemnification fund from the Philippine Crop Insurance Corporation.

To date, 61 farmers were initially reported to be affected in Western Visayas, with damage incurred in HVC and cassava worth PHP952,200, according to the DA-Disaster Risk Reduction and Management Operations Center. (PNA)

ORDER

This is an Amended Petition, filed by petitioner Nona S. Lago, received by the Court on March 15, 2025, praying, among others, for the Court to fix and approve the bond over the proceeds of the sale of the minor's undivided share in TCT No. 057-2015008097 and ratifying the sale of the undivided share of the minor herein.

Petitioner alleged, in her Amended Petition, that:

- 1. Petitioner NONA S. LAGO is a Filipino citizen, widow of the late RUEL L. LAGO, of legal age and a resident of Block 8 Lot 4, Greenvillas Subdivision, Buhay na Tubig, Imus, Cavite. She may be served with orders and court processes at the address of the undersigned counsel. A copy of Marriage Certificate of the late Ruel L. Lago and petitioner is hereto attached as Annex A and made an integral part hereof.
- 2. Petitioner is the mother of and surviving parent of CARLOS GABRIEL S. LAGO, single, born on April 27, 2011, minor and is living with his mother in Block 8 Lot 4, Greenvillas Subdivision, Buhay na Tubig, Imus, Cavite. A copy of Live Birth Certificate of the minor child of petitioner is hereto attached as Annex B and made
- 3. On July 3, 2023, Ruel L. Lago died without a will and without debt. He left his widow and two (2) children, Denise Rose S. Lago who is already of legal age and minor Carlos Gabriel S. Lago: He did not leave sufficient cash to support his heirs. A copy of the Death Certificate of the late Ruel L. Lago is hereto attached as Annex C and made an integral part hereof.
- 4. The only property left by Ruel L. Lago when he died is the house and lot with an area of fifty (50) square meters more or less located at Road 30, Kensington 2, Block 8, Lot 84, Brgy. Navarro, General Trias, Cavite covered by Transfer Certificate of Title No. 057-2015008097 of the Registry of Deeds of the Province of Cavite. A copy of the Transfer Certificate of Title is hereto attached as Annex D and made an integral part hereof.
- 5. Thus, the undivided share of the minor child in the real property of the late Ruel L. Lago subject of this Petition, after removing the surviving spouse's share in the absolute community of property and the share of Denise Rose S. Lago is equivalent to 1/3 of 1/2 or 16.67% of the aforesaid real property.
- 6. On September 24, 2024, the heirs of Ruel L. Lago, the minor being represented by his mother, executed an Extrajudicial Settlement of Estate with Unilateral Deed of Absolute Sale in favor of Romeo L. De Ve Jr., first cousin of the late Ruel L. Lago. This was done mainly in order to defray the family expenses since petitioner was diagnosed with hyper tension and now under continuous maintenance medication.
- 7. Petitioner had no choice but to resign from her job last April 2024 since her request to be assigned on a day shift assignment so that she could take care of her child was denied. She could not risk leaving her children alone at night while she is at work. A copy of the Extrajudicial Settlement of Estate with Unilateral Deed of Absolute sale is hereto attached as Annex E and is made an integral part hereof.
- 8. That the names and residences of the relatives of minor Carlos Gabriele S. Lago outside of petitioner within the fourth civil degree are as follows:

9. Considering that the value of the real property belonging to the minor that was sold by petitioner is only 16.67% of the selling price of the aforesaid property, and the same was not deriving or producing any income, there is no doubt that petitioner will have a hard time coping with the family expenses including the sustenance and education of the minor child and it is for the best interest and benefit of the minor that the real property was sold.

- 10. Considering the value of the share of the minor in the estate of the late Ruel L. Lago is only 16.67% of the selling price of the aforesaid property, petitioner begs this Honorable Court to approve or ratify the sale of the undivided share of the minor Carlos Gabriel S. Lago expeditiously, so that the aforesaid sale can be consummated. In this way, the proceeds from the sale can help send the minor to school and to pay for his needs and care, before inflation can diminish the value of the purchase price agreed upon by petitioner and the buyer.
- 11. Though Petitioner is already considered as the legal guardian of Carlos Gabriele S. Lago, the former being the mother of said minor, there is still a necessity of posting guardianship bond considering that the share of said minor exceeds FIFTY THOUSANDS PESOS (P50,000.00). Hence, this petition.

WHEREFORE, finding the petition to be sufficient in form and substance, let the same be set for hearing on May 26, 2025, at 8:30 a.m. Any interested party may appear and show cause why this petition should not be granted

Let this Order be published once in a newspaper of general circulation, as may be chosen by a raffle.

Notify the relatives of the minor mentioned in this Petition, as well as the minor, Carlos Gabriel S. Lago, at their given addresses. Considering that some of the minor's paternal relatives reside in Australia, the petitioners are directed to furnish them a copy of this Order, at their expense, through registered mail, at their given addresses and to present the proof of service thereof during the hearing on May 26, 2025.

Pursuant to Section 9, A.M. No. 03-02-05-SC, May 1, 2003, Court Social Worker Belen Azuelo-Viegan, RTC-OCC, Imus City, Cavite is ordered to conduct a case study of the minor and all the prospective guardians and submit a Report and recommendation to the Court for its guidance before the scheduled hearing on May 26, 2025. The social worker may intervene on behalf of the minor if she finds that the petition for guardianship should be denied.

Weather agency PAGASA officially declared Wednesday, April 16, 2025 as the start of the dry season. This coincides with the observance of Holy Week, where travel and outdoor activities in the country peak and, consequently, puts a number of Filipinos at risk for summer- and heat-related illnesses. Last year, from January 1 to April 29, the Department of Health (DOH) reported 77 cases of heat-related illnesses with seven resulting in deaths.

PhilHealth reminds everyone that there are inpatient benefits packages for common summer-related illnesses available at accredited hospitals nationwide:

- Heat stroke, heat exhaustion, heat collapse, heat cramp and sunstroke: Php 12,675
- Heat fatigue and other effects of heat and light: Php 18,135
 Madagata to accurate the destricts Php 7,200.
- Moderate to severe dehydration: Php 7,800
 Varicella/chickenpox without complication: Php 7,800
- Typhoid fever: Php 19,500
- Sore eyes/conjunctivitis: Php 16,575
 Infectious diagraps (south goats posts)
- Infectious diarrhea/acute gastroenteritis: Php 11, 700
 Toxic effect of contect with figh and other marine anim.
- Toxic effect of contact with fish and other marine animals such as jellyfish, sea anemone, shellfish, and starfish: Php 11,115

For acute health care needs, heat-related or beyond, members are covered by the Outpatient Emergency Care Benefit (OECB) Package which can be availed at any accredited Level 1 to 3 hospital.

Meanwhile, PhilHealth continues to underscore the importance of observing preventive measures. PLDT readies P40 billion data center in Cavite

By Elijah Felice Rosales

Telco giant PLDT Inc. is drawing up a plan to build a P40-billion data center in Cavite to support its commitment of raising as much as 500 megawatts of capacity for information storage.

PLDT yesterday inaugurated VITRO Sta. Rosa in Laguna, its 11th and largest data center to date, with President Marcos gracing the launch as guest of honor.

VITRO Sta. Rosa can handle up to 50 MW in capacity, and is the first data center in the Philippines able to handle artificial intelli-

PLDT chairman, president and CEO Manuel V. Pangilinan told the President that the telco plans to provide the Philippines with as much as 500 MW in capacity.

Right now, PLDT's data center builder VITRO Inc. operates 11 facilities with a combined output of 100 MW.

"We do intend to expand our data center capability for up to 500 MW, (as) we have

to be at least equal to the capacity of Malaysia. You have our pledge, Mr. President, to make the Philippines a data center hub," Pangilinan said.

In an interview with reporters, Pangilinan said PLDT is preparing to invest P40 billion to put up its 12th data center, this time in General Trias, Cavite, with a capacity of 100 MW.

Since that facility would become PLDT's biggest by cost and size, Pangilinan said the telco aims to build it in five phases of 20 MW each.

While PLDT is still

ironing out the project specifications of the data center in Cavite, it said it targets to begin construction in 2026 and complete the facility by 2028. Further, Pangilinan said PLDT might hold back on its plan to sell a partial stake in its data centers as he believes the telco has to build more facilities first before it can raise the valuation it wants for its portfolio.

Based on previous negotiations, PLDT's data centers are reportedly worth \$1 billion. The largest Philippine telco had talked to Japan's Nippon Telegraph and Telephone Corp. and European fund manager CVC Capital Partners about the sale, but discussions fell through.

As things go digital, the world has seen a spike in the demand for data centers, where tech giants like Amazon, Google and Meta store their applications and information. With this, telcos like PLDT and Globe Telecom Inc. are racing to construct data centers to position the Philippines as an investment hub in Southeast Asia for digital firms.
