STT GDC investing \$1.56 billion for **Quezon City, Cavite data Centers**

The data center arm of the Ayala Group has invested up to \$1.56 billion for the construction of new data hubs in Metro Manila and Cavite, banking on booming demand for digital infrastructure.

Ayala-backed ST Telemedia Global Data Centers (STT GDC) Philippines is on track to operate the 124-megawatt STT Fairview in Quezon City and the six-MW STT Cavite 2 later this year.

Asked about the investment, company president and CEO Carlo Malana estimated around "\$11-12 million" per MW to develop a greenfield data center facility.

"Usually, you'll find data center costs are done in dollars per MW... It can be a little bit less; it can be a little bit more, depending on how big it goes," Malana

Bayan Muna Party-list and PrimeWater consumers Thursday filed a formal complaint before Malacañang, calling for the cancellation of all joint venture agreements (JVAs) between the Villar familyowned private water utility firm and local water districts widespread service failures and legal violations.

Based on the complaint addressed to President Ferdinand R. Marcos Jr., the group said the JVAs have resulted in frequent water interruptions, poor water quality, high rates, and unresponsive customer service in areas, including San Jose del Monte in Bulacan, Bacolod City, and the provinces of Quezon, Cavite, and Bukidnon.

Bayan Muna alleged that the JVAs, mostly entered into during the administration, Duterte are disadvantageous to the public and violate provisions of Presidential Decree 198, which granted operational control of water districts to their respective boards.

Asked if the Palace is open to calls to cancel the existing deal with PrimeWater, Castro

told reporters yesterday. STT Fairview, which is poised to become the country's largest data center, consists of four phases, with the first phase expected to be launched in the second quarter.

Malana said STT GDC Philippines is set to start the design of the second phase by "the end of this year."

And to further expand its capacity, the company is also constructing its second facility in its data center campus in Cavite. This expansion brings its total data centers to seven.

These data center investments are expected to bolster the digital economy of the Philippines, Malana

"Once seen as a service hub, it's now transforming into a strategic node for digital infrastructure, data connectivity and

innovation," Malana said.

"This is where opportunity lives. This is where STT GDC Philippines builds the future – in a place full of promise," he added.

STT GDC Philippines, a joint venture among Globe Telecom, Ayala Corp. (AC) and Singapore-based STT GDC, currently operates data centers across Metro Manila, Cavite and Davao, all powered by renewables.

Just last Wednesday, the data center builder signed a memorandum of agreement with AC and ACEN Corp. to jointly explore opportunities in the Philippine data center space. "Through this partnership, ACEN will explore initiatives to deliver renewable energy solutions to the growing data center demand in the country," ACEN said in a stock exchange filing yesterday.

SM Foundation Builds Better Classrooms in Tanza

In November 2020. amid the challenges of the COVID-19 pandemic, Punta Elementary School (PES) one of the oldest schools in the booming town of Tanza, Cavite-marked a significant milestone. Through the SM Foundation's School Building Program, in collaboration with SM Prime, the school received a new two-story, four-classroom building that addressed urgent space needs and created a more conducive environment for learning.

Nearly five years on, the building continues to serve as a vital space for students from Grades 3 to 6—many of whom once held classes in the school's covered court due to overcrowding.

With a current student population of around 3,000—double the number from before the turnover the additional classrooms have helped ease congestion at Punta Elementary School, providing space for 55 to 60 learners per class and creating a more conducive learning environment for both students and teachers.

The School Building Program outfitted the classrooms with essential amenities such as electric fans, panoramic whiteboards, and chairs—including those designed for left-handed students-crafted by the Foundation of These-Abled Persons. To further support health and hygiene, the foundation also installed a 10-faucet handwashing station on the school grounds.

This isn't actually just for my learners, but teachers like me also benefit from it," Grade 6 teacher Xeladawn delos Reves attested.
