

'Child-Friendly' LGUs recognized << P1

Government (DILG) IV-A and the Department of Social Welfare and Employment (DSWD) IV-A, recognized 63 LGUs in Calabarzon during the 2022 SCFLG awarding ceremony on April 4, for their exemplary performance in enacting programs and policies aimed at protecting children from abuse. The 2022 SCFLG assessed all 142 local government units in the Calabarzon region through the following indicators categorized under the four categories of children's rights: survival, development, protection and participation,

and governance. In a message of support, Agoncillo, Batangas Mayor Cinderella Valenton Reyes said local government units must protect the rights of children and not make compromises on cases of child abuse.

"The law dictates that we cannot make compromises in cases of child abuse. We, as elected officials, have to take a stand. We cannot make compromises on cases like these," Reyes said.

The local chief executive believes that local leaders have a moral obligation to be an instrument for the welfare and development of children. "We are all tasked by our Lord and the law to be vigilant and protect our youth. When the time comes, it is very difficult for a victim to find their voice and ultimately speak out against the abuse inflicted upon them," Reyes added.

Agoncillo is one of the 11 cities and municipalities in Batangas Province that received the 2022 SCFLG. They are joined by 13 LGUs in Laguna, 10 in Rizal Province, and 15 in Quezon Province.

Meanwhile, Carmona stands with the 14 LGUs in Cavite province to receive the award, having achieved a perfect score of 100 points in the 2022 audit.

Over the years, we have worked tirelessly to create an environment where children can go and realize their potential. We have strived to enable young people to take charge of their own lives, make informed decisions, and be engaged in the processes that affect them," the lawmaker declared.

the disease in Cavite from January to April 2024.

Based on the data presented by Ralph Laurence Figueroa, the health education and promotion officer-designate of Cavite PHO, there are 17 cases of pertussis recorded throughout 2023. By the first quarter of 2024, cases had significantly increased to 36 diagnosed and suspected patients, resulting in 6 deaths during the said period.

"From January 2024 to March 25, 2024, we recorded a total of 36 cases. The number of cases increased significantly at around a 3,500% increase in cases. Aside from that, there were six deaths recorded during that period," Figueroa stated.

While pertussis infect anyone, the Cavite PHO primarily focuses on vaccinating infants and children, as they are deemed the most vulnerable to the respiratory disease.

As of March 30, 2024, individuals infected by the highly contagious disease in the province range from 1 day old to 26 years old.

Figueroa explained: "We are currently prioritizing unvaccinated or undervaccinated children, particularly those haven't completed their primary dose. We cannot deny that we still have shortages of vaccines against pertussis at the moment, which is why we prioritize those unvaccinated

under-vaccinated children." Children ages 1 and a half months old, 2 and a half months old, and 3 and a half months old need to be administered with the Pentavalent vaccine. The vaccine requires three doses and should be completed within a 4-week interval between doses to protect against pertussis. In general, the provincial government of Cavite maintains close coordination with other government agencies, including the Department of Health for the timely reporting of cases, the status of vaccine delivery, and other supplies needed by the province. Along with getting vaccinated to boost defenses against pertussis,

the public is encouraged to wear masks if experiencing a cold or cough, consume nutritious food, and ensure adequate sleep or rest.

As of April 6, 2024, despite continuous measures to control the contagious disease, the DOH-Regional Epidemiology and Surveillance Unit has reported 59 confirmed and suspected pertussis cases in Cavite, with 8 fatalities due to the disease. (CO/PIA-4A)

PBBM lauded for 'monumental' diplomatic win in trilateral summit

Filipinos must continue supporting the Marcos administration and work hand in hand toward a future of peace, progress and prosperity for the country.

President Ferdinand R. Marcos Jr.'s trilateral meeting with United States President Joe Biden and Japanese Prime Minister Fumio Kishida in Washington, D.C. outcome of the trilateral meeting holds immense importance for the Filipino people, the economy and national interest, particularly in the context of the West Philippine Sea (WPS) issues.

"On behalf of the entire House of Representatives, I extend my warmest congratulations to President Marcos for his remarkable achievement in securing a monumental diplomatic victory through the recent historic trilateral meeting with President Biden and Prime Minister Kishida," House Speaker Ferdinand Martin Romualdez said in a statement on Sunday.

As the Philippines navigates the challenges posed by the global pandemic and work towards full economic recovery, such partnerships are instrumental in driving sustainable growth, fostering innovation, and creating employment opportunities for our people, Romualdez added.

He noted that the US and Japan committed to continue their support for Philippine defense modernization priorities and upgrading the capa-

bility of the Philippine Coast

"In addition, the three leaders will also conduct more combined naval training and exercises not only among the three countries but also with additional partners," he said.

Romualdez said aside from improved defense and maritime cooperation, among the major benefits the Philippines would derive from the trilateral summit include the following:

-- Launching of the Luzon Economic Corridor, which will support connectivity between Subic Bay, Clark, Manila, and Batangas by accelerating coordinated investments in high-impact infrastructure projects, including rail, ports modernization, clean energy and semiconductor supply chains and deployments, agribusiness, and civilian port upgrades at Subic Bay.

-- US and Japan pledge to provide at least USD8 million for Open Radio Access Network (RAN) field trials and the Asia Open RAN Academy based in Manila, to enable future commercial deployment and an open, interoperable, secure, reliable, and trusted information communications technology ecosystem in the Philippines.

-- Through the CHIPS and Science Act's International Technology Security and Innovation Fund, the US and the Philippines will coordinate efforts to develop and expand the Philippine semiconductor workforce to strengthen the global supply chain.

-- Expanded partnership on safe and secure civil-nuclear capacity building including trilateral cooperation on civilian nuclear workforce development to advance the Philippines' civil nuclear en-

ergy program. -- Expanded trilateral cooperation on the deployment of clean energy technologies, including renewable energy projects such as solar and wind, to support energy requirements in the Philippines and help ensure a just energy transition.

Romualdez said apart from securing these commitments of cooperation from the US and Japan, President Marcos also held meetings with leading US firms, such as the Ultra Safe Nuclear Corporation (USNC) and Google, as well as top US business leaders and officials of the Japan Chamber of Commerce and Industry. Romualdez said such engagements, held on the sidelines of the trilateral meeting, manifest President

Marcos' sustained campaign to attract more foreign investments into the country.

Philippine Ambassador to the US Jose Manuel Romualdez estimated that at least USD100 billion in investments from the US and Japan may come to the Philippines in five to 10 years as a result of the historic trilateral summit.
