LRT-1 Cavite Extension Phase 1 on track for completion by Q4 2024

The first phase of the 11.7-kilometer (km) Light Rail Transit Line 1 (LRT-1) Cavite Extension Project is nearing completion, according to the Light Rail Manila Corporation (LRMC), the private operator of LRT-1.

In a statement on Friday, the LRMC said the progress rate for the project has reached 82.7 percent as of March 2023, for both civil and rail system works since it started the construction in September 2019.

"The viaduct was completed in February 2022, while the ongoing station construction includes architectural, mechanical, electrical, plumbing, fire protection, and safe-

OPG-Extension staff also gave out free prescribed medicines and vitamin supplements to the locals.

Likewise, the Provincial Epidemiology and Surveillance Unit team rendered antigen swab testing, while the Provincial Government - Environment and Natural Resources Office staff ensured the sanitation of the venue.

shared the humble beginning of their association and their initiative to facilitate a health outreach program in order to give the residents, especially the solo parents and their families, access to the healthcare services. ty works. In terms of the rail system, trackwork, and overhead catenary system installation are almost complete," it said. The first phase covers 7 km of the 11-km extension, including five new stations: Redemptorist Station (56 percent complete), MIA Station (61 percent complete), Asia World (51 percent complete), Ninoy Aquino Station (55 percent complete), and Dr. Santos Station (60 percent complete). LRMC president and CEO Juan Alfonso said all civil and equipment installation works for the project are slated to be completed this year, with a focus on commissioning the entire project's rail line by next year.

"We are optimistic that we can start commercial operations of Phase 1 by the fourth quarter of 2024 as we continue to achieve milestones with our team," Alfon-

so said. To date, the LRMC has invested over PHP30 billion in capital improvement projects to upgrade the existing systems of the LRT-1 and for the construction of the Cavite extension since the operator took over the rail line in 2015.

The LRT-1 Cavite Extension project, a public-private partnership venture that aims to add an 11.7-kilometer Baclaran-Bacoor, Cavite segment to the current 18.1-kilometer train line, will have eight stations. The new stretch is expected to service up to 800,000 passengers per day and cut down travel time from Pasay City to Cavite from an hour and a half to just 25 to 30 minutes.

The remaining stations between Las Piñas and Niog are scheduled to become fully operational by 2027. (PNA)

DOH Calabarzon kicks off immunization drive vs measles, polio

BACOOR CITY, Cavite risk sa measles na maaring (PIA) — The Department of Health Center for Health Development - Calabarzon (DOH-CHD) has begun a ceremonial vaccination of children against measles, rubella, and polio ahead of the nationwide supplemental immunization drive next month. The 'Chikiting Ligtas sa Dagdag Bakuna Kontra Polio, Rubella, at Tigdas' campaign kicked off on April 12 in Bacoor City where 100 children received the measles-rubella vaccine and the oral polio vaccine.

The DOH targets to increase routine immunization coverage against the diseases by vaccinating at least 95% of children aged 0 to five years in the Calabarzon region.

In a statement, DOH Calabarzon Regional Director Ariel I. Valencia said it is important for children to have access to routine immunization to protect them against these diseases.

"Ang measles ang isa sa mga pinaka nakakahawang sakit na nakakaapekto sa kalusugan ng mga bata. Kaya ang mga batang walang bakuna ang itinuturing na high

magdulot ng seryosong komplikasyon na maaring mauwi pa sa kamatayan," Valencia

"Kaya naman lubhang napakahalaga ng immunization laban sa sakit na ito na siyang nagbibigay proteksyon sa kanila at maging ang pagkalat pa nito sa mga komunidad," the DOH Calabarzon chief added.

Citing the efficacy of vaccines, the DOH Calabarzon chief also urged parents to have their children immunized against measles, rubella, and polio which doubled during the first quarter of 2023. Data from the DOH Calabarzon showed that 49 cases of measles and rubella were reported in the region equivalent to 213% increase compared to the same period last year with only 23 cases.

The DOH cited that in 2021, immunization coverage worldwide dropped to 81% or one out of five children do not have access to essential vaccines through immunization services. In the same year, the Philippines was among the top 10 countries with the highest



number of "zero doses" children globally.

The World Health Organization (WHO) has worked on raising public awareness on the benefits of immunization ensuring that countries obtain the necessary guidance and technical support to implement high-quality immunization programs dedicated to making routine immunization services accessible to Filipino children.

The health department in the region said it will focus on catch-up and community-based immunization starting May 2 in partnership with various local government units, national government agencies, non-government organizations and other stakeholders. Other ceremonial vaccination will take place in various cities and towns across Calabarzon prior to the nationwide drive.

Apart from house-tohouse vaccination, the DOH Calabarzon is eyeing to set up immunization activities in rural health centers and strategic places like markets and plaza.

The DOH has also partnered with SM Malls and Walmart including the Philippine Pediatric Society-Southern Tagalog Chapter (PPS-STC) for the vaccination campaign. (PB/RBF/ MCA with reports from DOH Calabarzon)
