MPT South builds headquarters in Cavite for P800 million

Metro Pacific Tollways South Management Corp. said Friday it invested P800 million for new headquarters in Cavite province as part of its commitment to build sustainable infrastructure.

"The total cost of the hub is P800 million to serve as the headquarters, not only of CALAX [Cavite Laguna Expressway] but all of the concession of MPTC South that includes Cavitex and later CTBEx [Cavite Tagaytay Batangas Expressway]," MPTC chief finance officer and executive sponsor for sustainability Christopher Lizo said in a virtual briefing. "For 2022, we;re allocating roughly P30 million mostly for the installation

Some Maynilad customers to get P323 refund

Maynilad Water Services faces a financial penalty amounting to P63.97 million over its "unusual and prolonged" service interruptions in four cities in Metro Manila and five areas in Cavite province.

This penalty will be in the form of a bill rebate amounting to P323 per affected customer in southern Metro Manila and Cavite by April.

From December 2021 to February 2022, Maynilad implemented water service interruptions in the cities of Parañaque, Las Piñas, Muntinlupa, and Pasay, as well as Bacoor, Imus, Rosario, Noveleta, and Cavite City. This was due to repairs made at its Putatan Water Treatment Plant, as algal blooms affected water quality.

The Metropolitan Waterworks and Sewerage System Regulatory Office found that Maynilad breached its contractual responsibility of

"ensuring the availability of an uninterrupted 24-hour supply of water," depriving customers of service and placing their health and wel-

fare at risk. Maynilad earlier said it will comply with the decision. – with reports from Eirenne Lumasang/Rappler.

SSS Chief announces extension of ACOP compliance deadline to June 30, 2022

Social Security System (SSS) President and CEO Michael G. Regino announced that the compliance deadline for the Annual Confirmation of Pensioners' Program (ACOP) for the calendar year 2021 has been extended from March 31, 2022, to June 30, 2022.

The ACOP covers the following pensioner types:

• Survivor pensioners (receiving pensions through Death Benefit),

- Total disability pensioners,
- Guardians and their dependents, and
- Retirement pensioners residing abroad.

Retirement pensioners residing in the Philippines remain exempted from complying with the ACOP.

Regino said the extension aims to give those who have not yet complied with the ACOP more time to do so for them to avoid the suspension of their monthly pensions.

"Originally, we have given covered pensioners a period of six months from October 1 last year to comply with the ACOP for the calendar year 2021. But in view of the restrictions that were implemented at some point earlier this year due to the Omicron variant along with other considerations, we decided to extend the deadline for another three months or until June 30," Regino said.

"We urge those who have not yet complied with the program to submit their compliance immediately for them to not miss the new deadline. We have various methods for compliance that we developed with the utmost consideration for their safety and convenience," he added.

The guidelines and documentary requirements for the different methods of compliance such as through e-mail, mail, courier, drop box, video conference, and home visit (for total disability pensioners residing in the Philippines) can be accessed at https://bit.ly/3iwZBUE.

Covered pensioners under the ACOP who have already complied for the calendar year 2021 are no longer required to re-submit their compliance. The usual schedule of the ACOP will resume on July 1, 2022.

forming outside its offices. "We thank the ARTA led by Secretary Jeremiah B. Belgica for their commendation on the improvement of the delivery of our services. This gives us further inspiration and motivation to continuously enhance our processes and provide better services for our stakeholders," Regino said "We also appreciate their recommendations that helped us formulate immediate measures to address the surge of transacting members in our National Capital Region (NCR) branches since the declaration of Alert Level 1 in Metro Manila and other areas," he added.

Recently, SSS implemented the extension of its daily working hours in all NCR branches from March 11 to 31, 2022, to 6:00 AM to 6:00 PM from the usual 8:00 AM to 5:00 PM. Selected branches receiving high volume of transactions were also opened every Saturday this March from 8:00 AM to 5:00 PM to accept regular transactions except tellering

services. Moreover, SSS also deployed additional personnel in these branches and applied modified branch servicing guidelines to accommodate its transacting members. "We are continuously monitoring the volume of transactions that we receive in our branches, especially in the NCR and neighboring provinces, so that we can employ further measures to address them," Regino said.

"Apart from the stopgap measures we have implemented, we are also exerting efforts towards long-term solutions such as the continuous digitalization of our services. We recognize the important role of this initiative in providing easier and more convenient modes of transaction for our stakeholders, which can also eliminate the overcrowding and long queues in our branches," he added.

Currently, the SSS has 36 member and 21 employer services available online through the My.SSS Portal (www.sss.gov.ph). These cover transactions for membership, contributions, loan repayments, benefits, loans granting, disbursements, and others. Some of the services available in the said portal may also be accessed through other online channels such as the SSS Mobile App, Text-SSS, and Self-service Express Terminals. "We would like to invite our members, em-

ployers, pensioners, and the general public to familiarize themselves with our online services, accessible 24/7 at the convenience and safety of their homes or offices using their computers or smartphones. Information materials about these are available in our official social media pages and the uSSap Tayo Portal (https://crms.sss.gov.ph)," Regino concluded.

tions and digital payments was appreciated during the pandemic, following the movement restrictions imposed to address the spread of coronavirus disease 2019 (Covid-19).

Initially, people used it to buy necessities following the lockdowns but later on utilized it for convenience, he said during the launch of the 2021 Visa Consumer Payments Attitudes Study.

"And so, we anticipate this trend to continue. And consumer behavior not only will continue but will accelerate as more and more services and capabilities will bring and will make this type of transactions simpler and easier and more functional," he said. Results of Visa's annual online Consumer Payments Attitudes Study last year showed that 60 percent of the 1,000 respondents from Manila, Cebu, Cavite, Rizal, and Bulacan, carried less cash in their wallets and 84 percent tried going cashlaces.

Wolbert said respondents prefer using mobile wallets, 64 percent; card payment online, 52 percent; card payment at physical merchants, 44 percent; and quick response (QR) payments, 31 percent.

"While cash is still commonplace in the Philippines, the preference for cashless payments is clearly gaining momentum. Our study showed more Filipinos are confident to get by without cash and for longer periods of time -- with more than half feeling confident to get by for a week or longer, as cashless payment options grow," he said.

Wolbert said the rise of cashless payments in Asia is at varying levels and what is important in the Philippines, among other countries, is that the Bangko Sentral ng Pilipinas (BSP) is pushing for further rise in digital payments transactions.

He dubbed the private sector's partnership with the central bank towards digital payments as "unifying and north star for the Philippines and stakeholders".

"So, we're really focused on growing and aiming to achieve and we're really focused on driving for more electronification of payments," he said.

Wolbert said financial literacy and consumer education are important factors that will enhance people's acceptance of this payment mode even after the pandemic.

"The trend in e-commerce (electronic commerce) will continue to be sustained and face-to-face (transactions) will complement (it). We see continued opportunity for digital payments and furthering acceleration of adoption of digital payments," he added. (PNA)

"I am used to being alone in a lonely crusade against a corrupt system for the past 50 years. Nonetheless I am going all-in and all the way. Once a warrior, always a warrior," he posted on his Twitter account @iampinglacson on Sunday.

"I am used to starting a crusade, though it might be a difficult and lonely fight at first. The people would eventually see my point and join my cause. This is shown each time that my name has been put on the ballot, and the people have always renewed my mandate to serve them," he added.

As chief of the Philippine National Police from 1999 to 2001, Lacson was known to abhor kotong (bribe) and made sure all

cops follow his directives. In the Senate, he returns to the national treasury his share of the Priority Development Assistance Fund or pork barrel, which he sought to abolish as he said it becomes a source corruption.

On Thursday, Lacson announced his resignation from Partido Reporma after some of its officials decided to endorse another candidate.

The following day, he alleged that campaign expenses amounting to PHP800 million, which he could not provide, was the reason for Reporma dropping him.

"PHP800M can build 1,066 detached housing units with a floor area of 24 square meters on a 40 sqm (square meters) lot based on 2019 estimates," Lacson tweeted. On Saturday, leaders and members of Partido Reporma in Bohol province also tendered their irrevocable resignations from the party to support Lacson. The "Lacson-Sotto Support Group" in Bohol pledged their "strong and continued commitment and unequivocal support" to Lacson and running mate, Senate president Vicente Sotto III.

They include Jagna Mayor Joseph Rañola and former provincial police chief Edgardo Ingking; Joseph Sevilla (first district coordinator); Eduardo Aranay (secnd district coordinator); and Emmanuel Solomon Duites (third district coordinator).

"We believe that we need a leader like him who has a

clear vision on what he wants to do for our country and people and a clear plan based on science and hard data on how to accomplish it," the group statement read.

Earlier, members of Reporma-Cavite chapter similarly left the party to support Lacson. Party senatorial bets Minguita Padilla and Guillermo Eleazar and Reporma founder and chair emeritus Renato de Villa are also sticking with Lacson.

Lacson said de Villa, former Armed of the Philippines chief of staff, Executive Secretary, and Defense Secretary, has always been his inspiration in public service, "consistently honest and incorruptible". (With a report from Priam Nepomuceno/PNA)

up, according to the conservative estimate of police on the ground, or 100,000 according to the chief of police of General Trias. "Marami po kasi ang hindi nakapasok (Many were not able to enter)," Colonel Norman Tabaldo Rañon told Rappler.

Marcos previously held a motorcade in Cavite on February 11, which was also when Governor Juanito "Jonvic" Remulla Jr. pledged his full support for the son of the late dictator Ferdinand Marcos. The Remulla patriarch, the late long-time governor Juanito Remulla Sr., was a staunch ally of the dictator.

"I asked them to come back. Cavite has something to prove," Governor Remulla said after the rally at the General Trias Sports Complex, the same venue of Vice President Leni Robredo's rally on March 4, which was attended by an estimated 47,000 supporters.

In that rally, which helped boost the ground momentum that the Robredo camp needed, her supporters pledged that they will work hard to make sure it's not going to be a repeat of 2016, when Marcos edged her out here by 152,544 in the vice presidential race.

In response, Remulla on Tuesday promised that the 800,000 votes he earlier pledged to Marcos would not be his total votes, but in fact the margin. Is he that confident? "Yabang lang 'yun! (That's just cockiness), but we will get there," Remulla said.

Marcos has also been wooing the influential One Cebu party to his side for the votes from Cebu, the country's biggest voting population with 3.29 million voters. But Remulla declared that Cavite is more significant

"Cavite is the epicenter of politics in the Philippines. Where Cavite goes, the coun-

try goes, so it has to start here," said Remulla. President Rodrigo Duterte won in Cavite in the 2016 presidential race by a margin of more than 260,000 votes over the candidate who came in second in the province, Senator Grace Poe.

"It's not a pissing contest," said Remulla when asked if the reason he wanted Marcos to return to Cavite was because of Robredo's massive rally here.

Still, he was determined to show they topped what the Robredo campaign was able to muster, even estimating there were 40,000 other people not counted in the sports complex estimate.

But didn't his brother, Cavite 7th District Congress-

man Boying Remulla, doubt Robredo's 47,000 turnout by saying that the sports complex – the same venue of the Marcos-Duterte grand rally – could not hold that many people? How can it hold 80,000 to 100,000 now?

"He's (Boying) not the expert in crowd estimates. PNP (Philippine National Police) clearly stated the crowd was 3x the Leni-Kiko rally," said Remulla

The Marcos-Duterte rally coincided with a special non-working holiday in Cavite. Malacañang on March 8 declared March 22 a holiday in Cavite for the birth anniversary of former president Emilio Aguinaldo

At the Tuesday rally, Mar-

cos alluded to fears of election cheating – something that his camp has recently been floating. Senator Imee Marcos, chairperson of the Senate electoral reforms committee, has claimed that the tech provider for the polls, Smartmatic, has had a security breach – a claim denied both by the company and the Commission on Elections. Marcos' spokesperson Vic Rodriguez said they intend "to be vigilant in light of the growing rumors of possible poll fraud."

In General Trias, Marcos said he would send coffee to the crowd on election day so they can be alert, in reference to the 2016 count when Robredo overtook him overnight. The Supreme Court had unanimously junked Marcos' electoral protest against Robredo.

The crowd chanted: Hindi kami papayag na dayain ka! (We will not allow you to be cheated)

The crowd was also repeatedly chanting "hindi kami bayad!," that they were not paid, even though earlier that day Remulla gave crisp P1,000 bills to rally participants in Dasmariñas. Remulla said this was not an election offense because none of the national candidates were on stage yet when it happened. Two election lawyers told Rappler that the vote buying provision in the election code is clear that any person who gives money to induce someone to vote for a candidate is an election offense, regardless if the candidate was present or not.

Nonetheless, the Uniteam got what they wanted in Cavite on Tuesday. If Robredo likes to say, "Ipanalo na natin 'to (let's go and win this)," the Marcos-Duterte supporters chanted loud and clear: "Panalo ka na!" (You have won). There are 47 days left in the campaign.

Legarda to Cavite leaders: Support job creation projects

Senatorial candidate Loren Legarda urged Cavite leaders to support her programs to strengthen employment and livelihood creations in every Barangays in the province.

'LOREN sa bawat barangay' aims to strengthen the promotion and ensure better implementation of the (MSME) Law (RA 9501) and the Barangay Livelihood and Skills Training Act (RA 9509), which she both authored and sponsored during her term as Senator.

"For instance, renewable energy projects, developing agriculture, forestry, and horticulture, environmental information technology can generate jobs and provide livelihood opportunities to poor communities while making good use of recyclable waste materials, which would also help solve our waste management problem," Legarda added. Program (BKSTP), Training for Work Scholarship Program (TWSP), and Special Training for Employment Program (STEP); and DSWD Assistance to Individuals in Crisis Situation (AICS), especially LGUs affected by the Taal Volcano eruption. Legarda also assisted in improving healthcare in the province. She recently inaugurated the Ospital ng Tagaytay and allocated funds to provide equipment for Bacoor District Hospital in Cavite.

She also supported the construction and repair of roads, multipurpose buildings in the Cavite State University and other barangays in Carmona and Bacoor, and the construction of villa-type cottages in the Development Academy of the Philippines-Tagaytay.

Roque asks rice farmers to turn to cash crops to increase income

UniTeam senatorial aspirant Harry Roque is encouraging farmers grappling with high production costs, soaring fuel prices, and low farmgate prices to consider investing in cash crops to improve their earning capacity.

A cash crop and livestock farmer himself, Roque said rice and other staple farmers could also venture into cash crop farming to increase their income streams and ultimately raise their standard of living.

He said the buying price for palay (unhusked rice) has become unstable after the rice tariffication law repealed the non-tariff protective measures and the National Food Authority's role in rice importation.

The former presidential spokesman said rice farmers run the risk of impoverishment unless they diversify towards crops that offer bigger yields and faster harvest.

Based on 2018 data from the Philippine Statistics Authority, Filipino farmers posted a poverty incidence of 31.6 percent, the highest among the country's basic sector.

Roque shared that he owns a strawberry and ornamental plant farm in Benguet. His strawberry fields can yield up to 500 kilos, while his cut flowers and plant varieties can set a farmgate price of PHP15,000.

"I believe that crop diversification is the way. With the soaring farm inputs costs and petroleum prices, our farmers should not stick to just one crop," Roque said in a news release on Wednesday.

He recommended that the government provide technical assistance to farmers who may opt to plant cash crops such as coffee, spices, coconuts, tropical fruits, and ornamental plants.

Roque said, "The United States, China, and Europe have a growing demand for coconut water. Since we are the world's second-largest coconut producer, let us take advantage of this opportunity and not just stick to copra farming."


He added that the country could create a bigger name for Philippine coffee products, especially those produced in the Cordillera Region, Batangas, Cavite, and Mindanao Island, in the international market.

Meanwhile, Roque suggested that the government follow the example of other Asian countries with huge investments in capital expenditures and irrigation networks to intensify agriculture pro-

He said the Philippines could adopt the development strategies of Thailand and

try could also learn from the irrigated agricultural experience of Pakistan, which has the world's largest contiguous irrigation system.

Since agriculture remains

the lifeblood of the Philippine economy and society, Roque said the government should improve the country's irrigation network to ensure farm productivity.

As a party-list representative in the 17th Congress, Roque authored the 'Free Irrigation Services Act, or Republic Act 10969.

The law exempts farmers with landholdings of eight hectares and below from paying irrigation services fees for water derived from both national and communal irrigation systems under the National Irrigation Authority, irrigators associations, and other government agencies. (PR)
