The 32.15-kilometer, four-lane BCIB will connect Barangay Alas-asin in Mariveles, Bataan to Barangay Timalan Concepcion in Naic, Cavite, reducing travel

Bataan-Cavite Bridge to open economic opportunities

President Ferdinand R. Marcos Jr. said Friday the PHP175.6 billion Bataan-Cavite Interlink Bridge (BCIB) project is seen to boost the regional economies of the two provinces through improved connectivity.

During the bridge's milestone ceremony in Mariveles, Bataan, Marcos said new economic opportunities would open to Bataan and Cavite and their surrounding provinces because of the easier access that will be made available through the bridge project.

The President noted that the BCIB is projected to reduce the Central Luzon - Calabarzon travel time from 5 hours to just 45 minutes, cutting as much as 86 percent.

"That will be an incredible feat when it happens and would significantly help in decongesting Metro Manila as motorists will be able to travel without passing through the

Cavite commemorates 154th birth anniv of Gen. Aguinaldo

On March 22, 2023, the Provincial Government of Cavite through Provincial Tourism & Cultural Affairs Office, together with the National Historical Commission of the Philippines and the Municipality of Kawit, spearheaded the celebration of 154th birth anniversary of General Emilio Aguinaldo, the first president of the Philippine Republic.

The program started with a memorial mass of-

time from five hours to an estimated 45 minutes.

"Hopefully, we can start packages 1 and 2 this year and we could procure the other packages of this project until next year," said Teresita Bauzon, DPWH project manager, during the Saturday News Forum in Quezon City.

The entire construction may last until mid-2028, she

added. The project will be financed by loans from the Asian Development Bank (ADB) and Asian Infrastructure Investment Bank. "Right now, all the negotiations of the National Economic Development Authority and the ADB for funding of the construction are ongoing," Bauzon said. On Friday, President Ferdinand R. Marcos Jr. led the milestone ceremony

for the detailed engineering design of the project at the Maritime Academy of Asia and the Pacific in Mariveles, Bataan.

Marcos asked DPWH officials, employees, and consultants to remain committed to finishing the BCIB on schedule. "Do your best always to ensure that civil works for this bridge will commence by October this

year," he said. "Do your best also to deliver what we have proposed so that our people and their localities may live out the picture we have painted as our goal as soon as possible."

The feasibility study for the project started in March 2018, funded by the ADB Infrastructure Preparation and Innovation Facility loan. (PNA)

The job fair caravan featured booths from various companies and industries, including AQUAVIR International, Inc., Building Bet-

ter Lives Manpower Services International, Inc., Caishen Marketing Service, Inc., DLB International, Inc., Enomoto Philippines Manufacturing, Inc., Eyequest International Manpower Services, Inc., House Research & Development (HRD) Singapore Pte., Ltd., Lazurite Titanium 8 Life Insurance Agency, Inc. cade journey and success of the rehabilitation center in changing the lives of drug dependents. Secretary of the Interior and Local Government Benjamin C. Abalos Jr. graced the event as the guest of honor and speaker.

The DOH-TTRC, formerly manned by the National Bureau of Investigation (NBI) and the Philippine National Police (PNP), is the first treatment and rehabili-

tation center in the country that began in 1965. In 2005, the Department of Health took over the operations of the center by the Republic Act No. 9165 or the Comprehensive Dangerous Drugs Act of 2002,

From 20 drug dependents, the center has grown into a complex treatment and rehabilitation center that can accommodate up to 300 patients. It is maintained and

supervised by employees from different fields of expertise ranging from medical officers, psychiatrists, psychologists, and social workers.

The DOH-TTRC continues to serve with the mission to provide individualized, evidence-based, and holistic treatment and rehabilitation services to Persons Who Use Drugs (PWUDs) and their families, to sustain their long-term recovery and

to help them improve their quality of life.

PrimeWater Infrastructure Corp. joined the annual celebration of World Water Day by conducting nationwide simultaneous TalaKAYAnan and other activities, which aim to draw attention to the sustainable management of water resources.

The 32.15-km., fourlane, inter-island bridge will connect Barangay Alas-asin in Mariveles, Bataan and Barangay Timalan Concepcion in Naic, Cavite and once completed, it will be the longest bridge in the Philippines.

The BCIB will have two navigational bridges: the 400-meter North Channel Bridge and the 900-meter South Channel Bridge, which will traverse Corregidor Island. About 80 percent of the structure will be over the sea.

Primarily funded through Official Development Assistance loans from the Asian Development Bank (ADB), with co-financing from the Asian Infrastructure Investment Bank, BCIB's construction is expected to last for 60 months and is scheduled to be completed by the end of the third quarter of 2028.
