GENERAL TRIAS CITY, Cavite -- Department of Health (DOH) Secretary Francisco Duque III met Monday with the Cavite governor, mayors and legislators here to ensure preparedness and response plan on the dengue outbreak.

Duque expressed concern on the growing number of dengue cases in the country with some cities, towns, and provinces declaring "state of calamity" and immediate releases of health and calamity funds to avoid an epidemic, if not properly and immediately addressed.

Besides meeting with local chief executives and district lawmakers, the Health chief also conducted his rounds of hospital visits and checked on the health conditions of dengue patients.

Teenage pregnancy, an emergent concern in Calabarzon

The Philippines is a family-oriented country where most children live with their parents as long as they want to even after reaching their legal age and having their own family.

We also have conventional customs, although also biblical and religious, of marrying before having physical intercourse. Ultimately, even a touch of the hand during the early days was thought already as a sexual action.

But our society nowadays has been drastically changing. We are being influenced by western and other mixture of foreign cultures and now face an increasing number of early marriage and teenage pregnancy.

Commission on Population (POPCOM) IV Regional Director Angelito S. Obcena said in a radio guesting in "Yaman Kaalaman Mula sa PIA" program that one out of three teenager gets pregnant based on the data from Rural Health Units

"We were surprised that in 2013, based on the Young

Duque also urged local government units (LGUs) to establish hydration stations in all rural health units (RHUs) for those suffering from high fever to prevent dehydration, and ensure the necessary medical treatment and health services are in place in all levels of care to support communities with dengue cases.

The Cavite Provincial Epidemiology and Surveillance Unit (PESU) has recorded a total of 6,232 dengue cases from January 1 to August 5 this year, with 27 reported deaths.

It reported that this year's figure is 99 percent higher compared to the same period last year with 3,127 cases, which prompted the provincial government to declare a "state of calamity" last July 18 this year over rising cases of dengue.

The province of Cavite also called for intensified intervention measures to address the outbreak.

Dengue cases in the province have an age range of one month to 92 years old, with male patients comprising about 53 percent.

Top five cities with the most number of cases are Dasmariñas with 1,542 cases followed by General Trias with 575 cases; Bacoor -510; Imus - 507; and the town of Silang -475 cases.

"Magtulungan po tayo upang malutas natin at mapababa ang bilang ng mga nabibiktima ng dengue sa ating mga bayan at mailigtas sa tiyak na kapahamakan ang ating mga kababayan (let us collaborate to help lessen the number of dengue victims in our localities and save our constituents from imminent harm)," Duque urged local chief executives and district lawmakers.

Duque III called for collaborative efforts to totally eradicate the rampant out-

break of dengue during his visit to the province of Cavite on August 5, 2019. Secretary Duque made rounds at the Pediatric, Dengvaxia and Medical wards to personally see the conditions of patients and assess the quality of service given to them. In a discussion cum press briefing that followed, he emphasized the importance of prevention of the occurrence of dengue as he encouraged all the local chief executives to make necessary actions in order to lessen and totally eradicate dengue cases nationwide. By virtue of Provincial Board Resolution No. 1246-2019, Cavite has been declared under state of calamity due to the dengue outbreak on July 16, 2019 to expedite the release of emergency funds. During Sec. Duque's visit, 6th District Board Member and Chairperson on the Committee on Health, Nutrition and Population Kerby Salazar represented Governor Jonvic Remulla and Vice Governor Jolo Revilla. Other local government officials present were Cavite Councilor's League President Benzen Raleigh Rusit, GMA Mayor Walter Echevaria, GMA Vice Mayor Maricel Torres, Maragondon Mayor Reynaldo Rillo, Indang Mayor Perfecto Fidel, General Emilio Aguinaldo Mayor Nelia An-

geles, City of Bacoor Sangguniang Panlungsod Member Alde Pagulayan, Mayor's League President Mayor Frederick Vida of the municipality of Mendez, Ternate Mayor Lamberto Bambao and Alfonso Mayor Randy Salamat who have committed to monitor the situation in their localities and immediately respond to dengue alerts. Also, in attendance were Provincial Health Officer-in-Charge Dr. Romulo Lua, Dr. Nelson Soriano, and Dr. Aldous Angeles who explained the Cavite Provincial Emergency Response Plan for the Dengue Epidemic. Dr. Soriano tackled the actions taken to eradicate den-

gue and other vector-borne diseases in Cavite including the coordination and cooperation efforts with other government and private agencies for vector control activities on solid waste management, uninterrupted water supply, drainage management and behavioral change including health seeking behavior. DOH CALABARZON Assistant Regional Director Dr. Noel Pasion and Dr. Agnes Remulla, wife of Governor Jonvic Remulla, city/municipal health officers, medical professionals and some media practitioners also joined the activity on dengue outbreak prevention and control. --(PICAD)

ported among youth between ages 12 to 24 years old.

'We need to empower our students and give them the proper and accurate information on the basic of HIV/AIDS for them to avoid acquiring the virus," Marquez said.

'We need to train them, increase their knowledge and encourage behavior change for them to become an effective messenger among their peers for preventing HIV and other sexually transmitted infections (STIs) in the school and the community," he added. The training organized in partnership with the Department of Education (DepEd) was attended by 161 junior and senior high school students, teachers and guidance counselors from the 23 city schools.

In a statement, Dr. Marquez disclosed that the City of Bacoor has the highest cases of HIV/AIDS record-

ed in the region from 1984 to April 2019 with 726 cases followed by Dasmariñas with 686, and Imus City with 616 cases. Dr. Marquez also noted that all new confirmed cases last April come from the 15-24 age group.

Records of the HIV/ AIDS Registry of the Philippines (HARP) showed that a total of 9,926 HIV/

AIDS cases were recorded in Calabarzon (Cavite, Laguna, Batangas, Rizal, and Quezon) from 1984 to April 2019. The HIV/AIDS Registry of the Philippines (HARP), recorded a total of 9,926 HIV/AIDS cases in the region from 1984 to April 2019. Cavite recorded the highest number of cases with 3,555; Rizal with 2,667;

Laguna with 2,032; Batangas with 1,141; and Ouezon with 531 cases

The increasing number of HIV/AIDS infection in the country, according to DOH Region IV-A, prompted Health Secretary Francisco T. Duque III, to ensure the implementation of Republic Act 11166, otherwise known as the Philippine HIV and AIDS Policy Act.

It said that the law aims to effectively address the growing HIV epidemic in the country by forging stronger alliance among government, private sector, civil society faith-based organizations, organizations, media, and all stakeholders. (FSC with reports from DOH Region IV-A)

Adult Fertility and Sexuality Study (YAFS), many of our youth conceived too early. They should have been attending school to study but most of them are getting pregnant," he explained.

This is a very alarming fact that pushed POPCOM to launch their Adolescent Health and Development Program (AHDP).

AHDP is one of the key component programs of the Philippine Population Management Program (PPMP) with the overall goal to contribute to the improvement and promotion of the total well-being of young Filipinos ages 10-14, 15-9 and 20-24 through their sexual and reproductive This, specifically, health. aims to help reduce incidence of teenage pregnancy, sexually transmitted infection (STI) and HIV/AIDS among the youth in line with the thrust of the International Conference on Population and Development (ICPD) Program of Action (PoA). Fortunately, the regional director said that based on the report last year, the rate of teenage pregnancies from 2016 to 2018 has been declining. "We are grateful that the rate is decreasing because it means that people's awareness is increasing," he stated.

Teenage pregnancy has a big impact on the society and it affects not only the girls but even the boys. It is believed that once a girl gets pregnant, she is most likely forced to discontinue her studies. While, most of the boys who already take the responsibility to father their kid also have no choice but to stop studying and start working. Teenage pregnancy also has an effect on the econ-

omy as Obcena pointed out "According to the United Nations Population Fund or

UNFPA, if teenage pregnancies shall continue our Gross Domestic Products (GDP) may lose 33 billion or almost 1% of our GDP." Looking at it the other way around, if teens do not get pregnant early they shall contribute 33 billion in the country's Gross Domestic Product, hence, the impact of this societal issue is absolutely huge. For the last three years, he disclosed, Laguna is number one among the provinces in the region in terms of teenage pregnancy with 20,000 cases based on the latest report. It was followed by Cavite, Batangas, Quezon, while the province with the least number of teenage pregnancies is Rizal. Among the localities, Tanza in Cavite is number one in Calabarzon. Binan City, Calamba City and San Pablo City were the top three in Laguna. POPCOM IV has been monitoring 28 out of the 142 municipalities and cities in the region. These 28 identified vulnerable localities are those with the greatest number of teen pregnancy cases from Laguna, Cavite, and Batangas. Consequences of teenage pregnancy in a nutshell includes high-risk pregnancy. discontinuation of studies, repeated pregnancy especially those who enter into early marriage, giving birth to low birth weight babies eventually resulting in malnutrition, vulnerability to domestic violence, abortion, and tendency to commit suicide, among many others.

Brief story of a Teen Mom

Hacel Cunanan, 31-year old housewife, became a teenage mother and wife at the age of 17. She was then a graduating fourth year student when she conceived. Afraid of being judged and ashamed on her graduation march with a baby bump, she attempted to undergo an abortion.

Her mom and the mother of her husband, who was then her boyfriend, stopped her from pushing through with abortion. She then awakened with the realization that the fetus inside her was breathing and has the right to live. "Ang maipapayo ko sa mga kabataan ngayon na hindi pa handa sa realidad ng buhay, magaral kayong mabuti. Sundin ang mga magulang niyo kasi walang magulang ang magdadala sa inyo sa kasamaan kaya enjoyin niyo lang ang pagiging teenager niyo," she advised. (I advise the young people of this generation who are not yet ready to face life's reality to focus on their studies. You should obey your parents because all they want is what is good for you and just enjoy your teenage years.)

She is now a mom of two beautiful children while pregnant with her third while her first born, who she once attempted to abort, is now a topnotcher in her class

She might had been through a dark time in her life as a teenager, but with the guidance of her parents, right choices she made to correct the mistakes she committed, face its consequences and ask for God's forgiveness, she has now conquered her struggles and presently have a better life with her loving family.

Advice to teens

RD Obcena said the right time to get married does not come with age. But one must already have the right mind based on one's readiness and maturity. "Meaning kung may trabaho ka, tapos you're in the right mind na, iyong ready ka na mag-asawa at responsable ka na na mag-pamilya." (This means you have a stable job and you have the right mind or mature enough, that is, you are ready to get married and be responsible to have a family of your own.)

Each of us has his and her own phase of maturity. Thus, there is really no specific age for getting married. One of the factors why teenage pregnancy rate is high in the Calabarzon is because of the level of involvement of the parents. "It is very important! You have to monitor your children," he said expressing that parents in general have a vital role to play in preventing and addressing teenage pregnancy. The regional director said he believes that the solution to it is the parents themselves, or simply effective parenting.

Local initiatives for teen pregnancy prevention

The Provincial Government of Laguna crafted its own way to contribute to the solution to the social problem on teenage pregnancy and other issues concerning the youth.

Through the Youth De-

elopment Affairs Office (YDAO), the provincial government recently led a seminar titled "Love Revolution" tackling HIV/AIDS, Smoking Cessation, Anti-Drugs Abuse, Teenage Love and Teen Pregnancy. They have reached out to 600 students from Sta. Catalina Integrated National High School in the town of Majayjay, which is a big step towards encouraging the youth to do the right thing and make the right choices for their future. Seems cliché but it is always true that the youth is the hope of our nation, hence, it is alarming to know that the rate of teenage pregnancy in the region is high. Teenage pregnancy is a contributing factor that may paralyze or impede the country's development. Hence, the roles of the parents, institutions like school, and the government are all critical to hone the mind, values and morality of our young gener-

Cavite LGUs intensify road clearing ops

towns have intensified their
road clearing operations and
ridding the local sidewalks
of illegal vendors.

Department of the Interior and Local Government (DILG) Secretary Eduardo Año earlier issued a memorandum ordering department officials to monitor the progress on compliance by the local government units (LGUs) with the directive of President Rodrigo Duterte to clean up public roads of obstructions to ease traffic congestion.

In Bacoor City, Mayor

Lani Mercado-Revilla implemented clearing and maintenance operations along the stretch of Zapote Road and public roads in the Bacoor Public Market.

Revilla directed the city's 73 village chiefs to clear public streets, especially major thoroughfares used for private ends, and the remove obstructions and illegal structures along Aguinaldo highway and Molino Boulevard in the city of over 600,000 people.

The mayor also instructed both the City Engineering Office and Bacoor Traffic Management Team to assist the barangays in their clear-

ing operations.

In Kawit town, Mayor Emilio Angelo Aguinaldo has warned the 23 village chiefs to comply with the President's and DILG directives or face raps.

Among the areas the mayor wanted to give priority in the clearing operations are the major roads at Barangay Binakayan especially streets enclosing the Public Market, Zeus area in Muralas, the stretch of Centennial road from Barangay Gahak to Barangay Magdalo, Kalayaan Road in Barangay San Sebastian, and Tirona Highway to Magdiwang Highway at the town proper.

General Trias City Mayor Antonio Ferrer ordered the formation of the team composed of city traffic management chief Noel Morena, local police chief, Lt. Col. Marlo Solero, Liga ng mga Barangay (LnB) Federation president Alfred Ching, Licensing office head Romel Olimpo, and Francisco Evangelista Jr. as head of the GenTri Civil Security Unit to supervise the clearing operations.

The team members are tasked to inspect and supervise the cleanup drive, especially along the stretch of Antero Soriano Highway from Bacao to Tejero; Tejero Crossing, Tejero-San Juan Road, Malabon Trias proper; Gen. Antonio Road from Bacao to Dulong Bayan to Brgy. 96th.

Busy roads like Governor Ferrer Drive from Barangay Prinza to Manggahan, Crisanto delos Reyes Avenue from Manggahan to Alingaro, Governor's Drive from San Francisco to Manggahan, up to the boundary at Trece Martires City, are up for clearing operations.

In Dasmariñas City, Mayor Jenny Austria Barzaga ordered the city government to implement "no parking" on busy public streets from 6 a.m. to 8 p.m.

The mayor's order is covered through the city government Memorandum No. 240-S-2019, which declares the "no parking" zone on Molino-Salawag-Paliparan road anytime and the Placido Campos and Camerino avenues.

In her directive to the city's 75 village chiefs, Barzaga also ordered the clearing operations on all major and secondary public roads in the city. (PNA)

HEALTH SECRETARY DUQUE MEETS WITH MAYORS OF CAVITE PROVINCE FOR DENGUE

Department of Health (DOH) Secretary Francisco T. to prevent them from dehydration. Duque, III today conducted a meeting with various mayors of Cavite province to ensure that preparedness and outbreak response against dengue are in place in all levels of care to support communities with dengue cases held at the Cavite Collaboration Center for Public Health located at General Trias. Cavite.

"Dapat lahat ng ating mga lokal na pamahalaan ay handa na makapagbigay ng suporta sa mga biktima ng dengue lalo na ngayong patuloy na tunataas ang mga kaso dito sa Cavite kailangan natin ng dobleng pag-iingat," he stated in his mes-

"Magtulungan po tayo upang malutas natin at mapababa ang bilang ng mga nabibiktima ng dengue sa ating mga bayan at mailigtas sa tiyak na kapahamakan ang ating mga kababayan,"he urged local chief executives.

Duque also encouraged LGUs to establish hydration station in all rural health units for those suffering for high fever

According to the Provincial Epidemiology and Surveillance Unit (PESU), there were a total of 6,232 dengue cases recorded from January 1, 2019 to August 5, 2019 with 27 deaths. This year's figure is 99% higher compared to the same period last year with 3,127 cases.

Ages of cases ranged from 1 month to 92 years old with males having the majority of cases at 53%.

Among the top five municipality/city with the most number of cases is Dasmarinas with 1,542 cases followed by General Trias with 575 cases; Bacoor with 510 cases; Imus -507; and Silang - 475.

Duque also made his rounds at the dengue wards of the General Emilio T. Aguinaldo Memorial Hospital to check on the health status of patients.

On July 18, 2019, the provincial government of Cavite declared a state of calamaity on the province due to the rising cases of dengue cases.

RESPONDING TO THE MEDICAL NEEDS OF TRECEÑOS



A total of 399 residents in Barangay Inocencio in Trece Martires City received free consultations and tooth extraction during the conduct of PGC's medical and dental mission on August 2, 2019. Volunteer doctors, dentists and other medical professionals from General Emilio Aguinaldo Memorial Hospital examined every patient to know their health problems and prescribed the corresponding medicines. Treceños were also given the opportunity to avail other services including random blood sugar testing by Multilab Diagnostic and Health Services, checking of weight and blood pressure, and family planning counselling conducted by employees from the Provincial Population Office. Barangay Captain Rosendo Dilidili, barangay health workers and other volunteers from the local and provincial government assisted in the event making it more organized and successful. The event was made possible through the effort of TMC Mayor Gemma Lubigan, Vice Mayor Bobby Montehermoso and the members of the city and barangay councils.
