TRECE MARTIRES CITY, Cavite -- As Cavite province is placed under a state of calamity due to the increase of dengue cases in 16 towns and seven cities, a provincial lawmaker on Wednesday appealed to Cavite constituents to conduct cleanups and fumigations in mosquito breeding sites.

ang Panlalawigan's (Provincial Board) committee on health, nutrition and population, Cavite 6th District carry out the Department of Board Member Kerby Salazar underscored the need to close ranks to address the dengue outbreak in the province.

"I'm appealing to my fellow Caviteños to participate in the massive cleanup drive and fumigation to ensure the cleanliness of their respective localities," Sala-

Chair of the Sangguni- zar said. He noted that they have tapped the Liga ng mga Barangay (village league) to help mobilize village folks to Health's 4S strategy against dengue -- search and destroy mosquito breeding sites, secure self-protection, seek early consultation, and support misting/spraying to address the outbreak.



Cops arrest 2 for illegal possession of firearms in

GENERAL TRIAS CITY, Cavite - Police arrested two persons for illegal possession of firearms during the implementation of the search warrant, in line with the Simultaneous Anti-Criminality Law Enforcement Operation on Thursday night.

Police Col. Paul Bometivo, the acting city police chief, identified the apprehended suspects as Jaime Tuando Petilos, 50, of Tropical Village Pabahay, Barangay San Francisco; and Jaime Presa Laurencio, 46, of St. Francis Subdivision, Barangay San Juan 1, in this city.

"We are continuing our operations against lawless elements especially on our fight against loose firearms which could be used for other forms of criminality here in GenTri City," Bometivo said in an interview. He said the two suspects are now detained at the police detention facility as charges are filed against them for violation of Republic Act 10591 or the "Comprehensive Firearms and Ammunition Regulation Act".

The raiding team seized from Petilos a cal. 45 Rock Island Armory, a cal. 45 Armscor, 23 cal. 45 live ammunition, a Rock Island Armory Shotgun, a Karatay shotgun, eight live shotgun shells, and a Plainfield machine M1-carbine, and eight cal. 30 live ammunition.

The police operatives recovered from Laurencio a cal .380 Bersa Thunder, and 12 live ammunitions for cal.380. (PNA)

Cavite town boosts clean-up ops, fumigation vs. dengue

MAGALLANES, Cavite -- Alarmed by reports about the surge of dengue cases in some areas, the local government here embarked on a massive clean-up in possible dengue-carrying mosquito breeding sites and fumigation over the weekend.

Mayor Jasmin Maligaya-Bautista has ordered the Rural Health Unit (RHU), through its Municipal Health Officer Dr. Jose Jemmel Bacolod, to address the situation in view of eight dengue cases that were reported.

"I am calling on all our constituents to be on alert due to the rising dengue cases in our locality. Let us clean our surrounding especially in possible breeding sites of dengue carrier mosquitos, and avoid mosquito bites)," she said in Filipino during the flag-raising ceremony Monday.

Bautista also directed the village chiefs of the 16 barangays, especially in Barangay Ramirez where the eight dengue cases were recorded, to coordinate with the municipal health office on ways to contain the sit-

Meanwhile, Bacolod also embarked on a massive information and education drive in the barangays for



residents to be aware of the dengue symptoms.

The municipal health office also advised residents to never ignore symptoms like sudden high fever, severe headaches, pain behind the eyes, severe joint and muscle pain, fatigue, vomiting, and skin rashes which appear two to five days after the onset

"If you experience these symptoms, kindly go to the nearest hospital for proper medical treatment," Bacolod said.

He said residents should be more careful because these are known to increase during the rainy season when stagnant water becomes the breeding sites for the dengue-carrying mosquitoes.

Bacolod said dengue could be fatal when unattended, as mosquito bites could transmit the infection, which triggers a severe flu-like illness often followed by a severe drop in a patient's blood platelet count.



SSS: 2.5M pensyonado nakatanggap ng P62B pensyon mula Enero hanggang Mayo 2019

Mahigit P62.19 bilyong pensyon ang naibayad ng Social Security System (SSS) sa unang limang buwan ng taon. Ito ay mas mataas ng P4.84 bilyon kumpara noong nakaraang taon.

Ayon kay SSS President and Chief Executive Officer Aurora C. Ignacio, tumaas ang naibigay na pensyon dahil tumaas din ang bilang ng mga pensyonado mula 2.4 milyon noong Mayo 2018 ito ay naging 2.5 milyon ngayong Mayo 2019.

"Natutuwa kaming makita na napakikinabangan ng aming mga pensyonado ang kanilang buwanang pensyon matapos ang maraming taon ng kanilang pag-iimpok sa SSS. Natatamasa na nila ngayon ang bunga ng kanilang mga pagsisikap noong sila ay nagtatrabaho pa," sabi ni Ignacio.

Mayroon tatlong uri ng pensyon na ibinibigay ng SSS. Ito ay ang pensyon para sa pagreretiro, pensyon para sa pagkamatay, at pensyon para sa pagkabalda.
