GenTri CENRO, Beta Sigma Cavite conserve environment thru nature-based solutions

Recently, through the initiative of Dr. Escurel, the Beta Sigma Fraternity Cavite Assembly Agroforestry held a greening project in Magallanes, Cavite.

True to its form of giving back to the community, the Beta Sigma Fraternity continues to involve their group in private and foreign environmental movements. The brotherhood planted tree for the project "Alay ng Kapatiran sa Inang Kalikasan", as part of their greening program on a nationwide capacity. Historically, the Cavite Assembly has been planting trees in different areas in Cavite for more than a decade already. The group collaborates with the LGUs of the province. Significantly, the Fraternity launched a massive tree -planting and nurturing program on its 75th Diamond Jubilee celebra-

Their effort to help the environment survive and sustain condition was heeded by the government and other stake-

The Department of Environment and Natural Resources forged a long-term MOA and planting tree is just an initial effort to sustain the advocacy.

"The program is based on the internationally recognized approach called Nature Based Solutions that will address climate change thru the conservation of biodiversity, watershed protection, sustainable agriculture and community involvement," said Jose Andres Diaz, Beta Sigma officer.

Andres Diaz is the former Regional Executive Director, Assistant Director of the Protected Area and Wildlife Bureau (now Biodiversity Management Bureau-BMB) and Director of the Palawan Crocodile farming Institute of the DENR and a pioneer in the Philippine Native Plants Conservation Society, Inc. (PNPCSI). He is tasked to lead the Cavite assembly agro forestry project located in Mt. Ipus, Bgy. San Agustin, Magallanes. The team is comprised of dedicated advocates, Dr. Lito Barron former director of the Bureau of Plant Industry, brod Levy Perez a UPLB agriculture veteran who retired from USDA and now a successful Cavite farmer, Dr. Rene Escurel, brod Bobot Periodico another farmer from Magallanes, sis Sheryl Esguerra, who is both an enthusiastic environmentalist

Beta Sigma Fraternity Cavite Assembly Agro forestry entered into a MOA on June 2021. DENR, PENRO Cavite provided an initial symbolic 7.5 hectares area to be developed into a National Greening Program agro forestry site in 5 years, and a provision to expand within 5 years to its total area of 200 hectares.

Executive Director Butch Madarang of the Philippine Bamboo Industry Development Council during the activity also suggested the promotion of bamboo to be included as an integral part of the project.

"As the 'poor man's lumber,' bamboo has grown to be a 'green gold' resource because of its increasing value in global economy and its sustainability as among the fastest-growing and versatile forest products in the country," Madarang said.

In their recent activity, the Fraternity plans to change the expanded area into different tenurial instrument called the Socialized Industrial Forest Management Agreement. The agreement is between the DENR and the Cavite Assembly

which has tenure of 25 years renewable for another 25 years. The SIFMA also allows investment in commercial production such as tree plantation, agricultural and fruit trees, agro-ecotourism and even livestock production to ensure economic sustainability of the venture.

Presently, various crops are planted like a mix of bananas, different fruit trees, bamboos and agar wood covering approximately 4 hectares. To spread the advocacy, the group collaborates on their greening efforts with various NGOs and the Project Luntian Cavite, led by Prof. Julio Castillo, Jr. is one of them. The Cavite Medical Society led by its president Dr. Glen Cajida is actively participating, too. Consistently, the GEN-TRIMED hospital led by its president Dr. Jerry Genuino, the South East Asian Medical Center led by its medical director Dr. AnnaLou Diaz, the Magallanes LGU, and the Cavite PEN-RO are one in the advocacy of the BETA SIGMA Fraternity.

There is no stopping the Beta Sigma Fraternity Cavite Assembly Agro forestry in their efforts to help save the planet and part of their future plans are projects that will enjoin efforts with the Ecosystem Research and Development Bureau

Meanwhile, in Bacoor City, a compound in Barangay Molino II was locked down, where authorized persons outside residence (APOR) will also not be identified.

According to the local government's executive order (EO), the Zaragosa compound was locked down from August 9 to 22 after 5 confirmed cases of COVID-19 were recorded and 2 others tested positive in the antigen test.

Confirmed cases have

been transferred to the isolation facility. About 200 individuals were affected by the lockdown who will be given relief goods.

The city hall strongly ordered that even APORs not leave the house in the Zaragosa compound, and only barangay personnel will take or buy the needs of the residents. "No one, not even APOR, in the whole Zaragosa compound maybe allowed to go out of the house," EO said. The EO stressed that those who violate the lockdown would be punished accordingly.

Cavite governor defends Yorme

Cavite Gov. Juanito Victor "Jonvic Remulla," who had a spat with Manila City Mayor Francisco "Isko Moreno" Domagoso in connection with the distribution of aid for Manila relocatees in April, on Wednesday defended the former actor from criticisms.

In a Facebook post, Remulla said public servants should be judged by their performance, not by what they did in the past.

"Ang paghatol sa kalaban sa pulitika ay dapat tungkol sa kanyang kakayanan bilang Serbisyo Publiko at hindi paninira lamang base sa kanyang nakaraan o noong siya ay bata pa (Criticisms against political rivals should be about their skills as a public servant, not what they did in the past, when they were young)," Remulla said.

He said photos of the mayor circulating online were taken when he was an actor.

"Yorme (Domagoso) did not do those provocative poses while in office as a respected councilor, vice mayor or as the current Manila mayor," the governor pointed out. "Yorme did not break any laws by joining showbiz in his youth nor by posing sexy in photos," he said.

"He was very young then. I am sure the limelight was quite tempting for a young lad from a very poor background. And why not? The opportunity for him to earn a living was readily available," Remulla said.

"To not take advantage of such privilege would have been foolish," he added.

He said that for him, Domagoso's background is not an issue

"What's important is that Yorme never lied, did not steal, kill nor did he ever [bring] shame to the great people of Manila as a Public Servant," he wrote.

"Let [Domagoso's] record of governance speak for itself," he concluded.

2 Cavite towns shut down municipal halls amid COVID-19 outbreak

At least two municipal halls in Cavite were temporarily closed down this week amid the surge in COVID-19 cases in the province.

The municipal hall in Naic will be closed from Tuesday, August 10, until Friday, August 13, to give way for disinfection after four staff members of the General Services Office tested positive for COVID-19.

Naic Mayor Junio Dualan also suspended vaccinations scheduled at the Amisa Medical Mission Hospital in Barangay Cabuco from Tuesday to Friday after one doctor and three nurses tested positive.

"We are very concerned that in just past five days, our number of active cases has doubled. As of now, we have 166 active cases," Dualan said. As of Tuesday, Naic reported 1,238 confirmed COVID-19 cases, with 45 deaths and 1,027 recov-

The GSO as well as other local offices such as the Rural Health Unit, the Municipal Disaster and Risk Reduction and Management Office, and the Office of the Mayor are operating on a skeletal workforce.

Maragondon Mayor Rey Rillo also ordered the temporary closure of the municipal hall in Barangay Poblacion from August 11 to 15 for disinfection. Office work will resume on Monday, August 16.

In the municipality of Tanza, the local government suspended its vaccination program after 18 medical staff tested positive for COVID-19.

The 18 staff members are all vaccinated and asymptomatic, according to Tanza Municipal Administrator Tutuy Sanariz. Contact tracing is now ongoing in the municipality.

"The vaccination here in Tanza is temporarily suspended, but we will resume on Thursday, August 12, [at] all our sites," Sanariz said.

He said Tanza's 120-bed capacity isolation facilities are almost full, while the Tanza Specialists Medical Center in Barangay Daang Amaya has already reached full capacity.

Meanwhile, Noveleta Mayor Dino Chua has ordered municipal hall workers to work from home from August 6 to 15 while Cavite is under modified enhanced community quarantine. As of Monday, August 9, Cavite has 64,718 confirmed COVID-19 cases, with 6,654 active cases, 1,690 deaths, and 56,374 recoveries. – Rappler.com

LRT-1 Cavite Extension 60% finished

THE Cavite extension tion of the electrical system project of the Light Rail Transit Line 1 (LRT-1) is now 60% complete, its private operator Light Rail Manila Corp. (LRMC) said.

"The current progress for the Cavite extension is that it has reached about 60% completion," LRMC President and Chief Executive Officer Juan F. Alfonso said at a recent press briefing of the Metro Pacific Investments 18.1-kilometer train line. The Corp. (MPIC).

"The viaduct construction is now crossing from the Parañaque River, crossing Cavitex (Manila-Cavite Expressway) and going to Roxas Boulevard," he added.

LRMC is scheduled to complete the viaduct by the end of the year.

"Afterwards, we will start with the electromechanical works — the laying of the rails and the installaas well as the stations," Mr. Alfonso said.

The P64.9-billion LRT-1 Cavite extension project, a public-private partnership (PPP) venture that the National Economic and Development Authority board approved in November 2013, aims to add an 11.7-kilometer Baclaran-Bacoor, Cavite segment to the current new stretch will have eight stations.

The first phase of the extension consists of a seven-kilometer stretch with five stations between the Redemptorist Church area in Baclaran and Dr. Santos Ave. in Parañaque.

The Baclaran-Dr. Santos segment is expected to start partial operations in the first quarter of 2024, the Transportation department said. The government plans to conduct trial runs in March

The Cavite extension is expected to be fully operational by the second quarter

Once completed, the Transportation department expects daily ridership along the entire line to increase to 800,000 passengers from 500,000, and Baclaran-Bacoor travel time to be cut to 25 minutes from up to two

LRMC is the joint venture of Ayala Corp., Metro Pacific Light Rail Corp. and Macquarie Infrastructure Holdings (Philippines) Pte. Ltd. It holds the P65-billion, 32-year PPP contract to operate LRT-1 and build its extension to Cavite.

MPIC is one of three Philippine subsidiaries of Hong Kong's First Pacific Co. Ltd., the others being PLDT, Inc. and Philex Mining Corp. Hastings Holdings, Inc., a unit of PLDT Beneficial Trust Fund subsidiary MediaQuest Holdings, Inc., maintains an interest in BusinessWorld through the Philippine Star Group, which it controls. — Arjay L. Balinbin
