Mayor Isko to gov't: Focus on COVID-19 for now, not constitutional reforms

Manila City Mayor Isko Moreno on Friday urged concerned government officials to prioritize combating the COVID-19 pandemic instead of making constitutional reforms.

In a television interview, Moreno said although he supports development in the present Constitution, the focus for now should be the prevention of the spread of the disease.

"I agree in any given development at any given time in a normal situation. That's why we elect congressmen and senators to change laws. In this case, if it can help later on, why not? Pero for now, please... let's just focus muna kay COVID-19," Moreno told ANC.

The League of Municipalities of the Philippines (LMP) has submitted a



resolution to the Department of the Interior and Local Government which stresses two constitutional amendments that they support — institutionalize the Mandanas Ruling of the Supreme Court in the Constitution and the lifting of restrictions on foreign investment in industries

that are presently limited to Filipinos.

The LMP said these would help them attain economic and social progress in their respective lo-

DILG spokesman Undersecretary Jonathan Malaya has said the resolution will be forwarded to Speaker Alan Peter Cayetano and House Committee on Constitutional Amendments chair Rufus Rodriguez.

Cavite Governor Jonvic Remulla has earlier questioned the timing of such moves to amend the 1987 Constitution given the current health crisis. — KBK, GMA News



Flu vaccine a must amid pandemic-health experts

Health experts are encouraging the public to get vaccinated against the flu amid the continued spread of the coronavirus disease (COVID-19) in the country.



Dr. Arthur Roman, an official of the Philippine Society for Microbiology and Infectious Diseases (PSMID) during a media forum on Thursday, July 23, said, flu vaccination matters even more during this time, noting it will prevent the development of signs and symptoms similar to COVID-19.

"When you get the flu vaccine, you don't get the flu and you don't develop signs and symptoms na maaring maipagkamali mo na COVID-19 (which can be mistaken for COVID-19)," he said. "So yung risk of you developing unnecessary anxiety kasi baka isipin mo may COVID-19 ka, nawawala iyon kasi you get the flu vaccine and the risk of you getting these signs and symptoms ay bumababa rin (So the risk of you developing unnecessary anxiety because you might think you have COVID-19—it disappearsbecause you get the flu vaccine and the risk of you getting these signs and symptoms also decreases)," he added. To note, some of the signs and symptoms of COVID-19 similar to flu include fever, cough, body aches, fatigue, and sore throat.

The public should not only be proactive in fighting COVID-19 "but also other infectious diseases that continuously affect the lives of many Filipinos," said Philippine Foundation for Vaccination (PFV) President Dr. Liza Gonzales.

"Although the flu vaccine cannot prevent COVID-19, it can still help protect even the most vulnerable among us against complications from the disease, making it a beneficial option we can take advantage of to keep ourselves healthy," she said. Roman underscored that a person should prevent influenza infection as it can weaken one's immune system, thus making an individual "suscepti-

ble' to COVID-19. "When you develop any type of infection such as influenza virus infection bumababa rin ang immune system. And when your immune system is low, then opportunistic infection....kagaya ng COVID-19 ay maaari kang atakihin (When you develop any type of infection such as influenza virus infection — the immune system becomes low. And when your immune system is low, then opportunistic infection like COVID-19 can attack you)," he said. "When you have COVID-19 infection and you also develop the influenza infection, this combination can actually lead to very serious complications," he added. Roman added it can also help keep hospitals from becoming overwhelmed.

"Alam naman natin na yung mga hospital—they are already catering to a lot of COVID-19 cases. The tendency for us to consult doctors ay mas bumababa. Kumbaga hindi na tayo makiki-agaw sa mga health services na prinoprovide ng hospital ngayon (We know that hospitals are already catering to a lot of COVID-19 cases. The tendency for us to consult doctors will be less. It is as if we will not add to the burden in the health services being provided by the hospitals at present)," he said.

Roman encouraged medical professionals to ensure their patients will get immunized against flu.

Among his recommendations in order for the medical professionals to administer the anti-flu shot include setting home visits by appointment, setting a date for vaccination, or conducting drive thru-like arrangement of giving the vaccine outside hospitals. "We have to make innovations because having the pandemic doesn't mean we have to stop giving our other necessary services, such as immunization," he said. "Vaccination in general is one way for you to keep

yourself healthy because it is a form of prevention. Staying healthy at this time is your best shot against preventing COVID-19 infection," he emphasized.

Cavite Gov Remulla suspends mall's operations for quarantine violations

CAVITE Jonvic Remulla ordered on Friday to suspend the operations of a popular mall "until further notice" for violating the province's quarantine pass policy.

In a statement posted on his official Facebook page, Remulla said he received a video showing the SM City Trece Martires violating the provincial government's quarantine pass policy.

Remulla said police had an undercover operation in Cavite malls last July 22, 2020 to find out if they were complying with the province's regulations to fight the spread of the coronavirus disease 2019 (Covid-19).

"Guidelines are meant to put order into controlling the pandemic situation. For those who think that the worst is over, you are mistaken," said Remulla.

"Collective responsibility means if we arrest the small people in the streets for face mask violation or public intoxication, then we should also close down the



Q-Pass Policy set by the LGU (local government unit). The rule applies to everyone," he

Cavite, the most populous province in the Calabarzon region, has recorded over 1,000 cases of Covid-19, up from 200 cases before its big malls if they violate the general community quarantine (GCQ) started in mid-May, said Remulla.

In line with the relaxation of quarantine measures in the country, the Cavite provincial government implemented the modified Q-Pass System policy last June 7 where quarantine passes were now transferable to other qualified, of legal-age members of the household.

Last May, Remulla ordered all the malls in the province closed after it reopened for failing to ensure physical distancing two days after the province was placed under GCQ.
