Cavite Mayors back localized granular lockdowns

SOME Cavite mayors have adopted localized and granular lockdowns along with targeted testing to contain coronavirus infection rates in local clusters, according to Presidential Adviser for Entrepreneurship and Go

Negosyo founder Jose Maria “Joey” Concepcion 3rd.

“Bringing innovation into testing is very important for us because this is the only weapon we have to create visibility. By creating visibility, then we know what areas

or barangay (village) to lockdown and that’s very important. I believe our mayors are the most capable people in determining where to lockdown,” he said.

Concepcion joined mayors Lani Mercado-Revilla, Antonio Ferrer and Emmanuel Maliksi, and representatives of other cities during a briefing on Wednesday.

The official stressed the importance of balancing public health and the economy.

“What is important is we have to save both. It is not a choice of either/or, but it is saving lives, jobs, and livelihoods. Saving all three to the

best we can. My focus is on a granular lockdown and avoid [broad] locking down which disrupts the economy much more. Massive targeted testing plus a granular approach is the best way forward,” he said.

Mercado-Revilla, mayor of Bacoor City, agreed on the use of rapid test kit and reverse transcription polymerase chain reaction (RT-PCR) to curb transmission.

“We will continue to use both just to monitor and help us isolate, treat, and do minimum lockdowns,” she said. Project ARK (antibody

NCR, Bulacan, Cavite, Laguna, Rizal back to GCQ, says Duterte

President Rodrigo Duterte has returned Metro Manila and nearby provinces to a general community quarantine as proposed by the Inter-Agency Task Force on Emerging Infectious Diseases.

In a televised briefing from Davao, Duterte said the following areas will be under GCQ:

Metro Manila, Bulacan, Cavite, Laguna, Rizal, Nueva Ecija, Batangas, Quezon, Iloilo City, Cebu City, Lapu-Lapu City, Mandaue City, Talisay City in Cebu, and the municipalities of Minglanilla and Consolacion.

The rest of the country will be under modified GCQ. "Just be careful. Follow the safeguards," Duterte reminded the public.

The new directive will be in effect starting Wednesday, August 19, and will last until Monday, August 31.

GCQ guidelines

Presidential spokesman Harry Roque said restrictions under GCQ were more relaxed compared to the modified enhanced community quarantine Metro Manila was under for two weeks.

"Mas marami pong industriyang bukas. Pupuwede po ang dine-in sa mga restaurant, pupuwede po na magkaroon ng religious services pero hanggang 30% lang po," Roque said.

"Halos lahat po ng industriya ay magbubukas bukod na lang po doon sa maraming natitipon-tipon, 'yung mga entertainment, at 'yung mga amusement para po sa bata," he added.

Under GCQ, more establishments will be allowed to open at varying levels of capacity.

The Labor and Trade Departments have also released guidelines for infection prevention in workplaces in GCQ areas.

Travel guidelines for areas under GCQ also limit movement to essential purposes only.

'Refreshed' COVID-19 response

Roque said the government used the two-week modified enhanced community quarantine to "refresh" the country's pandemic response.

He said that the government would improve testing, tracing, and isolation capabilities as well as continue the active case finding initiative of the Department of Health.

Roque added that 250 beds exclusively for COVID-19 patients were inaugurated at the East Avenue Medical Center earlier on Monday, while the seamless hospital referral system has also been operational.

Experts from the University of the Philippines earlier urged the government to extend the MECQ for 15 more days to prevent an "uncontrolled" spike in infections.

The Philippines has logged 164,474 COVID-19 cases as of Monday afternoon, still the highest across Southeast Asia. —Julia Mari Ornedo/NB/KG, GMA News

rapid test kit) Medical Team Lead Mingueta Padilla emphasized the importance of quality, high-specificity rapid test kits (RTKs). She said that RTKs can help companies stay open.

"Like any weapon, the key is to use it properly," she said. "At the beginning, there was nothing so we used RTKs but [they should be used] always in strategic combination with RT-PCR when necessary and always following DoH (Department of Health) guidelines. [Our] knowledge about the virus has evolved and is continuing to evolve. What we know today is different from what we know tomorrow. That's the nature of medicine. There are no absolutes. We started with RTKs, we have RT-PCR, now we're going to pooled PCR then perhaps there's also rapid antigen testing. We have to keep our minds open and make the most of what we have — technology-wise."

The mayors agreed that

RTKs supported their surveillance efforts and augmented their limited testing capacity.

Ferrer, mayor of General Trias, thanked Project ARK for donating RTKs, which were used to test medical frontliners and barangay personnel.

"By making these [rapid] test kits available, we were able to address the need and obtain information that can guide us to our way forward. Testing helps us to identify probable areas that we need to strengthen protection, especially for our people and where and how to rally our resources to respond appropriately. Rapid testing keeps the morale of your workers up," he said.

Meanwhile, Maliksi, the mayor of Imus, said 1,315 individuals were tested using the RTKs donated by Project Ark. Maliksi said that they used nearly all of the 3,500 RTKs to screen workers in two public health markets.

Maliksi admitted the importance of RTKs due to its affordability and ability to offer a good insight into infection levels.

"We are able to isolate cases and enhance our contact tracing with the use of the rapid tests," Mercado-Revilla said.

She and Jenny Barzaga of Dasmariñas City, who received RTKs from Wilcon Depot shared that the test kits they received have been a viable help for the probable patient examination.

Project Ark is advancing pooled testing, a system that would enable the testing of more people at lower cost.

Concepcion said that the result of the pooled testing in Makati City will guide other local government units.

"With favorable results for the PCR pooled testing to be released on Monday (August 17), the system could further be tried on the rest of the 16 cities [and one municipality] in the Nation-

al Capital Region," he said. Concepcion noted that this testing method could work in a high-prevalence area if the number in the pool is reduced.

Pools of five or fewer can be used in such areas and up to 20 in low-prevalence areas, he said.

"It will work. We just have to be more careful. If it will not be cost-efficient, don't go for [a pool] of 10," Concepcion said, adding that pool testing should be done "regularly."

Under pooled testing, swab samples of multiple individuals would go through a single RT-PCR test. If a positive result emerges from one batch, further individual assessments will be made.

The test is designed to be sensitive enough to come up positive when at least one sample in the batch is positive. If the swab test of multiple individuals comes back negative, then individual tests are not needed.

The 11 RTC judges were directed "to hear, try, and decide expropriation cases involving national government infrastructure projects in their respective territorial jurisdiction."

The SC directive was issued in response to the letter sent to Chief Justice Peralta and Court Administrator Jose Midas P. Marquez by Public Works and Highways Secretary Mark A. Villar who

sought assistance "into the possibility of considering expropriation proceedings for the acquisition of right-of-way for priority 'Build, Build, Build' projects of the DPWH as urgent matter..."

The circular noted that several Regional Development Councils have also requested the designation of special courts to handle expropriation cases.

In the case of Villar's request, the SC was told that "two funded and on-going priority big-ticket projects – the Cavite-Laguna Expressway (CALAX) Project and

the NLEX SLEX Connector Road Project — which involved a total of 308 expropriation cases are pending with several RTCs in the cities of Imus, Trece Martires, Tagaytay, Caloocan, and Manila."

The SC was also told that 902 more expropriation cases are expected to be filed in connection with the two projects.

The SC said that the number of designated RTCs may increase on recommendation of the DPWH for key cities with priority infrastructure projects.

GenTri head welcomes joint national task force teams against COVID-19

GENERAL TRIAS CITY, Cavite Aug 17 (PIA) -- Mayor Antonio 'Ony' Ferrer on Aug 13 led the city government in welcoming the joint national task force teams composed of the National Task Force (NTF) Against COVID-19 Coordinated Operations to Defeat Epidemic (CODE) Team, and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID), in their move to support the local government units with high number of COVID-19 positive cases.

During his interview with the Presidential Communications Operations Office (PCOO) Secretary Martin Andanar, Mayor Ferrer shared the local government's support to the different sectors severely affected by the pandemic.

The mayor said the local government had always been in coordination with the City Schools Division Superintendent and the Department of Education to stay on top of the situation especially for the gadgets acquisition for the online/blended learning modalities of education in the New Normal setting.

Meanwhile, Mayor Ony revealed that there were 22 Micro Small and Medium Enterprises (MSMEs) in the city that had closed due to the adverse effect of the

pandemic. In support of the struggling businesses in the city, "The local government had issued an ordinance to waive penalties and surcharges for the payment of business taxes, and the like, and the provision of free training programs for would-be entrepreneurs," said Mayor Ferrer.

He also mentioned that although the city have a limited agriculture sector because the city is primarily an industrial city, the city government in collaboration with the Department of Agriculture (DA) had distributed free vegetables seeds to barangays to promote backyard gardening for food security during the health crisis.

The economic recovery plan of the city government mainly relies with the continued operation of the two (2) industrial estates in the city, the Cavite Economic Zone and the Gateway Business Park. Mayor Ony said, "We continue to have a dialogue with the employers of the locators in the industrial estates to inform us what support they need from the city government, like the establishment of halfway houses for their workers who need go home to their families and expose them to health risks from the COVID-19 disease." na sumailalim sa Phase 3 field trial ng dalawang kilalang pharmaceutical giant. Kasama sa pag-aaral ay ang mahigit sa 10,000 volunteer recipients ng experimental vaccine," Remulla said in a statement.

(Some Cavite residents will soon undergo phase 3 field trial from three known pharmaceutical giants. Over 10,000 volunteer recipients of the experimental vaccine will participate.)

In a text message to reporters, Remulla said the two pharmaceutical giants are from the US and UK, but claimed the agreements are

yet to be finalized and signed next week.

In the trial to be conducted, 5,000 volunteers will receive the vaccine shots while the other 5,000 will get placebo treatment.

"Ang ibig sabihin po ng placebo, ang matatanggap ng kalahati ay walang therapeutic effect. Ito ay standard protocol sa lahat ng clinical trials na ginagawa sa buong mundo," said the governor.

(It means half of them will receive vaccines that do not have therapeutic effects. This is a standard protocol in all clinical trials conducted around the world.)

"Ito din ay bahagi sa 100,000 sample size na parte ng pangatlong level ng pagsusuri sa epekto ng bakuna," he added.

(This is also part of the 100,000 sample size in the third phase of test for the effectiveness of the vaccine.)

Remulla assured that the vaccines will undergo intense scrutiny by the scientific community to determine its effectiveness.

Meanwhile, Remulla also aired concern over the Russian vaccine which President Vladimir Putin announced was the first approved vaccine for

COVID-19 even as it has yet to finish the last stage of test.

"As far as I know, the Russian data is UNAVAILABLE; their methodology is NOT open; and its efficacy has not been subject to a review and analysis," said Remulla.

He then advised the Department of Health to safeguard the process of review, approval, and appropriation of COVID-19 vaccines.

"There is no bigger decision than choosing a clinically tested and effective vaccine, at the correct time, at the fair price," he pointed out.

NTF CODE Team, IATF-EID visit Cavite Province

The Coordinated Operations to Defeat Epidemic (CODE) Team of the National Task Force (NTF) Against COVID-19, and the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID) visited the province of Cavite August 13 to provide stronger support to local government units with high transmission of the coronavirus disease.

The activity held at the Eagle Ridge Golf and Country Club began with a brief dialogue between the task force teams led by Health Secretary Francisco Duque III and the provincial government headed by Gov. Jonvic Remulla together with General Trias City Mayor Antonio 'Ony' Ferrer.

Gov. Remulla shared the province's mitigating measures implemented against the pandemic, the best practices for the containment of the spread of the coronavirus, and the plans and programs for the province's economic recovery as

well as his insights on the current situation of the country in the ongoing emergency health crisis. Sec. Duque was joined by Presidential Communications Operations Office (PCOO) Secretary Martin Andanar, Department of Trade and Industry (DTI) Secretary Ramon Lopez, Bases Conversion and Development Authority (BCDA) Secretary and Testing Czar Vince Dizon, Department of Labor and Employment (DOLE) Secretary Silvestre Bello III. Also present were Baguio City Mayor and Contact Tracing Czar Benjie Magalong, USEC Jonathan Malaya and USEC Bernard Florece, Jr. of DILG, ASEC Ma. Francia Laxamana of DOH and ASEC Dominic Tolentino of DTI. The CODE Team, composed of experts from line agencies is tasked to provide technical guidance to LGUs in developing action plans and strategies putting emphases in prevention. After the dialogue, a ceremonial distribution of face masks was held at Barangay Javalera pursuant to President Rodrigo Roa Duterte's directive to strictly enforce minimum health standards in communities and to provide 20 million face masks to vulnerable sectors that include households with senior citizens, pregnant women, special health conditions and Social Amelioration Program (SAP) beneficiaries. Cavite to roll out free Wi-Fi system for students

The province of Cavite is set to roll out a free Wi-Fi system which will be used for the educational needs of students amid the COVID-19 pandemic, Governor Jonvic Remulla said on Tuesday.

"I am very happy to announce that the Province of Cavite is about to embark in a massive rollout of FREE WiFi system that shall cover (up to 90%) of the residential areas," Remulla said in a Facebook post.

"During the ongoing quarantine period, the #CaviteFreeWiFi system shall be purely utilized for the educational requirements of public school or DepEd students which they

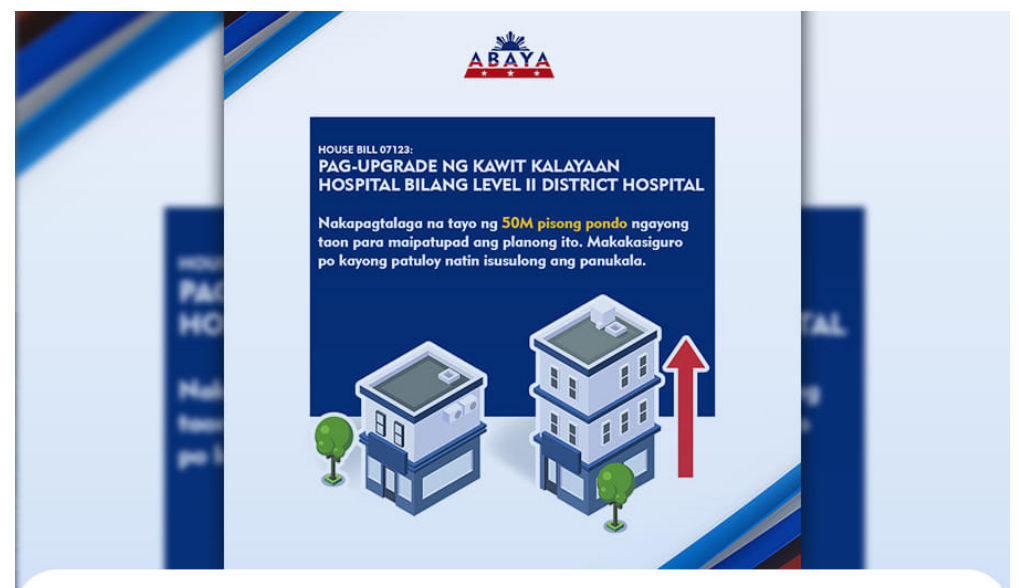
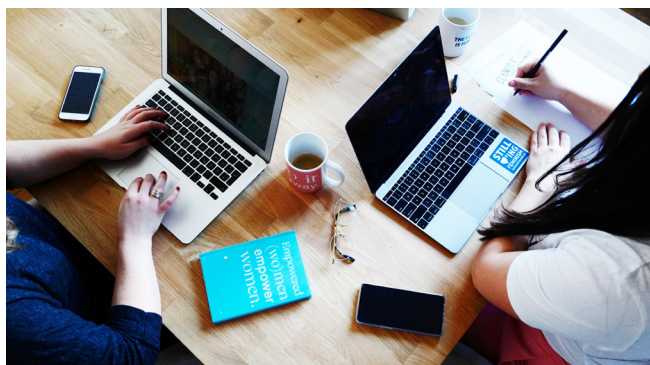
can access using their ID number," he added.

Remulla said the province is set to sign a contract with a telecommunications firm in two weeks.

When the pandemic is over, Remulla said the free Wi-Fi could also be used "as a tool for research, con-

nectivity, online retail, and knowledge generation."

Cavite Provincial Hospital starts gradual opening

TRECE MARTIRES CITY, Cavite -- The Cavite Provincial Hospital (General Emilio Aguinaldo Memorial Hospital) in Bgy. Luciano will gradually open today after it was temporarily closed last August 8 due to Covid-19 related cases.

"We will open little by little because we don't have enough staff members. Many of them are infected and

Persons Under Investigation (PUIs)," Dr. Noni John Dalisay, acting Provincial Health officer said. Cavite Gov. Juanito Victor "Jonvic" Remulla Jr. on August 8 ordered the temporary closure of the provincial hospital after many of the medical frontliners became PUIs.

"So far, wala namang malubha sa kanila, ngunit sa panahon ngayon, sugal-buhay ang hinaharap nila araw," Remulla said. Dalisay said they will only allow emergency cases at the hospital. "No admission yet," the hospital official said. According to Dalisay, around 161 hospital staff members were under investigation for Covid-19. The Provincial Environment and Natural Resources Office (PENRO) are conducting disinfection of the provincial hospital.
