# Robbery Hold-Up suspects in Imus City, nabbed

Camp BGen Pantaleon Garcia, Imus City, Cavite — Cavite PNP is actively investigating a robbery hold-up incident that occurred on the evening of August 21, 2023 in Brgy. Anabu, Imus City, Cavite, involving six suspects

According to the initial investigation, the suspects armed with firearms suddenly entered the restaurant and declared a hold-up, forcibly took the personal stuff of the victims and immediately fled after the incident.

In a manhunt operations conducted by the Imus City Police Station together with the Provincial Intelligence Unit - Cavite PPO, one of the suspect was arrested in a follow up operation in Pasay City, through continuous investigation and

## New CAVITEX toll rates << P1

Corporation, CAVITEX motorists traveling in the R1 Section or Seaside to Zapote, would be charged Php 35.00 from Php33.00 for Class 1, Php 70.00 from Php67.00 for Class 2, and Php 104.00 from Php100.00 for Class 3.

Meanwhile, motorists traversing the R1 Extension Segment 4 or Zapote to Kawit would be charged Php 73.00 from Php64.00 for Class 1, Php 146.00 from Php129.00 for Class 2, and Php 219.00 from Php194.00 for Class 3.

According to the Toll Regulatory Board, the last toll increase for R1 Section was implemented on May 12, 2022 for their 2011 and 2014 Petitions and Phase 2 Enhancement Works, while it will be the first toll adjustment for the R1 Expressway Extension, Segment 4 since May 1, 2011.

The toll increase is part of the Toll Operation Agreement between the TRB, CIC, and PRA which allows the CAVITEX toll rates to be periodically adjusted every three years.

With these toll fee adjustments, CIC and PRA are expected to continue performing their operations and maintenance obligations and to complete their ongoing expansion and improvement projects such as the C5 Link,

and enhancements on their Electronic Toll Collection System, among others, and other future expansion projects. MPTC President and CEO Rogelio Singson said that they recognize the impact of the toll increase, especially to Class 1 and Class 2 PUV drivers, thus they will re-activate the Abante Card Program to alleviate the situation during the transition.

"With the Abante Card, PUV drivers will have the opportunity to adjust and enjoy the old toll rates for a period of about three months. We believe this program will help alleviate the financial burden on our valued PUV

drivers and provide them with a smoother transition during this time. We remain committed to supporting the PUV community and ensuring their continued success on the road," Singson said.

The toll reprieve program has been designed to be user-friendly and convenient for PUV operators and drivers, MPTC said.

Once enrolled, the program will automatically apply the reprieve for a duration of 90 days, starting from the first day of the implementation of the new toll rates. (RF/PIA-Cavite; with reports from MPTS Corporate Communication)

Busway plans to improve the existing EDSA Carousel by addressing the high demand for transportation through increasing capacity and service reliability.

"The project may also involve the introduction of electric buses, reducing the carbon emissions along heavily trafficked corridors of Metro Manila,"the DOTr chief said.

Ad Hoc Committee on the MUP Pension System have borne fruit," he said.

Among the key MUP reforms include: a 90 percent maximum retirement package based on base pay for all MUP, an increase from the previous package of 85 percent for the Armed Forces of the Philippines (AFP) personnel; an annual guaranteed salary increase of 3 percent for all MUP; and two separate pension management systems: one dedicated for AFP and another for civilian uniformed personnel.

The bill also proposes that MUPs would be required to contribute 5 percent for the first three years, 7 percent for the next three years and 9 percent thereafter for active personnel while new entrants would contribute 9 percent of their base and longevity pay for their pension.

As a counterpart, the government will chip in 16 percent for the pension of those in active service during the first three years, 14 percent during the fourth to sixth year and 12 percent for the seventh year and onwards.

The government will contribute 12 percent for new entrants

"This revamped pension system underscores our unwavering commitment to the brave men and women in uniform. It not only provides financial security but also recognizes their boundless dedication and service to our nation," Romualdez

Romualdez particularly gave credit to the Philippine Marine Corps' Force Reconnaissance Group, whose 51-year presence has given Filipinos priceless peace of mind as security forces battle all kinds of terrorism.

In addition to these services, the Municipality of Alfonso extended their support by offering free circumcision for the



# **TESDA Cavite to launch 2023** World Café of Opportunities


CITY, CAVITE (PIA) - The Technical Education and Skills Development Authority (TESDA) Cavite Provincial Office prepares for the conduct of a job facilitation activity dubbed "World Café of Opportunities (WCO) this August 22 to further operationalize the agency's Job Linkaging and Networking Services (JoLINS).

## Die, mold industry's contribution to economy, employment cited

Philippine Economic Zone Authority (PEZA) Director General Tereso Panga has highlighted the contribution of the die and mold industry in the economy and employment.

In his keynote speech at the 10th Philippine Die and Mold Machineries and Equipment Exhibition (PDMEX) at the World Trade Center, Pasay City Wednesday, Panga said there are 285 registered projects in PEZA that are engaged in the die and mold activity.

These projects have generated a total of PHP23.49 billion in investments as of June 2023.

"These projects contribute to PEZA's consistent positive performance with our investments this year already totaling PHP97.163 billion, three times larger as compared to the same period last year,"

Panga said these investments also created 35,487 jobs inside economic zones.

He said that through government and private sector collaboration, the Mold and Die Technology Support Center (MTSC) was established at Cavite Economic Zone.

MTSC was funded by the Korean government with USD6.3 million in grants. It seeks to train thousands of Filipino workers on CNC machining, precision tooling, mold designing and production of various dies and molds.

"Through our program, we can help grow the metals, plastics and engineering sectors that serve the requirements of downstream manufacturing companies as well



as the local and export core-manufacturing industry," Panga said.

Panga further said the die and mold industry is a backbone for small and medium enterprises, and a critical pillar in industrial development.

"It is said that the design and manufacture of dies and molds represent a significant link in the entire production chain because nearly all mass-produced discrete parts are formed using processes that employ dies and molds," he added.

Meanwhile, PDMEX 2023 is being held until Aug. 26, showcasing cutting-edge technologies, innovations and advancements of 250 exhibitors from China, Singapore, Thailand, Hong Kong and
