Price freeze imposed over << P1

Government (DILG) Secretary Benhur Abalos announced. On Wednesday evening, Cainta Mayor Elenita Nieto put the municipality in the same status, after the Metro Manila Council decided to put the entire National Capital Region under a state of calamity due to the impact of the inclement weather.

The Department of Trade and Industry (DTI) reminded stakeholders that a price freeze is automatically imposed on basic goods upon the declaration of a state of calamity.

The DTI also posted

the prevailing prices of basic necessities. Prices range from PHP5 to PHP17 for 350 ml to 500 ml bottled water; PHP15.40 to PHP27 for 1-liter bottled water; and from PHP50 to PHP88 for 6- to 7-liter bottled water.

A 400- to 600-gram loaf of bread, as of July 24, costs from PHP40.50 to PHP8, while 250 grams to 300 grams of pandesal cost a low of PHP23.50 and a high of PHP54.

Prices of 155-gram canned sardines range from PHP13.40 to PHP25.50, depending on the brand.

Prices of black coffee

and 3-in-1 mix range from PHP4.10 to PHP84.50, depending on the brand and weight.

A 55-gram pack of instant noodles costs PHP7 to PHP10.65.

Depending on the brand and size, the prices of condensed milk and condensada range from PHP33.50 to PHP105, while evaporated milk and evaporada prices range from PHP20.50 to PHP69. Powdered milk prices range from PHP44 to PHP162 for 135- to 350-gram packs.

Prices of iodized salt range from PHP4.50 to

PHP54 for 250-gram to 1-kg. packs.

Laundry soap prices should be frozen between PHP18.50 and PHP40, depending on the weight of the product.

Prices of candles in the next 60 days should only range from PHP33.42 to PHP177.50, depending on the brand, size, and pieces.

"The DTI urges the public to report any incident of overpricing and consumer violation to the DTI Consumer Care Hotline 1-384 or at email address consumercare@dti.gov.ph," the agency said. (PNA)

that immediate repairs worth PHP5.1 million are needed for Level 1 damage, which involves restoring service areas, and PHP24 million for Level 2 damage, which entails more extensive repairs to restore facilities to their original condition.

Among the notable damages reported are a 20-meter collapsed canal lining on the west main canal of the Mayor River Irrigation System (RIS) in Mabitac, Laguna; the sluice gate of the Matanda River Irrigation System in Tanza, Cavite; and the brass dam

and river channeling of the Agos River Irrigation System (RIS) in Infanta, Quezon. In terms of agricultural impact, Palacol reported that 4,987 hectares of farmland and 5,134 farmers have been affected, with estimated crop losses reaching PHP111.81 million, predominantly affecting rice crops in their vegetative stage. Laguna province experienced the greatest damage, with PHP45.8 million reported under communal irrigation systems and PHP 34 million under national irrigation systems. The damage report

will be forwarded to the Office of the Civil Defense (OCD) and the National Disaster Risk Reduction and Management Council for Quick Response Fund assistance. "Since last week,

NIA Calabarzon, supported by Irrigators Associations, has initiated desilting and clearing operations along irrigation canals to remove debris and restore water flow," Palacol said. (PNA)

Recto: GOCCs' idle funds to be used for projects accelerating growth

Finance Secretary Ralph Recto on Tuesday said the unutilized government subsidies will be used exclusively to fund the list of projects identified under the unprogrammed appropriations as mandated by the 2024 General Appropriations Act (GAA).



Recto, during the Senate Committee on Health and Demography's inquiry on the implementation of the Universal Health Care Act, including the utilization of PhilHealth funds for program benefits, said that if the projects were to be funded with additional borrowings, it would increase the country's deficit-to-GDP (gross domestic product) ratio from 5.6 percent in 2023 to 6.4 percent in 2024.

He said this would also hike the debt-to-GDP ratio from 60.6 percent to 61.4 percent this year.

Recto said this means the country will have to pay an additional PHP12.7 billion in interest payments every year.

"In effect, we will not hit our Medium-Term Fiscal Program. And this may put pressure on our investment grade rating," he added.

A credit rating downgrade will increase the country's borrowing rates by around one full percentage point, translating to additional interest payments of at least PHP15 billion annually.

Recto said a downgrade will also generate significant uncertainties that may destabilize the country's macroeconomic environment and jeopardize the country's recovery efforts from the pandemic.

He said the projects under the list of unprogrammed appropriations include but are not limited to the Davao City By-Pass Construction Project; Samal Island Davao City Connector Project; Panay-Guimaras-Negros Island Bridges; Bataan-Cavite Interlink Bridge Project; Metro Manila Subway Project; and the Salary Standardization VI for government employees.

"To fund the unprogrammed appropriations, Congress determined that there is another way aside from new taxes as well as debts," Recto said, adding this is through collecting the idle and unused money of government-owned and controlled corporations (GOCCs).

"Our cost-benefit analysis shows that the projects to be funded by the Unprogrammed Appropriations --na utos ng Kongreso (ordered by Congress) --will hike real [gross domestic product] GDP growth by 0.7 percent, increase an additional PHP23 (billion)-PHP24.4 billion in revenues, and create hundreds of thousands of jobs," he said.

Recto said implementing these projects will help the government hit its target of 6 to 7 percent growth for the year, especially after Super Typhoon Carina ravaged Metro Manila, the country's economic powerhouse that comprises 31 percent of its GDP.

During the inquiry, Recto reiterated there is a legal basis behind the use of the PhilHealth's unutilized funds to finance projects under the unprogrammed appropriations.

He said the DOF moved in line with Republic Act No. 11975 or the GAA 2024, which was approved by the Congress.

The DOF first reviewed and studied the provision to determine its merit, assessing if it will help in growing the economy and also consulted the Governance Commission for GOCCs. Recto said the DOF also sought the legal opinions of the Government Corporate Counsel and the Commission on Audit to ensure full compliance with the law.

He added the DOF received favorable legal opinions on the matter and was advised that PhilHealth's PHP89.9 billion unutilized government subsidies are not part of its reserve funds, nor income that is being restricted by the Universal Health Care Act to be used by the national government as a general fund. It aligns with the Philippines observance of the World Day against Trafficking (WDAT) every 30th, July as a signatory to the United Nations Convention Against Transnational Organized Crime and its Protocol to Prevent, Suppress



and Punish Trafficking in Persons, particularly women and children.

DA to assist oil spill-affected fisherfolks

Department of Agriculture (DA) Secretary Francisco Tiu Laurel on Tuesday bared plans to assist fisherfolks in areas affected by the oil spill from the sunken motor tanker (MT) Terra Nova off Limay town, Bataan province.

In an ambush interview, he said the DA may utilize part of the fund intended for fuel subsidies, or from the PHP1-billion of its quick response fund (QRF).

"Ang tingin kong pinakamagandang gawin diyan is the fuel subsidy para makalayo sila at makapunta sila sa ibang lugar (I think the best thing to do is give them fuel subsidy so they can go to other areas) to continue their catching fish and deliver it to the market," Laurel said.

The DA has around PHP510.447 million budget for fuel subsidy which is initially set to be distributed to crop, livestock, and poultry farmers who own or rent production machinery.

"We are also figuring out the menu kung ano kailangang ibigay (what is needed to be given) using the QRF," Laurel said.

The Bureau of Fisheries and Aquatic Resources (BFAR), meanwhile, assured continued assessment and evaluation of the quality and safety of fish for consumption from the affected areas.

"Diyan po sa bahagi ng (In the parts of) Tanza, Cavite, Naic, Noveleta, and Rosario. May napapabalita nang dumadaong na oil slick na posibleng nangagaling na doon sa lumubog na barko (There are reported oil slick that are possibly coming from the sunken ship)," BFAR Spokesperson Nazario Briguera said during the Bagong Pilipinas Ngayon (BPN) briefing.

In terms of fishing ban implementation, Briguera said it is now up to the local governments to assess the real-time situation.

"Nasa local government units na ang pagpapasya kung magdedeklara sila base doon sa actual na nangyayari sa kanilang lokalidad (The decision will be coming from the local government units based on the actual events in their localities)," he said.

Briguera said the public should no longer consume crustaceans, shellfish, and other fishes with visible oil slick.

Overall, the BFAR said the estimated loss of income for all registered fishers in Metro Manila, Central Luzon, and Calabarzon may reach as high as PHP351 million if the oil spill continues to spread for 22 days.

To date, there are 46,000 fishers registered in the said regions. (PNA)
