According to DepEd's latest data, 2,116,809 >> P2 learners were registered in the region's provinces of Cavite, Laguna, Batangas, Rizal, and Quezon for the upcoming school year 2022-2023.

SC halts flag-raising rites, imposes lockdowns to curb infections

The Supreme Court on Monday adopted further measures to mitigate the continuing impact of the Covid-19 pandemic, including a temporary stop on the weekly flag-raising ceremony in Manila.

"It was put on hold as a precaution to the recent spike in Covid-19 infections," SC spokesperson Brian Keith Hosaka told the Philippine News Agency on Monday. Among the courts temporarily shut down were to August 2; Tarlac City RTC Branch 110 from July 29 the Calamba City, Laguna Regional Trial Court (RTC) Branch 35 from July 28 to August 3; Imus, Cavite Metropolitan Trial Court in Cities (MTCCs) Office of the Clerk of Court and Branches 1 and 2 from July 26 to August 1; Municipal Circuit Trial Court Branch 5 of Don Carlos-Kitaotao-Dangcagan in Bukidnon from July 29

to August 4; Lucena City RTC Branch 55 from July 28 to August 3; and Baguio City Family Court Branch 2 from July 29 to August 4.

The National Capital Region (NCR) remains under the most lenient Alert Level 1 classification but is classified as moderate risk for Covid-19, according to Undersecretary for Public Health Services Team Beverly Ho

She said the NCR has the highest daily moving average with almost 1,100 cases per day.

The Department of Health (DOH) reported 4,127 new cases of Covid-19 on Friday that brought the total active infections to 32,637.

The DOH likewise recorded 890 additional cases of the Omicron BA.5 subvariant of Covid-19 on July 28, but 823 of them have recovered.

To date, the country has logged a total of 1,997 BA.5 cases, 71 BA.4 cases, and 154 BA.2.12.1 cases. (PNA)

resolve as a world-class manufacturer," URC's president and chief executive officer Irwin Lee said in a statement Thursday.

"The culminating goal," he said, "is to establish a sustainable value chain within a few years."

With "Juan Goal for Plastic", URC hopes to help convert post-consumer waste into something useful, and to be an active part of consumers' collect-and-recycle activities. Under this program, several plastic collection sites have been set up in the country, with more to be opened within the year.

Through its La Carlota sugar mill in Negros Occidental and in partnership with the city of La Carlota, Barangay Roberto Salas Benedicto (RSB) and the Sangguniang Kabataan of Barangay RSB, URC is collecting PET (polyethylene terephthalate) bottles and other types of plastic every month. It is exchanging plastic waste for cash, matching weight for "environmental points".

URC's plant in Bagong Ilog partnered with the Pasig City government and Basic

Environmental Systems & Technologies, Inc. (BEST) to collect plastic twice a week in exchange for environmental points that can be used to redeem URC products or school supplies. In General Mariano Alvarez (GMA), Cavite, URC's plant teamed up with the local government of GMA and Municipal Environment and Natural Resources Office (MENRO) to collect plastic every month in exchange for URC products.

Other sites include Robinsons Malls Galleria that started July 30, to be followed by Robinsons Malls in Ermita, Las Pinas, Magnolia and Starmills Pampanga, starting August 13.

In partnership with Robinsons Land Corporation (RLC), URC will set up plastic collection booths in these locations every payday weekend, which will offer a drop-weigh-redeem scheme for clean and dry plastic

"With our current systems, plastic waste will be segregated and given new life that supports a true circular economy," Lee said.

URC has also been looking at multi-stakeholder partnerships to tackle the immense plastics challenge.

It is one of the member companies of the Alliance to End Plastic Waste, an industry-founded non-profit organization which promotes solutions that reduce and avoid environmental pollution from plastic waste.

URC is likewise an investor and strategic partner of Planet First, a purpose-led European growth investment platform dedicated to developing solutions to address sustainability challenges.

URC's initiatives are in line with the Gokongwei Group's thrust to promote long-term efforts that will significantly help manage post-consumer plastic waste.

Other business units under the group have ongoing collection, sorting and recycling programs in various areas nationwide.

RLC is offering rice in exchange for plastic waste through its "Trash to Bigas" project. Robinsons malls partnered with Robinsons Supermarket, where customers can swap a kilo of plastic donated with a half-kilo of rice every weekend since June. This initiative is currently being done at Robinsons Place in General Santos City. Another initiative is the Easy on the Plastic program which aims to divert plastics from oceans and landfills to more sustainable options.

In two years, 18,000 ecobricks were collected and were used to create a community center for the Yangil tribe in Zambales while some were converted to school Select Robinsons Easymart and Robinsons Supermarket branches have started accepting clean and dry PET bottles, which will be processed and recycled.

"Our ambition to become a sustainable global enterprise has been steadfast and resolute, amid lingering challenges and the steady reopening of economies," Lee said. "The plans that we have set in motion are bringing us closer to our goals." (PR)

DepEd: Calabarzon logs << P

This accounted for over 10 percent of the national figure for enrollment hitting 14,284,778.

The National Capital Region (NCR) recorded the second highest count with more than 1.7 million enrollees, followed by Central Luzon with over 1.4 million.

Learners at the elementary level recorded the highest turnout with over 6.6 million, followed by enrollees from Junior High School with more than 4.6 million, then over 2.1 million learners in Senior High School, and 946,611 learners in Kindergarten.

Earlier, Education spokesperson Michael Poa noted that this year's enrollment turnout was significantly higher than the previous school year, considering their approach to a gradual transitioning to in-person

The DepEd assured the public that the majority of schools last year have shown preparedness for the face-toface learning setup.

In a Viber message, the DepEd said 34,769 schools

are participating in face-toface classes.

"Out of this number, 33,691 of which are public schools or 74.67 percent of the total number of public schools, and 1,078 of which are private schools or 8.73 percent of the total number of private schools," the DepEd said. (PNA)

and House Speaker for seven days. Ramos passed away on Sunday at the age of 94.

Before the start of the session, senators offered a prayer to the late President headed by Senate President Pro Tempore Senator Loren Legarda.,

Senate President Juan Miguel Zubiri, in his resolution, said the Ramos administration from 1992 to 1998 is known for the program "Philippines 2000", which envisioned the country to be newly industrialized by the year 2000, for instituting economic reforms which drove investments in the country to surge, and for navigating the Philippine economy during the 1997 East Asia Financial crisis, steering our country 's effort and turning the sick man of Asia into Asia's next Tiger economy,. For his part, Senate Minority Leader Aquilino "Koko" Pimentel III extended his deepest condolences to the family and all the loved ones of former President Ramos, the father of the Edsa Revolution and the man who once turned the Philippines as Asia's Economic Tiger.

"President FVR shall be remembered as the man who sincerely pursued people empowerment and implemented many reforms and innovative ideas such as the Build Operate Transfer Law. Rest in peace President Ramos. Please say hello to my Tatay Nene (Aquilino Pimentel Jr.) in heaven." Pimentel said.

Senator Sonny Angara, on the other hand, said the late President Ramos' success in leveraging a minority mandate into major reform victories shows the way on how crucial changes in governance can be done. He did it through consultations, by listening, and by reaching out to all stakeholders, even to those who are not in his camp. "To channel good ideas to a forum where these can be discussed, he (Ramos) created with my late father (then Senate President Ed Angara) sounding boards like the Legislative Executive Development Advisory Council or the LEDAC. He was the leader "who cast a wide net in order to haul in

great ideas." Angara said.

He said the late President used his expertise in the military in cobbling together many ragtag units into one cohesive fighting force in building the same coalition when he became president and even assembled a senatorial slate that was considered a team of rivals. "Hindi nya sinupil ang opposition (He did not suppress the opposition). Instead of curtailing constructive criticisms, he cultivated it. And he took action on complaints through handwritten orders to the concerned agencies." Angara added. Earlier, Senator Ramon Bong Revilla described the late President as his mentor when he was then Vice Governor of Cavite and they

Senator Risa Hontiveros, on the other hand, described the former President as a major game-changer during the People Power Revolution, encouraging many other longer-standing freedom fighters, and laid down a strong foundation for political recovery and economic stability, which reinvigorated a country emerging from the very dark shadow of the Martial Law dictatorship.

"I also echo his belief that land reform and strengthening agriculture are pillars of peace in the rural areas. President Ramos saw tillers owning their own land as being fundamental to deepening Philippine democracy. Peace and stability, which took top priority in his 5-point program, also set the stage for talks and negotiations with separatist groups, which broke down barriers and led to a landmark peace agreement." Hontiveros said.

President Ramos can also be remembered as the architect for building peace among the Moro rebels when he initiated peace talks with the Moro National Liberation Front (MNLF) in 1996.

"The Filipino people lived in a time of hope during former President Fidel Valdez Ramos' tenure. FVR oversaw massive economic gains for the country that were translated to programs for the welfare of the people.

PFF begins building new office in Cavite

CARMONA, Cavite – The Philippine Football Federation (PFF) has begun the construction of its new head-quarters here -- a five-story office building with state-of-the-art facilities that would help in the advancement of the federation's functions.

PFF president Nonong Araneta, secretary general Ed Gastanes, Philippine Sports Commission (PSC) officer-in-charge Guillermo Iroy, and officials of international body FIFA and Asian Football Confederation (AFC), graced the groundbreaking ceremonies along Sugar Road. "I'm just happy that having a new headquarters is becoming a reality for Philippine football," Araneta said in an interview. "We need a new headquarters for developing the popularity of the sport in this country."

He revealed that the AFC granted the PFF USD800,000 for buying the lot while FIFA is taking care of the finances for building the office.

A fitness and rehabilitation gym will be included in the new PFF office. While the new PFF building will be far from the metropolis



compared to the federation's current office in Pasig City, near the PSC, Araneta said it is high time for a new "House of Football". "You've seen our headquarters in Pasig, which is not very conducive. The organization is growing and expanding so we need a new place," he said. "Doon sa PFF ngayon, siksikan na (It's crowded in our current office). Now, we have enough space for our employees."

The new PFF headquarters is expected to be completed by 2023, in time for the country's stint in the FIFA Women's World Cup in Australia and New Zealand.

The new PFF office is

directly accessible to the PFF National Training Centre (NTC) as they share the same main road.

The Sugar Road Gate of

the San Lazaro Leisure Park, where the NTC is located, is closed for now as part of Covid-19 protocols.

The PFF plans to reopen

the gate once the new PFF office is operational. "We're going to have two buses that

will be there [in the PFF headquarters], which will be used by our national team and our employees to ferry them here," he added. For now, the national football staff, the Azkals, and the Filipinas, are being transported to the NTC from Metro Manila, although holding their training sessions at the Rizal Memorial Stadium in Manila is another option. Araneta said there is also a plan to build a dormitory for both the Azkals and Filipinas by 2024. (PNA)

Metro Manila Subway Project 60% complete on procurement

An official of the Department of Transportation (DOTr) on Tuesday said the Metro Manila Subway Project has reached 60 percent completion rate on procurement.

"Metro Manila Subway is 33 kilometers (km) from Valenzuela all the way to the Ninoy Aquino International Airport (NAIA), around 17 stations. We expect to provide daily ridership from 400,000 to as high as 800,000," DOTr Undersecretary for Railways Cesar Chavez said during the post-State of the Nation Address (SONA) economic briefing at the Philippine International Convention Center (PICC) in Pasay City. He also gave an update on the railway projects based on four indicators—procurement, design, right-of-way (ROW) acquisition, and construction. Another big-ticket project is the North-South Commuter Railway (NSCR) project, with both its Tutuban to Malolos and Malolos to Clark segments at 93 percent complete on procurement, while the Manila to Tutuban to Calamba segment is at 61 percent complete on procurement. "As to the detail and design, we're more than 70 percent complete, and as to ROW, it's 55 to 60 percent," he said.

The NSCR is expected to be operational by 2026 to 2027 and will run for 147 kilometers from Clark to Calamba.

It will have 35 stations and is expected to have a daily passenger capacity of 400,000 to 700,000 daily. Chavez said the Light Rail Transit Line 1 (LRT-1) Extension Project—which will extend the LRT-1 southward from Baclaran to Bacoor, Cavite—is at 69 percent completion rate on construction. "The 122 trains are there already, around 24 rolling stocks. The station developments are in place already, except Las Piñas to Bacoor," he said. Meanwhile, the Metro Rail Transit Line 7 (MRT-7), a public-private partnership (PPP) project with San Miguel Corp., is at a 61 percent completion rate on construction.

Once complete, Chavez said the MRT-7 is seen to have a daily passenger capacity from 400,000 to 800,000. It will run for 22.8 km

from northeast to northwest, have 14 stations, and will connect San Jose del Monte, Bulacan to the Common Station in Quezon City.

To date, Chavez said the common station, or the Unified Grand Central Station, is expected to be completed by "the second quarter of 2023."

Designed to connect the LRT-1, MRT-3, MRT-7, and the Metro Manila Subway with access to road transport, he said the station is expected to serve "at least 150, passengers daily."

In addition to these projects in Luzon, he reiterated President Ferdinand "Bongbong" Marcos Jr.'s desire to complete the Cebu Railway System, the Panay Railway Project, and the Mindanao Railway Project (MRP). The MRP, he said, is to be "resubmitted" to the National Economic Development Authority (NEDA) "in the coming weeks" for funding reapproval.

"The intention is to continue whether we're going to PPP or ODA (official development assistance), we will leave it to the Department of Finance, NEDA, and the economic team of the President," he said. He said while the Panay Railway Project is not "in the master plan," he said at least five railway projects have been identified for development in the Visayas. "Good news for Cebu, because in the master plan of rail transport from 2018 to 2019 there are five railway projects identified for development in the Visayas, in particular in Cebu province," he said.

On Monday, Marcos in his first SONA announced his administration's desire to continue the "Build, Build, Build" program of the previous administration and other projects such as the Panay Railway Project and the Cebu Railway System.

The 12 railway projects have a combined cost of PHP1.9 trillion and are at various stages of implementation. Marcos noted that the infrastructure development spending of the country will be sustained at 5 percent of the gross domestic product in addition to making use of PPPs. (PNA)
