

Cavite to soon open 'biggest COVID-19 testing lab in the country'

The province of Cavite may soon be able to conduct around 10,000 COVID-19 tests a day with the upcoming opening of a testing laboratory that can facilitate 3,000 tests daily, Gov. Jonvic Remulla said on Thursday.

Distribution of Financial and Burial Assistance

Amidst the Covid 19 pandemic, the provincial government led by Governor Jonvic Remulla never cease to find ways to deliver its services to the people of Cavite, particularly the distribution of financial assistance which was temporarily suspended due to the outbreak. Prioritizing the safety of its constituents, mass distribution which will gather a huge crowd was disallowed



"In Cavite, we are doing our best: The biggest testing laboratory in the country is about to open at DLSU (Dela Salle University) Dasmariñas: 3,000 tests a day, 7 days a week," he said

Once the laboratory at the university opens to the public, this will bring Cavite's testing capacity to 10,000 tests per day, Remulla said in a text message to INQUIR-ER.net.

Remulla said Cavite is building two more laboratories for COVID-19 testing.

Sought for confirmation if the Cavite laboratory would indeed be the biggest laboratory by capacity, Health Undersecretary Maria Rosario

Bacoor City Hall of Justice placed under 2-week lockdown



BACOOR, Cavite – The city government announced on Saturday (Aug. 1) that the Hall of Justice in Barangay Tabing Dagat will be temporarily closed after two lawyers and a security guard tested positive for coronavirus disease (COVID-19).

The Hall of Justice will be on lockdown until August 14 for contract-tracing measures and for all employees to undergo a 14-day quarantine. The local government unit (LGU) also asked those who visited the Hall of Justice between July 20 and July 30 to immediately coordinate with their respective Barangay Health Emergency Response Teams (BHERTs), especially if they are experiencing COVID-19

symptoms. With the Hall of Justice being a critical zone (CrZ), an area surrounding it is categorized as a containment zone (CZ) where modified enhanced community quarantine (MECQ) rules will apply during the lockdown period. Barangay officials were tasked to identify exactly which households fall under the CZ. As of July 30, the city has recorded 695 cases of COVID-19, with 264 recoveries and 38 deaths.

No 'jowa passes': Cavite lays down rules for MECQ

Cavite Governor Jonvic Remulla announced on Tuesday several guidelines for the modified enhanced community quarantine (MECQ) to be imposed in the province, including the cancellation of "jowa passes."

"Unofficial travel shall be strictly limited. All jowa passes are cancelled," Remulla said in a Facebook post, apparently referring to ex-





Megaworld's upscale village in Cavite sold out

Tycoon Andrew Tan-led property developer Megaworld Corp. sold out its first upscale residential village in Trece Martires, Cavite last month, generating P3 billion from the sale of the entire residential inventory within seven months from project launch.

Sales of residential lots at the 18-hectare Arden Botanical Village, which was launched in November 2019, peaked at P1.4 billion during the second quarter, despite tough lockdown protocols for most of this period.

Metro Manila and the Cavite-Laguna-Batangas-Rizal-Quezon shifted to general community quarantine (GCQ) only starting June 1, alongside Davao City, Cagayan Valley, Central Luzon, Pangasinan and Albay.

This was even as Megaworld increased selling prices twice, first in January and another May this year. From P23,000 per square meter in December last year, lot prices in the village rose by 35 percent to P31,000 per square meter in May this year.

When the project was unveiled in November last year, the group was projecting to unlock only P2.5 billion worth of lot sales from Arden Botanical Estate.

we have booked sales from buyers in the Philippines and across the world who were looking for purposeful, more livable spaces to build a house.

Arden Botanical Village's concept gave us a convenient push, and the unique concept of Arden Botanical Estate as an integrated lifestyle community was a huge factor in selling this fast even amidst the pandemic," said Eugene Em Lozano, first vice president for sales and marketing at Megaworld.

Turnover of lots at Arden Botanical Village, which is part of the 251-hectare Arden Botanical Estate, is scheduled to start in 2024. The village will have 329 lots ranging from 280 to 609 square meters.

"A P7 million lot bought when we started selling late last year can now be sold at almost P9.5 million. Our early takers are so happy with their investments today," added Lozano.

Designed by Filipino landscape architect and environmental planner Paulo Alcazaren, the centrepiece of the gated Arden Botanical Village will be Centrera Park, which is surrounded by natural groves of mature trees, natural waterways and "Amid the lockdown, ponds, sprawling lush green-





eries, expansive open space, promenades and parks, and jogging paths.

The clubhouse will also be part of the Centrera Park. A natural swimming pool will be part of the amenities and village landscape, in line with the trend seen among European neighborhoods.

Taking inspiration from Scandinavian architecture, Arden Botanical Village will also feature thematic bridges, landscaped walkways, bike lanes, and some interactive water features.

Houses and village ame-

nities, including the village showroom, will feature minimalist form and clean lines with panoramic windows that look out, and make a pleasant contrast with the village's verdant landscape.

This village is a joint development of Megaworld and its subsidiary Global-Estate Resorts Inc. (GERI).

They expect to spend P18 billion to build the integrated lifestyle community in Arden Botanical Estate, which will be highlighted by flower farms and gardens, within the next 10 years.

said were confusing policies of the government in dealing with the pandemic.

"We are launching an educational plan in 10 days. Clue: #FreeWiFiForCavite," said the governor.

He also revealed that Cavite will implement a provincial identification system for effective administration of the COVID-19 vaccine once it is available.

He said that the government should be ready to respond to specific concerns once the vaccine becomes ready for use.

"How do we administer 220,000,000 doses (2 shots per person x 110 million Filipinos)? How do we do it without creating the least amount of panic and hysteria? Who gets it FIRST and how do people get it quickly enough?" asked the gover-

"How do we apply the lessons learned from the challenges we encountered during the SAP distribution and avoid the same mistakes when it comes to the availment and administration of the vaccine?" he also asked.

He noted that "if our minds are full in the containment strategy, then our best minds should have the foresight and prepare for the arrival of the vaccine."

"The good news is we are now crafting a proactive and viable plan for Cavite," Remulla added.

Cavite's Educational Plan bared, strictly for students' learning

MARTIRES CITY, Cavite, Aug 4 (PIA) --Cavite Governor Jonvic Remulla bared the province's Educational Plan in anticipation of the opening of classes on August 24, 2020 following the Department of Education's blended learning modalities.

According to Gov. Jonvic Remulla, the provincial government would invest over Php4M a year for 5 years to set up a Virtual Private Network to serve the entire DepEd (approximately 650,000 students) in Cavite to run the Cavite Educational program.

This will involve setting up 5,000 access points across 829 barangays to reach 400,000 homes for the whole province.

Similarly, the program will use the DepEd system of transmission of lessons that can be downloaded with the use of electronic gadgets (smart phones, laptops, desktops, and tablets).



Moreover, the system is time bound sensitive for assessment purposes to monitor the progress of the chil-

On the other hand, the program's limitations are the access to devices with those who could not afford a gadget will have to rely on the materials printed by DepEd and the system cannot be used for any other application except for education.

The system can only be accessed with the use of the DepEd Student ID number system.

Governor Remulla was happy to announced that the Cavite Educational system is free. "Investing in our students is investing for the future. The pandemic may be gone sooner or later but the opportunity lost for the young minds today is a cost that will be hard to pay for," the governor concluded. Cavite's COVID-19 plans: 10,000 coronavirus tests a day, free WiFi, vaccine ID system

If free internet access to students and roll out an ID system for the distribution of a vaccine against COVID-19, the province's governor said Thursday.

A laboratory that can run 3,000 tests a day will open at the De La Salle University - Dasmariñas, Cavite Governor Jonvic Remulla said on Facebook.

The local government is building 2 more laboratories to serve Cavite, the most populous province in the Calabarzon

"Our combined capacity will reach 10k/day," he said in a text message to reporters. The screening will give priority to Caviteños, said Remulla. "Targeted testing for qualified

> The governor also hinted that the local government would offer free WiFi to students while face-to-face classes remain prohibited.

> "We are launching an EDUCATIONAL plan in 10 days. Clue: #FreeWiFiForCavite," Remulla said.

> In preparation for the availability of a vaccine against the novel coronavirus, Cavite will implement a provincial ID system "for effective administration purposes," he said.

> Coronavirus infections in the Philippines breached the 85,000-mark on Wednesday, as projected by researchers from the University of the Philippines and surpassing mainland China's cumulative tally of the disease.

> "Maraming magulo at walang kabuluhan na patakaran (backride parachute). Parami ng parami ang napipikon habang ang iba naman ay patuloy na umaasa at naghihintay sa susunod na ayuda," said the governor.
