Cavite mayors to discuss fare readjustment

Moreno visits Cavite to offer pro-poor plan

Presidential candidate and Manila City Mayor Isko Moreno Domagoso has won the hearts and minds of Caviteňos as he offered his pro-poor agenda to the province.

In a town hall meeting in Naic, Cavite on Saturday, Moreno, the Aksyon Demokratiko standard-bearer, vowed that if elected president, he will give the people a government that focuses on the plight of the ordinary people, a government that listens and cares for their needs.

"I know that for many of you, before the pandemic, life was hard. Of course, we are even more devastated by the pandemic. It's hard to be poor," Moreno said, in front of more than a thousand residents.

The 45-kilometer Cavite-Laguna Expressway (CALAX) is seen to become a "green highway" under a partnership inked on Monday, December 6. Manny Pangilinan-led Metro Pacific Tollways (MPT) South Management Corporation signed a memorandum of agreement with the United States Agency for International Development (USAID) for sustainability efforts along the expressway, under the Sustainable Interventions for Biodiversity, Oceans, and Landscapes (SIBOL) project.



MPT South and USAID will work on a biodiversity program that will include tree planting along CALAX, advancing science-based decision-making, promoting good environmental practices, and fos-

Gatchalian seeks to institutionalize 'One Town One Product' to encourage growth of MSMEs

The proposed OTOP Philippines Program highlights the use of indigenous raw materials and utilization of local skills and talents. It

Tycoons facing make or break in Sangley airport bid

Cavite Gov. Jonvic Remulla remains keen on developing an international airport in Sangley Point alongside private sector partners, saying the evaluation of a new proposal will be completed "within a month."

Last November, business groups led by taipan Lucio Tan, the Yuchengco family, and Luis Virata submitted an unsolicited bid to turn Sangley into a global gateway that would rival and eventually replace Manila's Ninoy Aquino International Airport.

"We are pursuing the airport project," Remulla told the Inquirer over the weekend.

Calling themselves the SPIA Development Consortium, the business tycoons partnered with South Korean firm Samsung C&T Corp. and Munich Airport International GmbH, the management services arm of

In a previous statement, the Cavite government said the proposed venture with the consortium would include the development, design, financing, construction, operation and maintenance of the Sangley airport

Lacson confident for Cavite's support in 2022

Presidential aspirant and Senator Panfilo Lacson is confident his fellow Caviteños will rally behind him in next vear's elections.

Lacson said ever since he joined national politics, he has always ranked first in his hometown, except in 2001, when he placed second to



broadcaster Noli De Castro in tional Police chief Guillermo the senatorial race.

They met with their supporters in General Trias City, along with Mayor Ony Ferrer, Carmona Mayor Roy Loyola, and Cavite 6th District Rep. Jonjon Ferrer.

"Hopefully, with God's mercy and with your help, if I am lucky, you will have a government that you can lean on, that has ears, that you can run to, and that understands and listens to you," Moreno said.

To achieve a government for the people, Moreno said his administration would prioritize providing the minimum basic needs food, housing, health, education, and jobs.

To bring immediate relief to the people, the 47-year-old presidential aspirant said the first policies he would institute is to cut by 50 percent the taxes of petroleum products and electricity by 50 percent to bring more food on the table, raise family income and provide extra savings.

While the twin tax cuts may result in some P130 billion in revenue losses to the government, he said it will ease the plight of the poor and provide them the wherewithal to survive the pandemic in the next two years.

"I just want the government to step back a little bit first, the people to move a little bit. The losses of the government are for the benefit of the people. The fast method, when people can taste it right away, it alleviates their problems - cheap prices, being able to work, cheap fares, cheap electricity, "Moreno said.

He said he would also build more modern public housing, public hospitals, and public-school buildings around the country, like what he did in Manila.

Under the leadership of Moreno, the City Government of Manila has built vertical housing units like Tondominium and Binondominium; built modern public hospitals like the Bagong Ospital ng Maynila and the Corazon C. Aquino General Hospital; built a Covid Field Hospital, and built 10-story modern public-school

with Cavite Governor Jonvic Remulla at the provincial capitol in Trece Martires City.

Remulla has not endorsed any presidential or vice-presidential aspirants. But his political party, the National Unity Party, is allied with Partido Reporma, which Lacson heads.

Earlier, Vice President Leni Robredo and her running mate, Sen. Kiko Pangilinan, also met with Remulla. But Lacson said he is confident he would get the governor's support, even adding that they are related by blood.

"Sa tingin ko, makukuha pa rin namin ang Cavite as a solid vote. At least, kami ang tatangkilikin. Mataas ang aming pag-asa na kami [ang] mananalo sa Cavite," he said.

[Translation: I believe we will clinch the solid vote of Cavite. At least, it is us whom they will support. We are very hopeful that we will win in Cavite.]

Cavite is the second most vote-rich province in the country, with more than 2.1 million voters as of 2019, based on data from the Commission on Elections.

of end September 2021 from Franchising and Regulatory 52.5% in June 2020. The same survey showed that although 27.7% of MSMEs stopped operations in June 2020, the figures went down to 6.9% as of end September 2021.
