# SSS reminds members of << P1

members may submit their UMID Card applications at SSS branches following the number coding system. They may also set first an appointment with their preferred branch using the Appointment System in the My.SSS Member Portal.

The list of SSS branches accepting UMID Card applications can be accessed at https://bit.ly/UMIDAppFacilities.

"We encourage our members to accomplish the UMID Card Application Form before going to their preferred SSS branch to lessen the time they will spend

in them," SSS President and CEO Aurora C. Ignacio said.

Together with the properly accomplished UMID Card Application Form, members are also required to bring one primary valid ID, or in its absence, two secondary valid IDs.

UMID Card Application Forms can be downloaded through the SSS website https://bit.ly/UMIDAp-

Starting September 27, 2021, the SSS gradually resumed the acceptance of UMID Card applications in its branches.

Qualified to apply for branches. We are remind-

members with at least one posted contribution. It is free of charge for first-time applicants, but for those who lost their UMID Cards or need to update them, they will have to pay a P200 replacement fee at the SSS branch.

"The SSS is the only authorized institution that accepts applications and issues UMID Cards for its members working in the private sector. The biometrics data capturing, which is an important process in the issuance of UMID Cards, is currently done only through our

SSS-issued UMID Cards are ing our members to refrain from transacting with fixers to avoid any inconvenience," Ignacio added. Meanwhile, members who applied for an SS Number online beginning December 10, 2020, will no longer need to fill out a UMID Card Application Form. They just need to set an appointment with their preferred SSS branch for biometric data capture and present their printed SS Number application and transaction number slip.

> The SSS advises its members that there will be delays in the production and availability of UMID Cards until

further notice. A notification will be issued to UMID applicants when their cards are available for pick-up. For members who are applying

for work in Taiwan, the SSS will continue to issue certification in lieu of the SSS-issued UMID Card to facilitate their visa application.

He disclosed that the demo farm showcased a variety of vegetables and served as the learning field for the twenty-eight (28) farmer-members of the three (3) DAR assisted agrarian reform beneficiary organizations (ARBOs) enrolled under the DAR's Farm Business

School (FBS), where farming technology was introduced.

"Your established demo farm is undeniably the fruit of your hard work, coordination, and unity. We want to congratulate all of you on the successful implementation of the project. So you can see, there is money in farming and vegetable production," Dubongco said.

Go's team provided financial assistance, grocery packs, vitamins, snacks and masks to a total of 148 families at Niog 1 Elementary School. They also gave select residents bicycles and new pairs of shoes, as well as computer tablets to help children studying under the blended learning set-up.

Meanwhile, the Department of Social Welfare and Development provided the fire victims financial assistance. The National Housing Authority also assessed potential beneficiaries for its Emergency Housing Assistance Program.

Go also noted that the pandemic has disrupted access of many Caviteños to vital health services. He advised those who cannot settle their hospital bills to seek aid from the government through the Malasakit Centers at the Southern Tagalog Regional Hospital in Bacoor City and General Emilio Aguinaldo Memorial Hospital in Trece Martires City.

The Malasakit Center is a one-stop shop that aims to provide patients convenient access to the medical assistance programs of the DSWD, Department of Health, Philippine Health Insurance Corporation and Philippine Charity Sweepstakes Office.

As Vice Chair of the Senate Committee on Finance, Go has also supported various initiatives to accelerate the infrastructure development and improve the delivery of key services in Cavite.

In General Trias City, he supported various road concreting projects as well as the construction and rehabilitation of various multipurpose buildings, covered courts, barangay halls and drainage systems. In Imus City, he helped fund various road rehabilitations and construction of multipurpose buildings. He was also instrumental in the construction of the National Road System (Primary Roads-Manila-Cavite) in Cavite City and the provision of medical assistance to indigenous people in Kawit.

Other initiatives he supported include the improvement of roads in the cities of Dasmariñas and Tagaytay; acquisition of ambulance units for the local governments of Indang and Trece Martires City; rehabilitation and improvement of the municipal fire station in Noveleta; and improvement of a sports facility in the Cavite State University in Indang.

# Shorter interval between primary, booster shots under study

The government is studying the possibility of shortening the interval between primary doses and booster shots, National Task Force (NTF) Against Covid-19 chief Secretary Carlito Galvez Jr. said on Monday.

Current guidelines require six months, except for the single-dose Janssen vaccine that needs just three months.

# Over 1.4K housing units to benefit informal settlers in Bacoor

The Department of Human Settlements and Urban Development (DHSUD) announced on Wednesday that more than 1,400 informal settler families (ISFs) will benefit from the newly built-government housing project in Bacoor, Cavite.

DHSUD Secretary Eduardo del Rosario said among the beneficiaries are families residing in danger zones and accident-prone areas in Bacoor City.

On Tuesday, del Rosario graced the inspection and ceremonial turnover of the new houses within "the Ciudad de Strike Phase I", the government's third low-rise housing project in Barangay Molino.

The housing project materialized via the Social Housing Finance Corporation (SHFC), under its Community Mortgage Program, in partnership with the local government of Bacoor.

"Masasabi po natin para po sa inyo ang pinakamaganda at pinakamahalagang Christmas gift na maibibigay ng Bacoor City LGU, na magkaroon kayo ng isang housing settlement na masasabi nating disente, affordable at sustainable (I can say that the greatest and valuable Christmas gift that Bacoor-LGU could give is to provide you a decent, affordable and sustainable housing settlement)," del Rosario said in his message during the event.

Del Rosario noted that the project is part of the government's resettlement program, in direct coordination with the local government units, which provide subsidized housing rates for beneficiaries.

"Pinababa po namin nang husto ang interest rate dahil yan po ang utos ng ating mahal na Pangulo to ensure na tulungan ang ating mga kababayan (We drastically lowered the interest rate because that is the order of our President to ensure that we help our countrymen), 81 percent of Filipinos will have their own dream house," he added.

The housing czar reiterated that part of the DHSUD's primary principles is "housing is a right of every Filipino family,

# Elderly, immunocompromised remain vax priorities

The government will continue to prioritize senior citizens and persons with comorbidities as it expands the vaccination program with booster shots for more sectors.

Presidential Adviser on Covid-19 Response, Secretary Vince Dizon, said Monday the inoculation of the elderly and immunocompromised will always be among the priorities, aside from health workers.

"But, since we have enough [vaccine] supply, sabay-sabay na tayo (we can do it simultaneously)," he said in an interview during a mall vaccination activity in Bacoor, Cavite. The government continues to urge Filipinos to avail of the primary doses and booster shots once they are qualified -- three months after the single-dose Janssen and six months for all other brands.

The second leg of the "Bayanihan, Bakunahan" massive vaccination drive will be held on December 15 to 17 to reach the target for population protection by the end of the year, pegged at 54 million.

Department of Health Assistant Secretary, Dr. Maria Francia Laxamana, said apart from health care workers, senior citizens, and persons with comorbidities, the economic workers and indigent population may now avail themselves of booster shots and additional Covid-19 doses.

Laxamana said the second round of "Bayanihan, Bakunhanan" will inoculate the 12-17 age bracket and administer primary doses and booster shots.

Walk-in vaccinees will be allowed as the three-day drive aims for seven million jabs.

The administration of second doses will also be prioritized this month.

Based on the latest data from the national Covid-19 vaccination dashboard, the Philippines has administered 96,282,497 doses nationwide, with 54,644,780 doses used as first shots, 40,881,035 as second doses and 756,682 as booster shots. (PNA)

Escudero first put forward the bill in 2007 when he was elected to the Senate and refiled it in 2013 in a move to boost transparency and accountability, and curb graft and corruption within the bureaucracy. # SC cautions lawyers vs. unbecoming outbursts

A lawyer who voiced harsh words against his adversary in public has been reprimanded by the Supreme Court and sternly warned against repeating the same.

In a resolution uploaded on the SC website on December 3, the SC's Second Division sanctioned lawyer Simeon C. Sato for angrily shouting "I will send you to jail!" during a heated exchange with the complainant, Ik Kwan Lee in 2015 in Rosario, Cavite.

"Emotions ran high, considering that there are civil cases between Atty. Sato's client and Lee. Even so, Atty. Sato should be warned not to engage in the same or any similar act in the future," the SC said.

Sato, the opposing counsel in an ejectment case Lee supposedly already won, angrily confronted the latter at the compound of RIH ITA Electronics Corp. at the Cavite Export Processing Zone in Rosario, Cavite.

Sato allegedly told Lee, "You



should not be here, it has been a long time since you have been gone" and Lee replied "I came to claim my factory back".

Sato apparently entered his car when Lee instructed a witness to record the incident on her phone prompting Sato to Lee "I will send you to jail".

In its ruling, the SC said the counsel was reminded "that a lawyer must conduct him/herself ethically and morally, and should not engage in any behavior that would adversely affect his/ her fitness to practice law"

It added that Sato "should have held his temper and avoided having an argument with Lee". (PNA)
