# Cavite town sees better health care services with devolution

The local government of General Mariano Alvarez (GMA) in Cavite expects more benefits, including health care services, through devolution of government functions.

In June 2021, President Rodrigo Roa Duterte signed Executive Order (EO) 138 mandating the transfer of certain functions from the national government to Local Government Units (LGUs).

This is in connection with the Supreme Court's landmark Mandanas-Garcia decision, which will increase local governments' share in national taxes beginning next year.

With the impending government decentralization, the national government delegates programs and

is among the beneficiaries who are set to move into the new housing units constructed under SHFC's Vertical Community Mortgage Program (CMP) modality.

The construction of the P883-million project started in December 2019 and is expected to be completed by March 2022. Ciudad de Strike is composed of 20 three-story buildings, accommodating 72 families each. Every household will occupy a 24-square meter unit with a room for a loft. This is a far cry from the illegal shanties and makeshift dwellings along the waterways of Bacoor that they previously lived in.

"We are extremely happy that SHFC became an instrument to make your dreams of having your own home come true," SHFC President Atty. Arnolfo Ricardo Cabling said in his speech. "We hope that every beneficiary will treasure and strive to maintain these beautiful housing units." He also expressed hope that the project will inspire other local government units in working with SHFC in providing safe, decent, and affordable housing for low-income Filipinos.

Department of Human Settlements and Urban Development Sec. Eduardo del Rosario also attended the ceremony, along with Bacoor Mayor Lani Mercado-Revilla and Cavite 2nd District Cong. Strike Revilla. The CMP aims to improve the living conditions of underprivileged families by giving them an affordable financing scheme wherein they can borrow as a community to buy the land they occupy or would like to relocate to. To date, it has provided security of tenure to about 380,000 families through approximately P18.8 billion in loan assistance.

ment of Health Undersecre- tine in Cavite and has retary Maria Rosario Vergeire said Monday. The patient had travel history to Egypt.

According to Vergeire, the patient underwent isolation in Cebu until December 16 after testing positive for COVID-19 on December 5. The patient, who is asymptomatic, is now undergoing home quarantine in Cavite.

The results of the latest batch of genome sequencing were released on Saturday. The patient was tested again on Sunday and his test yielded a negative result.

"The case is currently finishing his home quaranmained to be asymptomatic since arrival," Vergeire said.

Authorities identified three close contacts of the individual. Vergeire said all underwent home quarantine and tested negative for COVID-19.

Last week, health authorities detected the country's first two cases of the heavily-mutated Omicron variant, which has been classified as being "of concern" by the World Health Organization. Early studies suggest that Omicron is more transmissible than the Delta variant.

project, titled, "Employing Hydroponics and Vegetable Gardening Technologies to Alleviate Covid-19 Threats to Food Security in Selected Municipalities in Region IV-A," is being led by Director Fernando E. Ablaza of the Provincial Science and Technology Center-Rizal.

The project has two sites—General Trias, Cavite, and Angono, Rizal.

It is part of the Galing-PCAARRD Kontra Covid-19 Program- Component 3—Pagkain at Kabuhayan sa Pamayanan.

According to Jazzner de Dios, program manager of Bukid Kabataan Center, besides the children-beneficiaries in General Trias, Cavite, around 10,000 malnourished and hungry children in Metro Manila will also benefit from the project.

He said during the recent DOST IV-A's Greenhouse Launching at Bukid Kabataan Center in General Trias, Cavite, that their main objective is to use less manpower, less inputs, and less space to grow more vegetables for the communities.

According to DOST IV-A Regional Director Emelita P. Bagsit, the project is timely because agricultural lands are diminishing due to their conversion into other purposes, such as subdivisions and shopping malls.

In a small space with just one greenhouse, 7,000 lettuce seedlings can already be grown through hydroponics technology, Bagsit said.

The greenhouse will be managed by two persons only, unlike in conventional more farmers are needed to This also underscores

take care of 7,000 seedlings. The improved greenhouse design, local materials, hydroponics technology and vegetable seeds were made possible through the DOST-PCAARRD-funded projects led by Central Luzon State University (CLSU) Professor Dr. Chito F. Sace.

Sace emphasized that the greenhouse design and the hydroponics technology are products of his research at CLSU which is funded by DOST-PCAARRD and Taiwan Agricultural Research Institute. He said that DOST-PCAARRD funded a total of three projects to establish demo farms at CLSU, where he showcased his studies on greenhouses, hydroponics, and aquaponics.

DOST-PCAARRD and CLSU also held several training courses on hydroponics for different institutions in the country to promote the adoption of the technology.

DOST-PCAARRD Executive Director Reynaldo V. Ebora thanked and congratulated DOST IV-A for its patience and determination despite the constraints brought about by COViD-19 pandemic.

He said that establishing the greenhouse structures and the procurement procedures may not been easy, but with their diligence, these became possible.

Before the end of the project, two more greenhouses with hydroponics and aquaponics technologies will be completed and used for growing different kinds of vegetables.

Torres said while the municipality has already-existing healthcare facilities, the lack of health care personnel remains to be the LGU's key concern as she foresees a major challenge in the next three years of the devolution transition period.

"Meron na tayong existing na building for the [health] cluster, health facilities, yun nga lang, yung personnel... kulang na kulang kami in terms of health services. (We already have healthcare facilities. However, we are short on personnel in terms of health services)," she said.

She said the big challenge is if the LGUs can implement the devolution effectively and with quality.

GMA also intends to establish local finance and economic enterprise that will serve as an additional funding source and expand the scope of social services to reach more sectors.

Despite the lack of personnel, she said the town will find ways to achieve quality service to its constituents.

# Prov'l gov't, PCG send food, water to Bohol island villages

The provincial government of Bohol and the Philippine Coast Guard (PCG) on Tuesday delivered tons of food, water, and clothes to the island villages cut off from the mainland due to Typhoon Odette.

Governor Arthur Yap, in a presser before boarding the Philippine Coast Guard vessel "Tubattaha", said they targeted to deliver the relief assistance to 16 villages in two coastal towns.

He stressed the need to rush the distribution, considering that islanders have had no food and water since Thursday when the typhoon hit the province.

"Their situation is so bad. Imagine that they are living on an island that has no more fishing boats or outriggers, no more fishing equipment after being destroyed by the typhoon. Their houses were destroyed and yet they have no food, no water, and the mainland could not give them water because there is no power," Yap told reporters in Filipino.

The relief effort on Tuesday will benefit residents in eight island barangays of Talibon town and another eight in Getafe, while other islets will be visited on Wednesday.

Yap said the province needs more food packs from the Department of Social Welfare and Development for distribution to the island barangays while the situation is yet to nor-

ment of Environment and Natural Resources for clearing secondary roads. Yap said Bohol's main arterial highways have only one lane passable because of the presence of fallen debris, electric posts, and trees.

The governor also asked the Department of Energy to authorize the doubling of delivery allocation of fuel for Bohol, pointing out long queues in gasoline stations.

Likewise, he appealed to the Department of Trade and Industry to mobilize its consumer protection unit to impose a price freeze on basic commodities, including gasoline and diesel which are now being sold by unscrupulous individuals at much higher prices. Yap also requested the Department of Information and Communications Technology to send a satellite phone to ensure continued connectivity, as he called on major telecommunication companies to fast-track the restoration of their connection lines.

"Two days ago, I was able to talk to only 21 out of 48 mayors because of lack of signal. I am asking the mayors to conduct rapid damage assessment because the National Housing Authority can give assistance of PHP25,000 to PHP30,000," he said. (PNA)

# Institutions, establishments can't refuse PhilSys ID: PSA

The Philippine Identification (PhilID) or national ID must be honored in all public and private transactions requiring the confirmation of the identity of the holder.

The Philippine Statistics Authority (PSA) stressed this anew after continuous reports that some private companies and government agencies refuse to recognize the PhilID.

"Your Philsys national identification card is valid and can be used for any legal transactions. This is a memo from the Philippine Identification System of the Philippine Statistics Authority that mandates that your PhilSys national ID should be accepted for customer identification and verification in any bank transactions in the Philippines. No institutions or establishments should refuse your PhilSys national ID card or they will be penalized," the PSA posted on December 13.

PSA has also been issuing repeated reminders to government agencies and private entities to accept the Phi-IID in transactions or they will be penalized by as much as PHP500,000 under the PhilSys Act.

PhilSys-registered Jebon Ontua, a resident here, is confident she will be able to use the PhilID in all her transactions.

"I registered for the national ID because according to the government, it is a valid ID and I can use it for many transactions. I already completed Steps 1 and 2. I will just wait for the arrival of my PhilID card," Ontua said in the vernacular in an interview.

She will apply for a passport once her PhilID card arrives. The Department of Foreign Affairs earlier confirmed it is honoring the national ID in passport applications.

# DA gives seeds to 'Odette'-hit farmers in Antique

The Department of Agriculture (DA) in this province has given the go-signal to distribute 600 bags of certified seeds as replanting materials to farmers in the wake of Typhoon Odette's devastation.

Arlene De Los Reyes, Office of the Provincial Agriculture (OPA) seed coordinator, said in an interview on Wednesday that farmers in the Municipality of Sebaste through their Municipal Agriculture Office (MAO) have received 70 bags of certified seeds.

"We have an initial 600 bags of certified seeds from DA Regional Office 6 (Western Visayas) to be distributed to the farmers," she said.

She said the certified seeds, supposedly buffer stock before the onslaught of the typhoon, will now be used to assist the farmers.

On Thursday, the Municipality of Hamtic will also be getting 60 bags of certified seeds from their warehouse in Barangay Badiang here, De Los Reyes said.

"For every hectare of rice field damaged, a farmer is given one bag of 30 kilos seeds," she added.

The farmers could also request replanting materials through the Rice Competitiveness Enhancement Fund (RCEF), to help bring down the cost of rice production

Meanwhile, OPA planning officer II Serafin Yanga said as of their latest report, the agri-fishery damage due to Typhoon Odette has now reached PHP143 million with the rice farmers absorbing the biggest damage in the amount of PHP68 million.

"There were 2,171 rice farmers who had been affected from the 16 municipalities that had already reported," he said.

The OPA is still waiting for a damage report from the towns of Libertad and Caluya to complete the 18 towns of the province.

He also said the total affected area is 1,711.32 hectares with Hamtic incurring the biggest damage on 170.8 hectares of rice fields.

Other damages incurred due to the typhoon were on fisheries at PHP58 million with 1,896 fishermen affected; high-value crops at PHP14 million with 827 farmers affected; and corn at PHP2 million with 80 farmers affected.(PNA)

Odette. Signed into law by President Rodrigo R. Duterte in August 2018, Republic Act 11055, or the Philippine Identification System Act, aims to establish a single national ID for all Filipinos and resident aliens.

The national ID shall be a valid proof of identity that shall be a means of simplifying public and private transactions, enrollment in schools, and the opening of bank accounts.

It also seeks to boost efficiency, especially in dealing with government agencies where people will only need to present one ID during transactions. (PNA)

# Airline joins relief ops for Cebu, other 'Odette'-hit areas

Another airline has partnered with the government and various organizations to boost relief operations by transporting essential goods to provinces badly hit by Typhoon Odette last week.

AirAsia Philippines has already airlifted more than 20 tons of items since December 17.

"Although we are faced with a lot of challenges, especially our crew who were also affected by the typhoon, we continue to soldier on to ensure that we continue to service our guests the best possible way during the peak season," company spokesperson Steve Dailisan said in a statement.

Post-typhoon, the airline has re-strategized flight routes and communications with local government units and airports for the speedy restart of flight operations.

All its domestic flight routes fully resumed on Monday, with the exception of Puerto Princesa in Pala-

wan, as on-ground communications continue to be a challenge in the province following the impact of the typhoon.

"Odette" made landfall in Roxas town on Friday, one of nine by the strongest weather disturbance to hit the country this year.

From December 16 to 19, a total of 198 of the airline's domestic flights were canceled or postponed, affecting an estimated 30,000 passengers.

AirAsia also mounted two recovery flights from Manila to Cebu on Sunday, catering to almost 1,000 passengers.

Guests affected by flight delays and cancellations from Manila to Puerto Princesa City may also avail of a recovery flight to the province on Thursday, December 23, the airline announced.

Help desks are available in local airports such as those in Mactan in Cebu, Puerto Princesa, and Bohol province. (PNA)
