Remulla cautions against Christmas parties, mass gatherings

The provincial government of Cavite on Wednesday (Dec. 2) warned the public against joining mass gatherings, such as Christmas parties, amid the coronavirus pandemic.

In an advisory released Wednesday morning, Gov. Jonvic Remulla said while the daily infection rate is declining in Cavite, a second wave of COVID-19 infection is still possible.

"Bawal pa rin yang mga beso beso, sayaw-sayaw, party-party, fiesta mentality, boodle fights. Lalong-lalo na ang pakikipagkamayan sa mga tao (Greeting a person with a kiss on the cheek, dancing, parties, fiesta mentality, and boodle fights are still prohibited. Handshakes

Cavite scrutinizes partner's financial power to build Sangley airport

The Cavite government is already evaluating the final submission of a China-backed consortium for the proposed Sangley Point International Airport (SPIA) project, according to Gov. Jonvic Remulla.

The review was meant to ensure the strength of their joint venture for a new air gateway that would eventually rival Manila's Ninoy Aquino International Airport (Naia).

"The country has a long history of failed joint venture agreements," Remulla told the Inquirer, adding the local government would ensure "all compliance issues are addressed."

The Cavite government's Public Private Partnership office would review the ownership structure and equity sourcing, among others. "There has to be substantial equity on the in-

Cavite lifts liquor ban, allows minors in malls

CAVITE – Despite the province still being under modified general community quarantine (MGCQ) for the month of December, the local government unit has eased some guidelines meant to curb the spread of coronavirus disease (COVID-19).

On Wednesday (December 2), Governor Jonvic Remulla announced that minors are now allowed to go to malls within the province as

long as they are accompanied by their guardians. Just like their adult companions, the minors are required to wear face masks and face shields when going out of the house.

Mall operations are extended until 9 p.m. this month, with an 8:30 p.m. cut-off for customers coming in. Aside from eased mall guidelines, Remulla also an-

Gatchalian mulls law on providing laptop, connectivity for every public school learner

Senator Win Gatchalian eyes introducing legislation that will give every public school learner a laptop and access to the internet.

To emphasize the urgency of this planned measure, Gatchalian pointed to a finding by assessment instruments provider Center for Educational Measurement (CEM) on the 2018 Programme for International Student Assessment (PISA), which revealed that access to computers and internet at home affects student performance.

According to CEM, around 60 percent of learners who participated in the PISA did not have access to computers and connectivity at home. The proportion of learners without computers and internet is much higher in the lower proficiency groups compared to higher proficiency



groups, CEM's analysis points out. Results of the PISA 2018 showed that out of 79 countries, the Philippines ranked lowest in Reading Comprehension and second lowest in Science and Mathematics

Gatchalian also pointed out that the COVID-19 pandemic also underscored the need to make distance learn-

SM Foundation finishes 101st school building for Tanza, Cavite

Even though face-to-face classes are still not allowed because of Covid 19, SM Prime, through SM Foundation Inc. (SMFI), formally turned over a two-story, four-classroom school building to Punta Elementary School in Tanza, Cavite on November 20.

These new classrooms are set to be utilized by Grade 2 pupils once the threat of Covid-19 subsides.

School principal Dr. Gloria Casiano said before the coronavirus pandemic, some of their classes were held in their covered court.

This SM school building will help address their room shortages and will improve their current classroom to student ratio of 1:50, Casiano said.

"We are overwhelmed and thankful to SM Foundation and SM Prime for continuing with the project despite the Covid-19 pandemic. This school building will serve as a haven in nurturing the young minds of our Puntaceño learners," she added.

The school building is the 101st built by SMFI under its School Building Program.

SMFI is an active partner of the Department of Education for its Adopt-A-School program. This social good initiative aims to promote quality public education by building classrooms nationwide.

Following the standard design of SM school buildings, the infrastructure is fully furnished, PWD-friendly and emergency-ready. Moreover, SMFI tapped the members of the Foundation of These-Abled Persons to make the teacher's desk

sets and student armchairs. Through this strategy, SMFI enables PWDs — persons with disability — to be economically self-sufficient and at the same time, highlights their valuable contribution in nation-building.

To care for the wellness of the school population, additional features were also installed, including a library hub, guidance and counselling room, and a clinic with an isolation room where pupils can be given first aid treatment or isolated at the onset of early symptoms of illness.

The SM school building also comes with a 10-faucet handwashing area that intends to promote handwashing in the community. With such features, SMFI aims to spread the culture of good hygiene and prevent the spread of harmful viruses and diseases.

A "green" space has also been created around a 50-year-old tree that stands in the campus in order to promote the culture of environmental conservation. Established in June 1937, Punta Elementary School is one of the oldest schools in the municipality.

Four tables and eight benches have been put up

around the tree to create the ideal study garden. With the green space, SMFI intends to reduce the stress of the children, enhance their mental health, concentration and environmental awareness—aside from providing the students and teachers with

an additional learning area. In addition to Punta Elementary School, the Basud Elementary School in Sorsogon City and Banisil Elementary School in General Santos are also scheduled to receive a fully furnished school building this year.

We only have a few days to go, and yet our sticker installation sites are still packing long lines, especially this last weekend before implementation on December 1. Given the surge in last-minute applications we're seeing, we don't think we will be able to serve everyone. A large number of motorists will not make it to the December 1 deadline," said Ang.

"My honest opinion is we will really need at least until February. And that is what we are asking government. To allow us to retain even just a few cash lanes until February."

He added that, despite the company's efforts to roll out additional measures to expedite the installation of opening of 100 additional sticker installation sites and implementing 24 hours installation at major locations, the volume was just too much.

Both the Autosweep and the Easytrip systems -- which cater to the expressways connected to Metro Manila -- are set to go fully contactless by December. The Autosweep tags are issued by the San Miguel Group for the Skyway, the South Luzon Expressway (SLEx), the STAR Tollway, the Tarlac-Pangasinan-La Union Expressway (TPLEx), the NAIA Expressway (NAIAx), and the Muntinlupa-Cavite Expressway (MCX).

The Easytrip System covers the North Luzon Expressway (NLEx), the Subic-Clark-Tarlac Expressway Expressway (CAVITEX), the C5 Southlink, and the Cavite-Laguna Expressway (CALAX). Under the first phase of the government's Toll Collection Interoperability Project, Autosweep tags will be readable by the Easytrip System, while the second phase will allow Easytrip RFID tags to be readable by the Autosweep System.

For its part, the DOTr said there would be no apprehensions for vehicles without RFID tags until January 11.

"As the DOTr itself said, there really is no need to panic if you are a non-regular user of expressways. Even with the scheduled implementation on December 1, motorists with no stickers will not be apprehended. Also, stickering will continue

at the toll plazas and installation sites. In fact, these will continue even after January," said Ang.

"But given that many motorists still want to get their stickers as soon as possible, I think we can still accommodate them.

Because anyway, those who have secured their stickers earlier will already realize the benefits of government's mandate, and that is convenience and added safety."

As for those that have not been able to secure their RFID, And said that nothing would be lost by providing them some consideration.

He thus hoped the government would study a possible extension carefully, though at the end of the day, "we will abide by what they say." — DVM, GMA News

ing part of the norm to avoid prolonged disruptions to education, especially in times of calamities, emergencies, and crises.

"After this pandemic, laptops and access to the internet are basic requirements to learning. No child should be left behind simply because he or she cannot have access to gadgets and the internet. That's a challenge for our government," said the Chairman of the Senate Committee on Basic Education, Arts and Culture.

"Now the basic question is 'who will pay for it?' because affordability becomes an issue and that's what we are trying to solve right now. I think there is no question that learners should have a laptop and access to the internet now, not ten or fifteen years from now. And we would like to formulate a law

wherein we will give every child, every learner a laptop and access to the internet," Gatchalian added.

Data from the Department of Education (DepEd) shows that 87 percent of more than 22 million public school learners are using self-learning modules (SLMs). DepEd admits, however, that the use of SLMs are costly and result in the buildreported that some 3.6 million learners have access to the internet while 1.9 million have laptops.

Gatchalian also pointed out that despite the availability of high-quality DepEd TV episodes online, its YouTube channel only has around 59,000 subscribers, which shows the need to reach millions more



Bong Go aids typhoon-hit communities in Cavite

to extend assistance to the victims of Typhoon Ulysses, an outreach team from the Office of Senator Christopher "Bong" Go paid a visit to the typhoon-hit towns of Kawit and Rosario in Cavite on November 26 and 27, respectively.

Five hundred beneficiary families were provided with meals, food packs, vitamins, masks and face shields during an activity held at the Tangulan Arena in Kawit. An additional given similar assistance at the Rosario National High School. Both activities were carried out in strict compliance with the health and safety protocols against COVID-19.



Emilo G. Aguinaldo. The Senator expressed confidence that the country would overcome the challenges posed by the recent series of typhoons and ongoing pandemic. As communities begin the process of rebuilding, he encouraged everyone to join in the responsibility of caring and supporting their neighbors who are facing challenges.

"Parati naming sinasabi ni Pangulo Duterte, konting tiis lang po. Basta sa abot ng aming makakaya ay tutulong kami sa inyong lahat. Mga kababayan ko, kapit lang tayo.
