HEALTH CARE ASSISTANCE PROVIDED TO THE PEOPLE OF TERNATE



delivery of quality and community-driven shelter solutions under the Community Mortgage Program (CMP), the corporation's flagship initiative.

The turnover ceremony was led by SHFC President Atty. Arnolfo Cabling and Hon. Mayor Lani Mercado-Revilla together with Bacoor Congressman Strike Revilla, Sen. Ramon 'Bong' Revilla, Jr. and Negros Occidental 3rdDistrict Congressman Francisco Benitez, vice-chairperson of the Committee on Housing and Urban Development.

Ciudad de Strike 2 Homeowners Association, Inc. is a community comprised of 20 three-storey buildings of 30-square meter units that could accommodate 72 families with a total of 1,440 underprivileged families of the city and those that were relocated from waterways and danger areas in Las Piñas and Parañaque benefitting from this project.
