The Social Security System (SSS) on Wednesday said that P178 million worth of benefits were released in 2019 under its unemployment benefit or involuntary separation insurance program, which is one of the key features of Republic Act 11199 or the Social Security Act of 2018 which took effect on March 5,

SSS President and Chief Executive Officer Aurora C. Ignacio said the pension fund received 15,151 unemployment benefit applications in 2019 of which 14,895 were approved and translated to P178 million of benefit releases. The unemployment benefit program is the newest among the benefits being offered by SSS which allows qualified SSS members who are involuntarily separated from work to claim for a cash allowance equivalent to two times his average monthly

Rationale:

The Global Innovation Index (GII) aims to capture the multi-dimensional facets of innovation and provide the tools that can assist in tailoring policies to promote long-term output growth, improved productivity, and job growth. The GII helps to create an environment in which innovation factors are continually evaluated. It provides a key tool and a rich database of detailed metrics for economies, which in 2019 encompasses 129 economies. Over the last years, the GII has established itself as a leading reference on innovation. Understanding in more detail the human aspects behind innovation is essential for the design of policies that help promote economic development and richer innovation-prone environments locally.

Recognizing the key role of innovation as a driver of economic growth and prosperity, and the need for a broad horizontal vision of innovation applicable to developed and emerging economies, the GII includes indicators that go beyond the traditional measures of innovation such as the level of research and development. (https://www.globalinnovationindex.org)

Based on the GII Report 2019, the Philippines rank 54, marking the biggest leap among Southeast Asian countries. Overall, the Philippines scored 36.18 points out of 100. However, despite the improvement on the ranks, the Philippines presents a number of weak areas, which are concentrated in the innovation input side.

These include ease of starting a business, ease of getting credit, expenditure on education. Also, Scientific and technical articles and new businesses are relatively weak on the innovation output side.

Thus, the Department of Science and Technology (DOST) through the Technology Application and Promotion Institute (TAPI) in cooperation with the World Intellectual Property Organization (WIPO) will conduct the Technical Meeting and High Level Conference on Global Innovation Index in the Philippines with the key government agencies in the country to discuss future plans on how to move-up and sustain the momentum and ensuring all government approaches are towards the improvement of the Philippine rank.

- (2) To ensure that all government approaches are moving up towards the improvement of the Philippine rank;

salary credit. Since its implementation in August 2019, the bulk of the unemployment benefit applications were received in October with 4,596 approved applications which corresponded to P54.61 million released to qualified members.

"We are hoping that with the newest benefit, we will help more SSS members during times of unexpected job loss. The program was patterned after the unemployment benefit program in European countries. Our primary objective is to assist them while they are looking for another job after they were involuntarily separated from their work. They may also use the benefit for their retooling and capacity building to find a better job or work that will suit their skills, 'Ignacio said.

To qualify for unem-

ployment benefit, members must not be more than 60 years old at the time of involuntary separation, except for underground and surface mineworkers, and racehorse jockeys whose age should not be more than 50 and 55 years old, respectively.

"The unemployment benefit can be claimed only once every three years starting from the date of involuntary separation from work.

If two or more compensable contingencies occurred within the same period, SSS will only pay the highest benefit from the recorded contingencies. They are given one year from the time of their separation to file for their benefit claim," Ignacio added.

Member-applicant must have paid at least 36 monthly contributions, wherein 12 months of those should have been paid within the 18-month period prior to

separation. Ignacio reminded unemployment benefit applicants that to qualify for the benefit, the reason for separation should be any of labor-saving devices; redundancy; retrenchment; closure or cessation of operation; and disease or illnessof the employee whose continued employment is prohibited by law or is prejudicial to his or her co-employee's health.

Further, separation from employment because of employee's serious misconduct, willful disobedience to lawful orders, gross and habitual neglect of duties, fraud or willful breach of trust, commission of a crime or offense and analogous cases like abandonment, gross inefficiency, and disloyalty/conflict of interest will not qualify the employee to receive the unemployment benefit.

Applicants are required to submit a DOLE-issued certification establishing the nature and date of involun-

Aside from the governthe following: installation of ment-issued documents, applicants should present an original and photocopy of one primary ID card or document or in the absence of which, any two ID cards or documents, both with signature and at least one with photo at any SSS local branch or foreign office.

> As of now, the benefit will be credited to the savings account under the member's UMID card enrolled as ATM or Union Bank of Philippines (UBP) Quick Card. If the member has no UMID card enrolled as ATM or UBP Quick Card, the member will be instructed by the branch to open or avail of the UBP Quick Card to have their benefit automatically credited to their savings account and can be availed thru UBP Kiosks in selected SSS branches nationwide.

PSWD0 conducts drive for cyber safety

Cavite Provincial Social Welfare and Development Office (PSWDO) thru the Provincial Council for the Protection of Children (PCPC) in partnership with the Inter-Agency Council Against Trafficking (IACAT) IV-A and in coordination with the Department of Education conducted another Orientation on Anti-Child Pornography Act of 2008 on February 10, 2020 at the Cavite Provincial Gymnasium in Trece Martires City. With the theme "Cyber Safety is my Responsibility", the orientation aims to provide knowledge on the safe usage of internet and protect the youth against child pornography and on-line sexual exploitation. Discussion on RA 9775 or the Anti Child Pornography Act was facilitated this time by Ms. Mary Joy Santorio, Social Worker, PSWDO. Among the participants were students from Trece Martires City including the 80 pupils and five teachers from Krislizz International Academy, and 50 students, 20 parents and two coordinators from the Alternative Learning System. The program which was initiated last year focused on the advocacy campaign on the protection and rights of children. Film showing was presented which awaken the minds of the partakers to be conscious of the risk brought about by internet/social media if not used properly. After the orientation proper, the students shared their insights on what they have learned during the gathering. Cavite Provincial Government releases financial assistance to ASF-affected hog raisers



Hog raisers in the City of Bacoor who were affected by the African Swine Fever (ASF) received financial assistance from the Provincial Government of Cavite in the distribution held on February 11, 2020 at the Revilla Hall of Bacoor Government Center. Mayor Lani Mercado-Revilla witnessed the distribution together with Mr. Richard Quion, City Disaster Risk Reduction and Management Officer and Dr. Ella Mae Gandia of the City Veterinary Services Office. The mayor thanked the provincial government for the assistance to her constituents.

Following the African Swine Fever (ASF) epidemic that hit the province of Cavite late last year, the provincial government has distributed more than eleven million pesos worth of financial assistance to the 530 hog raisers affected. The first batch was released on February 11, 2020 for the 106 beneficiaries in the City of Bacoor in the distribution witnessed by City Mayor

Lani Mercado-Revilla, Mr. Richard Quion, City Disaster Risk Reduction and Management Officer and Dr. Ella Mae Gandia of the City Veterinary Services Office.

Cavite was hit by the African Swine Fever (ASF) late last year affecting its small hog industries. The PDRRMO and the Provincial Veterinary Office (PVO) conducted Pre-Disaster Risk Assessment and confirmed cases of ASF in the cities of Bacoor, Dasmariñas, Imus and Gen. Trias.

To prevent the further spread of the virus, additional Quarantine Checkpoints were stationed in entry and exit points in the province along with other epidemic interventions in the affected swine farms.

Governor Jonvic Remulla sought the aid of the legislative body for the passage of

CONTINUOUSLY SERVING THE PEOPLE THRU MEDICAL AND DENTAL MISSION



More than 300 locals of Brgy. Sabutan in the municipality of Silang benefitted from the medical and dental mission sponsored by the provincial government of Cavite as requested by 5th District Board Member Ivee Jane Reyes conducted on February 11, 2020. A total of 303 patients were treated by the medical staff from Gen. Emilio Aguinaldo Memorial Hospital while some 36 dental patients underwent tooth extraction.

The health activity was made possible with the initiative of OPG-Extension in cooperation with the Provincial Health Office and with the assistance of barangay officials, health workers, nutrition scholars and the officers of Brgy. Sabutan Senior Citizens Affairs Association. Punong Barangay Rodel R. Dacara together with the residents thanked the mission team for providing health assistance and some medicines and vitamins for their barangay. --- (PICAD)

Sangguniang Panlalawigan Resolution No. 1352-2019 declaring the province under State of Calamity on November 13, 2019 and authorizing the release of quick response fund to address the ASF and mitigate its impact.

Hogs affected by the virus and those within the one-kilometer radius were culled and buried as a standard protocol enforced by the Department of Agriculture. The financial assistance from the provincial government

was intended help small hog raisers recover from the losses brought by the ASF and is separate from the assistance from the national and local government. The amount of financial assistance which will be given to hog raisers is computed based on the number of pigs affected, each equivalent to Php 2,000.00. The PVO issued a certification which determines how much each beneficiary is entitled to receive.

Leading the distribution

of financial assistance were the Provincial Social Welfare and Development Office and Provincial Treasurer's Office in coordination with the local veterinary offices, DRRMs and city social welfare offices.

The second wave of financial assistance distribution was done on February 12, 2020 in the Cities of Imus with 32 beneficiaries, Dasmariñas with 273 affected hog raisers and Gen. Trias with 114 recipients.
