red, the Marcoses' traditional political campaign color, the Remullas endured the heat with Marcos all day long from Tanza, General Trias City, up to Imus.

"Categorically, we're together. I'm campaigning for him. We'll make all efforts to make him win," Remulla told journalists in General Trias City. He also promised to foot the bill for all of Bongbong's campaign sorties in Cavite, as well as the support of all mayors aligned with Cavite's current ruling family.

But the biggest of all promises the governor made is to make Marcos win by 800,000 votes in Cavite - the second most vote-rich province with 2.15 million registered voters.

Marcos defeated rival Vice President Leni Robredo in Cavite by 150,000 votes in the 2016 polls. He carried all towns and cities, except Alfonso and Carmona.

When asked how he plans to fulfill his promise, Remulla pointed to their internal surveys where Marcos' latest rating is at 64%. "The next one is Senator Ping (Lacson) and Vice President Leni (Robredo) and his lead is really overwhelming. It is by almost 50%," he said. "Marcos country talaga ito eh (Cavite is really a Marcos country)." he added.

The Marcoses and Remullas go way back.

Jonvic's father, the late Cavite governor Johnny Remulla, was a close ally of the late dictator Ferdinand Marcos. The governor said the Remullas have always supported the Marcoses whenever they seek national

"Every time na tumatakbo ang Marcos sa buong Pilipinas, (Senator) Imee, BBM, laging overwhelming sila rito. 2016 tumakbo siyang (Bongbong Marcos) vice president, panalo siya rito," Remulla said.

[Translation: Every time a Marcos is running for a national post, Senator Imee, BBM, they always win overwhelmingly here. When he ran for vice president in

2016, he won here.] Despite his support for Marcos' presidential bid, the Cavite governor said he and his province mate Lacson are still "very good friends." Remulla is a member of the National Unity Party (NUP), which is allied with Lacson's Partido Reforma. He said NUP leaders gave them the freedom to choose whoever they want to support in the May polls.

"The senator and I had a good talk and I explained things to him," he said. "Our relationship is great. In fact, he texted last night. He was thanking me for all the help, I was thanking him for all the friendship and service to my father. There's no acrimony between the senator and I."

Cavite is known as Lacson's bailiwick. He grew up in Imus City. He also carried the province - and the only one in the country - during his first presidential run in

SMC formally inaugurates << P1

Thankfully new projects like this one could ease the pain of commuters and travelers who have to use SLEX regularly. Today, San Miguel Corporation (SMC) formally inaugurated the SLEX Elevated Extension project, a P14 billion expressway that wil hopefully alleviate traffic in this part of the metro. President Rodrigo Duterte led the opening rites with SMC president and chief executive officer Ramon S. Ang.

You might recall that back in December 2021, a portion of the SLEX Elevated Extension was already opened to the public. The press release reads: "The four-kilometer, two-laned southbound alignment of the project was soft-opened to the public in early December, effectively connecting the Skyway in Sucat to SLEX at Susanna Heights in Muntinlupa, bypassing the Alabang viaduct, while improving direct access to both

the Alabang area and the Alabang-Zapote Road."

The full project will span 19 kilometers, and will address the ever-increasing volume of cars on Metro Manila roads, as well as the perenially bottlenecked Alabang viaduct. Together, the northbound and southbound lanes of the SLEX Elevated Extension project can accommodate 200,000 cars per day.

"Since we soft-opened the southbound SLEX Extension last December 10, motorists in the south have seen a major improvement in the traffic situation. It has provided relief to thousands of motorists who go home every day to Muntinlupa, Las Piñas, Cavite, Laguna, and Batangas. With both the southbound and northbound section of the SLEX Extension now fully operational, travel to and from the south is easier and faster than ever," said Ang.

well as in the National Capital Region, have dropped below 10%.

"The positivity rates in NCR and Calabarzon continued to fall as all provinces had less than 10% positivity rate as of February 15," he said.

OCTA earlier classified NCR as low risk for COVID-19 transmission. The independent monitoring group said the region may slide down to "very low risk" classification by March.

Among Calabarzon provinces, David said Quezon "is very close to being the first province under very low risk classification."

Based on OCTA's data, NCR has a positivity rate of 7% as of February 15, while Batangas has 10%, Cavite has 9%, Laguna and Rizal have 8%, and Quezon has 4%.

As for reproduction rate, NCR has 0.19, Batangas 0.25, Cavite 0.20, Laguna and Quezon 0.19, and Rizal 0.18.

Reproduction number refers to the number of people infected by one case. A reproduction number below 1 indicates that the transmission of the virus is slowing down.

Meanwhile, for average daily attack rate, the NCR has the highest with 3.57 while Quezon has the lowest at 0.79.

On Tuesday, the Department of Health (DOH) logged the lowest daily COVID-19 tally this year with 2,010 new infections, bringing the nationwide cases to 3,641,940. Total active cases, meanwhile, stood at 72,305, of which 1,498 were asymptomatic, 66,093 were mild, 2,961 were moderate, 1,441 were severe, and 312 were critical.

drigo Duterte. The full completion of the SLEX Elevated Extension project is seen to help boost economic growth in Metro Manila as well as its surrounding provinces. It is also expected to ease traffic, and give motorists faster travel time.

"We welcome this infrastructure development at a time when our economy is slowly opening up and recovering from the effects of the Covid-19 pandemic," Duterte said during the inauguration ceremony held at the Alabang Northbound Entry in Alabang, Muntinlupa City.

The Skyway northbound section of the SLEX Elevated Extension was opened to motorists last April 2021. The said section allows motorists to reach the North Luzon Expressway (NLEX) in 25 to 30 minutes instead of the usual travel time of two to three hours. It runs from Susana Heights to Sucat, giving easier access for motorists coming from Laguna or Batangas to get onto the Skyway.

Meanwhile, the Skyway southbound section of the SLEX Elevated Extension opened last December 2021. It has two lanes that run from the Skyway Main Toll Plaza to Soldier's Hills in Muntinlupa. Motorists should keep right or use the right-most pass-thru toll plaza to access the southbound elevated expressway. San Miguel Corporation (SMC) president Ramon Ang said the southbound section of the SLEX

Extension has provided faster travel for motorists bound to Muntinlupa, Las Piñas, Cavite, Laguna, and Batangas. "Since we soft-opened

the southbound SLEX Extension last December 10, 2021 motorists in the south have seen a major improvement in the traffic situation. It has

Sen. Joel "TESDAMAN" Villanueva visited the Technical Education and Skills Development Authority (TESDA) offices on Monday, to mark Valentine's Day with the renewal of his barista National Certificate.

The Chair of the Senate Committee on Labor, Employment, and Human Resource Development said that his National Certificate II (NC II) renewal is a way for him to "walk the talk" and emphasize how important technical-vocational education is for the country. When he was TESDA Director General, Villanueva himself issued the directive to have NCs renewed every five years to ensure up-to-date training and upskilling. "Tech-voc upskilling is essential in the National Employment Recovery Strategy (NERS), which

should be institutionalized and expanded through tech-voc," the senator said. Villanueva said that TESDA National Certifications embody his reelection platform of job opportunity and security.

"National Certifications create job opportunities and secure livelihoods. The promise of tech-voc education is the certainty of employability, and it's a promise that we in government should deliver," he said.

The senator said that his certificate renewal is part of the continuing effort to erase the social stigma against tech-voc courses. "TESDA's tech-voc quality education is laser-focused towards employment. It is one of the best ways we are tightening the jobskills mismatch, and is flexible enough to cater to ever-changing demands of the job market," he said.

Villanueva noted that TESDA initiatives such as TESDA Online Program (TOP) and the "TESDA Abot Lahat ang OFWs" program are examples of how the country's tech-voc education has kept up with the times. The TOP offers online tech-voc courses, while the OFW-centric program focuses on upskilling and retooling repatriated OFWs and their dependents, both seeing renewed success during the pandemic period.

CHIZ TO DOH: MAKE SURE CANCER **FUND GOES TO CANCER AID**

Two years after the National Integrated Cancer Control Act (Republic Act 11215) was signed into law on February 14, the national government must ensure that the promised financial aid for cancer patients is easily accessible to all who need it, Sorsogon Gov. Chiz Escudero said.

The former senator said the Department of Health (DOH) should facilitate the release of the P529.20 million Cancer Assistance Fund to cover the cost of cancer treatment and its care-related components such as diagnostics and laboratories.

"Dalawang taon na tayong nakatutok sa COVID-19 ngunit huwag nating kalimutan na ang kanser ay nananatiling isa sa mga pangunahing dahilan ng pagkamatay ng mga Pilipino. Ngayong pandemya, lalong humirap at lumala ang kondisyon nga mga may kanser dahil sa kakulangan ng mga ospital na kaya silang tanggapin sa gitna ng pandemya," said Escudero, who is seeking a Senate comeback.

From January to October 2021, cancer was the fourth leading cause of death in the Philippines, following ischemic heart diseases, cerebrovascular diseases, and deaths due to COVID-19 virus identified, according to the Philippine Statistics Authority.

In 2020, cancer was the second leading cause of mortality. Escudero noted that the condition of people with cancer who contract COVID-19 was 16 times more critical than COVID-19 patients without cancer, as reported by the Cancer Coalition of the Philippines. "While we continue to live with an extended health crisis, we cannot ignore the urgent needs of cancer patients and their caregivers, some of whom have lost their jobs because of the pandemic. Aside from the Cancer Assistance Fund, P786.956 million has been allocated for the government's Cancer Control Program in the 2022 General Appropriations Act. This amount is exclusively for the procurement of medicines for cancer, including supportive and palliative care drugs.

The GAA also allotted P33.68 million for the Philippine Cancer Center, which is mandated to lead and support cancer research, train medical professionals, and keep the population-based cancer registry.

Lacson-Sotto tandem to discuss senatorial lineup

Sen. Panfilo "Ping" Lacson and his running mate Senate President Vicente "Tito" Sotto III are set to talk about their senatorial lineup Tuesday afternoon.

The tandem also debunked rumors that they have dropped former Vice President Jojo Binay and Sen. Richard Gordon from the tandem's senatorial slate, with Sotto saying that the two are not among the 11 candidates whom they are endorsing so far.

"SP (Senate President) Sotto and I are meeting this afternoon. We need to discuss in detail many issues, including the matter of endorsing senatorial candidates. We will be guided by a gentlemen's agreement that is very simple and clear," Lacson told Philstar.com over Viber.

He clarified that they did not drop nor remove Binay or Gordon from their lineup.

"Not true at all that we are dropping much less have removed ex-VP Binay and Sen Gordon from our slate. As far as SP Sotto and I are concerned, they are gentlemen enough to stick to our agreement. We are as well," Lacson said.

Sotto separately confirmed that the two were not removed.

"We are endorsing 11 so far. [There is] room for one more," he told Philstar.com over Viber.

In a separate statement, Sotto explained that Gordon and Binay are not part of their senatorial lineup yet, adding that they will have to discuss who will complete their "Magic 12."

Asked by Philstar.com on whom they are eyeing as the 12th senatorial bet, Sotto answered: "[Ex-]VP Binay."

Last week, the tandem dropped Sen. Sherwin "Win" Gatchalian from their slate

after the lawmaker endorsed the late dictator's son Ferdinand "Bongbong" Marcos for president and his running mate Davao City Mayor Sara Duterte-Carpio for vice pres-

Former Quezon City Mayor Herbert "Bistek" Bautista was also removed from the tandem's slate after he asked for permission to represent the National People's Coalition (NPC) in the Mar-

cos-Duterte "Uniteam". Sotto chairs the NPC. The Lacson-Sotto tandem are pushing for good governance and an administration free from corruption, which have been long part of their advocacies.

They officially launched their presidential and vice presidential bids at Imus, Cavite, the hometown of Lacson on February 8, the start of campaign season for

Eleazar vows to empower senior citizens through jobs, provide them with healthcare

Former Philippine National Police (PNP) chief Police General Guillermo Lorenzo Eleazar, who is running for senator in the May 9 elections, emphasized the need for a support system for the senior citizens during a meet and greet in Tanza, Cavite on Monday, February

Eleazar vowed to empower senior citizens by ensuring job opportunities for those who are still fit to work and that they would be provided with support for their health and basic needs from the national government.

He said he would push to give equal job opportunities for senior citizens, citing a news report about a senior citizen who applied and was later hired to work as a call center agent.

"Lubos tayong nagagalak sa kaunting oras na nakasama natin ang ilang senior citizens sa Tanza, Cavite. Sa pamamagitan ng pagbisitang ito, mas lalo akong nag-asam na isama sa aking mga isusulong sa Senado ang

Eleazar has been advocating to bring doctors and medicines closer to the people through a regular barangay medical visitation especially in far-flung areas for the check-up and the downloading of basic medicines and maintenance especially for senior citizens and persons with disabilities

He argued that since some senior citizens and PWDs, especially from remote areas, could not easily travel for their medical needs, the solution is for the government to bring the basic health care needs for them in order for them to feel that they are not neglected and deprived of basic health services from the government.
