The Commission on Elections (Comelec) said the Final Testing and Sealing (FTS) of the 426 vote-counting machines (VCMs) to be used in the Feb. 25 special election for the representative of Cavite's 7th District was a success.

John Rex Laudiangco, Comelec spokesperson, said the machines functioned well during the FTS on Sunday. "Based on the general re-

BFAR, USAID team up to continue fight vs. illegal fishing

The Bureau of Fisheries and Aquatic Resources (BFAR) and the United States Agency for International Development (USAID) have partnered for the continuing fight against illegal fishing in Central Luzon.

BFAR 3 (Central Luzon) Director Wilfredo Cruz said on Friday that the USAID, through its Fish Right Program, engaged selected fisher folk in the region in listening sessions this week to help them understand the impact of illegal, unreported and unregulated fishing, which is a major contributor to declining fish stocks and marine habitat destruction.

Cruz said fishers from the towns of Masinloc and Subic in Zambales, and Mariveles in Bataan were involved in discussions and consultations to hear out issues and concerns in their major fishing ground.

Through the sessions, he said, the fishers' willingness to adopt harvest control strategies that can gradually reverse the deterioration of the fish population was determined.

Cruz cited the importance of the information gathered from the participating commercial fishers which, he said, would greatly contribute to reducing threats in fisheries and marine ecosystems.

At the same time, the gathered information will be essential to coming up with the best available data to develop fishery policies, he added.

"The effort further demonstrates the long-term partnership and joint strategic vision of the United

States and Philippine governments to combat illegal, unreported and unregulated fishing and enhance the well-being of Filipinos who depend on fishing for food and livelihood," Cruz said in a statement.

In October last year, the BFAR and the USAID conducted a training of trainers on the Philippine Illegal, Unreported and Unregulated (IUU) Fishing Index and Threat (I-FIT) assessment tool.

Participants were the region's law enforcement personnel, municipal agriculturists, provincial and LGU fisheries officers, technicians, and academicians who actively worked together to evaluate IUU fishing activities in their respective areas of jurisdiction.

During the workshop, the participants were trained to assess prevalence, vulnerability, and responses to IUU fishing and use the gathered information to develop targeted and focused strategies and interventions. (PNA)

PNP ready to secure gov't road projects in critical areas: Azurin

Philippine National Police (PNP) chief Gen. Rodolfo Azurin Jr. on Thursday reiterated its offer for the Department of Public Works and Highways (DPWH) to tap the police to secure workers in critical areas to ensure government infrastructure projects are uninterrupted.

"As a gesture, I am offering the services of the PNP saan man po ang mga project niyo, especially yung paggagawa niyo ng mga kalsada because we know na minsan ay naaantala ang paggawa ng kalsada because may mga area tayo dito sa Pilipinas na maraming mga nanggugulo sa kontraktor kaya kung minsan hindi matuloy tuloy ang projects (I am offering the services of the PNP wherever your road projects are because we know some projects get delayed because there are areas in the Philippines where there are people who harass contractors that sometimes lead to stalled projects)," Azurin said in a message during the inauguration and turn-over of the newly constructed forensics building, here.

DPWH-Cordillera Regional Director Khadaffy Tanggol officially turned over the PHP40 million worth of state-ofthe-art four stories building of the regional forensics group that stands on a 240 square meters land area inside the PNP's regional headquarters here. The building is the only PNP structure that has an elevator.

Azurin's offer to the DPWH is in gratitude for their support to the PNP in terms of infrastructure like the new build-

The PNP chief shared the situation at the Bangsamoro Autonomous Region for Muslim Mindanao (BARMM) where they have development concerns.

"This is one of our concerns in BARMM where development is stalled so I told the DPWH there that especially in critical areas, just let us know and our policemen will be there so that inch-by-inch of your road cementing works will have policemen in the area who will ensure that workers will not be harassed," Azurin said.

Gov. Remulla welcomes students for a learning visit

Cavite Governor Jonvic C. Remulla together with Provincial Administrator for Community Affairs Alvin Mojica welcomed the students and faculty members of University for Administration and Finances of Ludwigsburg, Germany and De La Salle - College of Saint Benilde, School of Diplomacy and Governance in a learning visit conducted at the Provincial Capitol Building, Trece Martires City on February 22, 2023.

The learning visit aimed to understand the dynamics, processes, issues, challenges and opportunities of local governance in the Philippines within the current context of COVID-19 pandemic recovery phase.

During the visit, Gov. Remulla and PA Alvin Mojica, shared a glimpse of Cavite by discussing its historical background, demographics and socio-economic profile. Likewise, local governance in the province was tackled during the dialogue.--- PICAD

Garcia: Comelec prep for village, youth polls almost done

Senators were assured on Monday by Commission on Elections (Comelec) Chairperson George Garcia that their preparations for the Oct. 30 Barangay and Sangguniang Kabataan Elections (BSKE) is almost

"As of today, we are able to print 86.59 percent of the ballots for the regular voters and as far as the Sanggunang Kabataan, we were able to print 90.62 percent of all the ballots. We are hoping to be able to print everything, all the ballots, before the end of February," Garcia told the Senate Committee on Electoral Reforms and People's Participation chaired by Senator Imee Marcos.

Garcia also reported that a total of 57,996,067 out of 66,973,949 barangay poll ballots have been printed.

As for the youth polls, he said a total of 21,422,300 out of 23,639,477 ballots have been printed.

The BSKE ballots that have been printed are for the following areas: Bangsamoro Autonomous Region in Muslim Mindanao, Caraga, Soccsksargen, Davao Region, Northern Mindanao, Zamboanga Peninsula, Eastern Visayas, Central Visayas, Western Visayas, Bicol Region, Mimaropa, Calabarzon, Cagayan Valley, Cordillera Administrative Region, and Ilocos Region.

Only the barangay ballots for two regions, Central Luzon and National Capital Region, have yet to be printed.

Meanwhile, only SK ballots from Metro Manila have yet to be printed.

Garcia, meanwhile, said they are looking to print additional official ballots in March once the Election Registration Boards (ERBs) have approved the applications submitted during the voter registration activities, which concluded last month.

"This coming March, we intend to print the ballots for the additional numbers from the recent voter registration activities," he said.

The poll body has received a total of 2,506,321 applications including new registrants, those applying for transfer of registration, reactivation among others during the resumption



of voter registration period from Dec. 12, 2022 until Jan. 31, 2023.

The applications have to be approved by the Election Registration Boards (ERBs) by conducting hearings, before an applicant can be considered regular voters and youth voters.

Each city and municipality have their own ERBs, which is composed of the city/municipal election officer, a public school official, and the local civil registrar.

Of its PHP5.7 billion approved 2023 budget, the Comelec chief said PHP1.250 billion was allotted for the construction of their building which is not enough.

Garcia estimated that they will be spending more or less an additional PHP2.8 billion which will be sourced from the Commission's

'We're going to still wait for the report of our field personnel for the project of the precincts. Doon po namin malalaman (We will know from there) if we're going to add precincts and/or ilan yung mga (how many) voters per precinct.

Before it was postponed, some PHP8.449 billion budget was approved for the conduct of BSKE to be conducted supposedly last Decem-

"We reserve the right to respectfully ask our Congress for additional budget as the need arises simply because at this point, we can just estimate but we cannot particularly pinpoint how much we're going to need simply because although there [are] additional 1.6 million registered voters from December 12 to January 31, hindi pa po sina-submit ng mga tao namin from the field kasi meron pa pong (our people from the field have not submitted yet) [the final numbers] because we will still be conducting [a] registration board hearing by March," Garcia noted saying by that time, the final number of additional registered voters and voting precincts will be determined.
