Bicol region under the State duque; Corcuera, Romblon of Calamity (SOC) following the devastation of Typhoon Tisoy in December. Members and pensioners who were residents of the said areas may now avail of the CAP as the program specifically caters to those who are placed under the SOC," Ignacio said.

"I know that most of our members and pensioners in Bicol have been waiting for this good news and we're glad to inform everyone that SSS is now ready to extend our financial assistance to them especially that they were directly affected by the said typhoon," Ignacio said.

Other areas declared under a state of calamity are Batangas City; Mabitac, Laguna; Provinces of Quezon, Cavite, Oriental Mindoro,

has recently declared areas in Occidental Mindoro, Marinand San Fernando in Romblon; and Province of Northern Samar.

> The CAP is comprised of a loan assistance program which is a separate loan window from the regular salary loan. Members can borrow up to P20,000 in calamity loan depending on the average of their monthly salary credit in the last 12 months. The financial assistance is also open to pensioners who can avail of a three-month advance pension. Moreover, members can also apply for direct housing repair and improvement loan.

> The calamity loan is payable in two years in equal monthly installments with an annual interest rate of 10 percent and a one percent penalty for late payments. To elim-

inate additional expenses on the part of member-borrowers, SSS waived the one percent service fee.

Applicants under the advance three-month pension whose present address differs from the address in the SSS database should submit a barangay certification to prove that they reside in a declared calamity area.

"Members who would like to avail of the Calamity Assistance Package are required to be registered in the My.SSS application to facilitate their billing requirements in the future," Ignacio said. The SSS Chief, however, clarified that members who still have outstanding loans under the Loan Restructuring Program (LRP) and previous CAPs, as well as those receiving pensions for total permanent disability and retirement, and those who have availed of the Pension

Loan Program (PLP) are not qualified to avail of the calamity loan.

Aside from the calamity loan, members with damaged properties can also avail of the direct house repair and Improvement loan with six months moratorium in amortization and interest payments. Members can borrow up to a maximum of P1 million under this program which will run for one (1) year or until December 19, 2020. To qualify, the applicant must not be more than 60 years old and with at least 24 monthly contributions, of which three contributions were remitted within the last 12-month period prior to the month of filing.

"Based on the latest NDRRMC Report, the onslaught of Typhoon Tisoy resulted to more than 346,000 damaged houses. This special program will

## Talaandig tribe, other indigenous groups, to benefit from DOST-FPRDI R&D program

Datu Rodelio "Waway" Saway is not called "Tatay" for nothing. A teacher at the Talaandig School of Living Traditions and a well-known performing artist, Saway has been keeping the Talaandig musical heritage intact by mentoring young members of their tribe. Community artists would always go to their Tatay Waway to learn how to play and craft their indigenous musical instruments.

"We use our traditional instruments to pray and connect with the Divine. Playing them is like opening a portal to the spiritual world," explained Saway, who has travelled the world flaunting the Talaandig's own brand of music.

"Despite the availability of tools that makes the production of bamboo musical instruments (BMI) easier, there are still issues affecting the durability of the instruments. There are times when our BMIs crack when brought to temperate countries. Some get infested by bukbok (powder-post beetle)," he noted.

Under the leadership of the DOST-Forest Products Research and Development Institute (DOST-FPRDI), a research program is now being conducted aimed at making better-quality BMIs. The initiative is in partnership with UP Diliman's Center for Ethnomusicology and the Philippine Normal University, and targets to develop technologies that can help people like Saway and other local BMI makers and users.

'We have been going around various indigenous communities and BMI production sites in the country to talk to key people and understand how important BMIs are in their local culture. We want to know how we can work together with them to improve these instruments," shared Program Leader Aralyn L. Quintos.

The R&D program seeks to develop technologies that will prolong the life of bamboo without negatively affecting the musical instruments' sound quality; standardize the production of selected BMIs; develop prototype design; analyze raw material sources and existing markets; and build a BMI processing facility.

According to Saway, long before their BMIs have been mass produced, they have been traded for other important things. He has crafted numerous BMIs, including the pulala (lip valley notch flute), tumpuy (chip-on-ledge flute), hulagteb (side-blown flute), takumbo (parallel-stringed zither) and bantula (slit drum).

## Introducing the new dehydrator machine for herbal tea materials

scientific back-up that will ner in testing the machine. ensure maximum benefits were no established protocols on material collection, drying, and brewing. Processing equipment were very limited, hence producers were unable to meet market demand.

A new dehydrator machine that efficiently dries herbal tea materials was recently developed by the Iloilo Science and Technology University (ISAT U), through the funding support of the Philippine Council for Agriculture, Aquatic, and Natural Resources Research and Development of the Department of Science and Technology (DOST-PCAARRD).

With the new dehydrator machine, tea producers in the province of Iloilo like Ephrathah Farms will now be able to increase their production capacity from the usual 0.5 kg/day to 5 kg/day at a lower energy cost. Ephrathah Farms is a producer of herbal

herbal tea used to have little gan, Iloilo and ISAT U's part- PCAARRD-funded project

According to Dr. Renerio S. Mucas of ISAT U, the dehydrator machine can efficiently dry fresh leaves of guava, moringa, guyabano, and roselle flower petals. It uses solar radiation to heat up the air that flows inside the dehydrator. The system consists of a solar heat catcher (installed outdoor) and a drying chamber fitted with 12 trays where the leaves are dried. The drying process takes place when the heated air flows through the trays containing the leaf samples. Drying takes place due to the difference in moisture concentration between the drying air and the air in the vicinity and inside of the crop surface. This drying process is known as convective heat transfer. In case of insufficient solar radiation, the dehydrator will utilize a back-up electric heater.

Dr. Mucas is an associate professor of ISAT U in

Production of local tea in Brgy. Sariri, Badian- La Paz, Iloilo City. He led the "Design and development of a programmable dehydrator machine for herbal tea materials." Aside from machine fabrication, Dr. Mucas and his team completed the phytochemical screening of the herbal tea raw materials and products, optimized the drying protocol of herbal tea materials and analyzed the shelf life of processed tea.

> Moreover, Dr. Mucas said that for optimum results, herbal tea materials should be dried at 45 °C until the desired moisture content of 8 % is obtained. At this moisture content, most of phenol content and high antioxidant activity of the tea materials are retained. Patent application for this machine has already been filed at the Intellectual Property Office of the Philippines (registration no 3-2018000623). A paper titled "Performance evaluation of a programmable dehydrator machine for herbal tea materials" was also



published in International Journal of Engineering Science and Computing (IJESC) June 2019 issue. ISAT U will continue its field testing and promotional activities. The project team is providing capability-building assistance to interested fabricators and adopters. The development of the dehydrator machine and drying protocol are expected to raise production of not only dehydrated crops but also of fishery products in the region (Romeo P. San-DOST-PCAARRD tiago, S&T Media Services).

Living at the foothills of the Kitanglad Mountain Ranges in Bukidnon, the Talaandigs create music reminiscent of the rustling of leaves and the chirping of birds. ## Pangangalaga sa taklobo sa Pilipinas, isinusulong ng programa

Ang mga taklobo ay may ginagampanang mahalagang tungkulin sa karagatan. Sila ay nagsisilbing tahanan ng mga isda, korales, at iba pang mga yamang-dagat. Ngunit dahil sa pagbabago ng klima at iba pang mga nakasisirang gawain ng tao, ang iba't ibang uri ng mga taklobo ay nanganganib nang maubos.

Upang matulungan silang maibalik sa iba't ibang parte ng Pilipinas, inilunsad ng University of the Philippines Diliman-Marine Science Institute (UPD-MSI) ang 'giant clam culture' o ang pagpaparami ng mga taklobo noong 1980s. Ang mga taklobo na ipinanganak at inalagaan hanggang sa hustong laki ay inilipat sa iba't ibang lugar sa bansa upang matulungang manumbalik ang kanilang mga lokal na populasyon.

Ang programang ito ay naglalayong muling bisitahin at suriin ang mga lugar na pinaglipatan ng mga taklobo nang malaman ang kanilang kasalukuyang kondisyon, mga uri, at bilang. Layunin din ng programang ito na mas pahusayin pa ang paraan ng pagpaparami at pag-aalaga ng mga taklobo sa 'hatchery' gamit ang mga makabagong paraang molekular.

Sa pamamagitan ng pag-aaral na ito, maaaring matuklasan ang kasalukuyang kalagayan ng mga taklobo sa iba't ibang rehiyon ng Pilipinas.
