

Mga Taong Kuntento Kung Ano at Meron Sila, Mga Kailangan sa Panahong Ito Kabi kabila ngayon ang mga sakuna, kalamidad, sunog, lindol, maramihang pagkamatay, pagkasira ng relasyon, pagkakaibigan at iba masasaklap na karanasan sa buhay.

Mga badya ito ng mga pagbabagong dapat gawin upang mapanumbalik ang masayang mundo na malayo sa kaway ng pag i imbot, mayeryalismo at kawalan ng kasiyahan. Magandang halimbawa rito ay ang buhay ni St. Basil the Great (Called the inspiration of all Eastern Monastism) One of the four greatest Eastern Doctors of the church, St. Basil was a man of learning, talent, and holiness all to an ineredibly advance degree. He came from the same brilliant family that produced Saint Gregory of Nyssa and St. Peter of sebaste (His brother) and was born at Caesarea and continued at Contantinople and Athens. He was shaken out of his Self-Satisfied attitude by Macrina, who through her appeals to Basil's Good sense and spiritual awareness, made him see the crampling limitations of a life taken up entirely by worldly activity. Basil was to be involved in other kinds of activity later in life, but this monastic foundation was probably his most important work and the one he loved the most. St. Basil the great wrote a set of rules later called the Basilian code, that became the inspiration of all Eastern Monastism. He was in the fight against heresy, Basil was closely attentive yo the other needs of his diocese. St. Basil surmounded all the difficulties, however and during his short tenure as bishop less than nine years he became the leading force in Caesarea. When he died on January 1,379 the Jews and Pagans there. As well as the Catholics were willing ti admit. That the city haf lost its best friend. Years after his death, Basil was described by a Church, Council as "the Great Basil, the Minister of grace who has expounded the truth to the whole world. "A just verdict, and one that has stood the test of time. Hence, we must be self satisfied of what we have. Especially in physical and spiritual thing. We must imitate St. Basil the great of his good sense and self awareness. We must be give ourselves to Jesus and Mary. (Definitely, we have an advisory that any fish coming from the area of Taal and Batangas should not be bought. We cannot expect its safety to our citizens.)

Should one accidentally eat fish sourced from Taal Lake and Batangas province, Laxamana said among symptoms that should be watched out for are stomach pain, vomiting, and diarrhea.

"Ngayon, kung halim-

bawa man na nagkaroon ng pagkakataon na nakakain siya o gusto n'ya talaga 'yung Tawilis na galing ng Taal Lake, meron po tayong mga symptoms," Laxamana said.

(Now, if for example there's the chance that a person ate or wants to really eat Tawilis from Taal Lake, there are symptoms to look out for.

"Kung ano po 'yung mga symptoms na mararanasan ng ating mga naka-ingest ng galing d'yan sa, baka patay na na mga isda, magkakaroon po 'yan ng sintomas kagaya ng pagsasakit ng tyan, magsusuka, magtatae. 'Yun po 'yung mga gagamutin nating sintomas," she added.

(As to the symptoms for those who may have ingested the fish from there, possibly dead fishes already, some of the symptoms include stomach ache, vomiting, and diarrhea. Those are the symptoms that need to be addressed.)

Those who will experience vomiting and diarrhea are strongly advised to rehydrate, Laxamana said.

"Ang number one na gagawin po natin is i-rehydrate po natin ang ating mga pasyente at bantayan po nating mabuti ang sitwasyon ng ating mga pasyente na nakaingest ng mga namatay na isda or may sulfur or whatever chemical or minerals na nandoon po sa isda na na-ingest," Laxamana said.

(The number one thing to do is to rehydrate and monitor patients who may have consumed dead fish or fish that has sulfur or whatever chemicals or minerals ingested by the fish.)

Taal Volcano remained under Alert Level 4, which means that "hazardous explosive eruption is possible within hours to days."

Bacoor reclamation projects draw support

BACOOR, Cavite - The proposed 420-hectare reclamation projects in Bacoor City earned overwhelming support from directly-impacted stakeholders during the public hearing conducted by the Environmental Management Bureau (EMB) of the Department of Environment and Natural Resources (DENR) on Jan. 9, which is part of the Environmental Impact Assessment System as mandated by Presidential Decree 1586 and DENR Administrative Order No. 2003-

The twin reclamation projects of the Bacoor City government are the Bacoor Reclamation and Development Project (BRDP) that consist of 320-hectare islands, and the Diamond Reclamation and Development Project (DRDP) consisting of one 100-hectare island via Public-Private Partnership under the PPP Code of Bacoor.

The city hopes to integrate in these two projects a most effective approach to the long-term clean-up of Manila Bay as mandated by a Supreme Court's (SC) con-

tinuing mandamus, being the only projects along the Manila Bay that carry with it a program for relocation and resettlement of Informal Settler Families (ISFs) living along the ten coastal barangays.

According to Bacoor City Mayor Lani M. Revilla, the proposed projects will also address flooding in the city as she made sure they are integrated with the various long-term flood mitigating projects of the Department of Public Works and Highways (DPWH).

The Flood Risk Management Project of the DPWH will improve river channels and create diversion channels from Imus to Bacoor City that will serve as the

flood discharge system of the rainwater catchment basin of Bacoor in "Buhay na Tubig."

The proposed reclamation islands are so situated and formed as to conform with the anti-flooding projects of DPWH, having more than sufficient channels in between the islands which are aligned with existing natural river outflows. The

studies conducted by the private sector partners of the city show that the islands will also serve as anti-storm surge walls of the City.

Among the sectors represented in the public hearing were the concerned barangay officials, fisherfolk, Informal Settler Families (ISFs), student leaders, mussel and oyster farmers, businessmen, environmental groups, and other concerned government agencies.

The fishermen are most satisfied with the proposed Fisherman's Village in Barangay Alima which is also part of the proposed reclamation projects in order to make sure that they will not be displaced from their industry.

The proposed projects are expected to uplift their living conditions with the establishment of the Fisherman's Wharf along Sineguelasan coasts which will also develop and preserve the 40-hectare mangroves plantation of the city.

"Sa mga sinabi po ng opisyales ng Bacoor na kami ay hindi maiiwan, bagkus ay mabibiyayaan kami po ay lubos na natutuwa at nagpapasalamat (We are very thankful for this projects because we are not left out)," said Cherielyn Espiritu, leader of the League of Modern and Responsible Women composed of female residents living along the city's coastal areas.

One of the stakeholders also expressed gratitude to the city government for holding the public hearing to address their concerns, noting they were never consulted for a similar project in the past, which is the construction of the Cavitex road.

Security Bank operations still suspended in Cavite, Batangas



The operations of Security Bank Corporation (Security Bank) remained suspended in several areas in Batangas and Cavite Thursday, as Alert Level 4 is still raised over Taal Volcano and state of calamity has been declared in the two provinces

In an advisory, the bank said the suspension covers the operations of its branches in Lemery, Lipa, Lipa-Medix, Lima, First Philippine Industrial Park-Sto. Tomas in Batangas, and Tagaytay, Cavite.

The bank advised its clients to call its 24-hour hotline at (02) 8887-91-88 for any inquiries.

"We will continue to monitor the situation to ensure the safety and protection of our employees," it added.

Taal Volcano started to spew ashes last Sunday.

In a bulletin issued 8 a.m. Thursday, the Philippine Institute of Volcanology and Seismology (Phivolcs) said Taal Volcano erupted short-lived dark gray ash plumes about 500 meters high at about 6:17 a.m. and around 800 meters high at about 6:21 a.m. Thursday.

Volcanic activity "has generally waned to weak emission of steam-laden plumes 700 meters high" but Alert Level 4 is still in effect over Taal Volcano.

"This means that hazardous explosive eruption is possible within hours to days," the bulletin added. (PNA)
