CA sides with Philracom in franchise row

The Court of Appeals (CA) has upheld its earlier ruling in favor of the Philippine Racing Commission (Philracom) and the Games and Amusements Board which ordered the Metro Manila Turf Club, Inc (MMTCI) to stop its operations last year.

In a resolution dated December 17 and written by Associate Justice Ruben Roxas, the CA said "there are no substantial matters which would warrant a reconsideration" of its earlier decision on February 19.

The CA ruled that the Mandaluyong Regional Trial Court (RTC) Branch 278 "committed grave abuse of discretion" in the case filed by MMTCI, which was no longer issued racing permits by Philracom after its franchise expired in April 2020. Mandaluyong RTC Judge Jaime Fortunato Caringal ruled in favor

CALAX traffic volume seen rising 10% during holidays; roadworks suspended



MPCALA Holdings, Inc., a subsidiary of Metro Pacific Tollways Corp. (MPTC), on Thursday said that it expects a 10% increase in vehicle volume on its expressway from Dec. 23 to Jan. 24.

The company placed the operation of the Cavite-Laguna Expressway (CALAX) "on heightened alert status to guarantee safe, secure, reliable, and convenient toll passages for travelers during the holiday rush," it said in an e-mailed statement.

The CALAX project is a 45-kilometer expressway running from Kawit, Cavite to Mamplasan Interchange in Biñan, Laguna.

"As of today, CALAX operates from Biñan, Laguna up to the east of Silang, Cavite and services about 18,000 vehicles on weekdays and experiencing a high of 32,000 on the weekends at the start of December," the company said. MPCA-LA Holdings President and

Gov't soon to abolish industrial estate in Cavite

The Governance Commission for Government Owned or Controlled Corporations (GCG) has "deactivated" state-run First Cavite Industrial Estate Inc. (FCIEI) pending its abolition since it was taking its time to settle unpaid dues to the ecozone regulator.

A memo on Dec. 21 signed by GCG ex-officio members Finance Secretary Carlos Dominguez III and Budget Officer-in-Charge Tina Rose Marie Canda, GCG Chair Samuel Dagpin Jr., and Commissioners Michael Cloribel and Marites Doral, showed FCIEI "deactivated," which means it should not enter into any contract or transaction while awaiting a for-

mal abolition. "It is in the best interest of the state to deactivate FCIEI in the interim, pending its formal abolition as recommended by the GCG to the Office of the President," GCG said.

FCIEI must thus preserve its assets while awaiting final disposition. It also cannot hire more personnel and is no longer entitled to benefits extended to government-owned and -controlled corporations (GOCCs).

It was in 2013 when

GCG recommended to then President Benigno Aquino III to abolish FCIEI, which was established in 1990 to acquire, own, lease, hold, subdivide, construct, develop, equip, operate and maintain industrial estates. It was a joint venture of the National Development Co. (NDC), Marubeni Corp. and Japan International Development Organization Inc.

Republic Act No. 10149 or the GOCC Governance Act of 2011 empowers the

GCG to rationalize GOCCs. Active firms enjoy subsidy, equity and net lending support from the national government.

President Aquino in 2016 approved in principle the abolition of FCIEI with the condition that it will settle its liabilities with the Philippine Economic Zone Authority (Peza).

Commission on Audit (COA) reports showed, however, that FCIEI "[did] not have enough money," forcing GCG to make a deal with Peza that allowed FCIEI to pay a partial P3 million to stop incurring interest charges. COA reports had also shown that FCIEI owed Peza a balance of P12.7 mil-

The GCG said FCIEI and the NDC boards in 2017 both approved to dissolve the firm, but it was only last year when its audited financial statements were prepared for liquidation purposes. INQ

As the year 2021 comes to a close, here are some of the milestones marked through the year in the prov-

In January, the local gov-

ernment units (LGUs), including Bacoor, Dasmariñas, Imus, General Trias, Carmona, Tanza, Silang and Noveleta, expressed their interest in procuring Covid vaccines for their respective constituents.

Remulla announced the cancellation of the Cavite International Airport project from its contractor in February. Former governor Erineo "Ayong" Maliksi died at 82 because of Covid-19 complications. Hundreds of Olive Ridley Sea turtle hatchlings were released in Noveleta and Naic towns.

In March, a leader of the militant Bagong Alyansang Makabayan (Bayan) in Cavite province was shot dead on March 7. Manny Asuncion was gunned down in a purported raid on the Workers Assistance Center in Dasmariñas City. Asuncion, a well-known Bayan leader in Cavite, led the group for more than two decades. Covid-19 affected the livelihood of residents, which prompted private citizens and the LGU to form community pantries giving out free food and health kits to those in need.

It was also in March that the vaccine rollout began in Bacoor and Tagaytay City for A1 priority groups or health care workers. Remulla ordered the closing of the Kaybiang Tunnel on March 17. Imus opened the first drivethrough vaccination site in Robinson's Place parking lot on March 19.

In August, General Mariano Alvarez Mayor Walter Echavarria Jr. resigned from his post due to health reasons. After her historical win, Olympic Gold medalist Hidilyn Diaz received a P10-million, brand new home in Tagaytay City as a reward.

The fight against Covid-19 continued in the province with the last four months of the year, with the province and the municipal mayors taking up the vaccination drive that has so far slashed down the new Covid cases to 119 as of December 23 from a high of 1,968 in November.

Villanueva: Better services for OFWs seen as bill creating Department of Migrant Workers signed into law

Senator Joel Villanueva welcomed the signing of Republic Act No. 11641 creating the Department of Migrant Workers, which seeks to improve the services given to millions of overseas Filipino workers by consolidating all government offices and agencies scattered across the bureaucracy under one roof.

"Today, December 30, the day we honor one of the great Filipinos who lived is made much more significant with the signing of Republic Act No. 11641 which establishes the Department of Migrant Workers. Ito pong bagong itatatag na kagawaran ang magsisilbing bahay ng ating mga overseas Filipino workers na tinagurian nating modern-day heroes," said Villanueva, principal sponsor and author of the Senate Bill No. 2234, which the House of Representatives adopted just before Congress adjourned in mid-December. That paved the way for the speedy signing of the bill, a long-awaited measure by overseas Filipino workers.

CHIZ: RELEASE QUICK RECOVERY FUND ASAP TO FIRST RESPONDER AGENCIES IN ODETTE-HIT AREAS

With the impact of Super Typhoon Odette (international name: Rai) reaching catastrophic levels, the Department of Budget and Management (DBM) must hasten the release of the Quick Recovery Fund (QRF) of agencies at the frontline of disaster response, Sorsogon Gov. Chiz Escudero said.

Escudero also said the Department of the Interior and Local Government (DILG) should equip local government units (LGUs) in developing an effective Local Disaster Risk Reduction and Management Plan (LDRRMP), so they can be better guided in spending their disaster fund.

"The DILG and DBM should give more leeway to LGUs in spending their Local Disaster Risk Reduction and Management Fund (LDRRMF) to prevent and mitigate disasters, and not straitjacket national agencies in using their QRF for rehabilitation and repair," said Escudero, who is running for a Senate seat. Since 2017, line agencies have been classified into first responders and non-first responders in a calamity. First responders for relief and rehabilitation are the Department of Social Welfare and Development; Department of National Defense; Department of Health; and National Electrification Administration. Non-first responders are the Department of Public Works and Highways; Armed Forces of the Philippines; and Office of Civil Defense, which are tasked with repair and

With over 200 cities and municipalities experiencing power interruptions and food shortages in the aftermath of Odette, Escudero highlighted the need to spend the LDRRMF

Escudero, whose province is in a typhoon-prone region, said the LDRRMF was legislated in 2010 precisely so LGUs would have the resources for disaster prevention and mitigation, preparedness, response, rehabilitation and recovery.

"As a big believer in preparedness, I think there is a need for LGUs to review and update their LDRRMPs so we can integrate disaster risk reduction into the local Comprehensive Development Plan. We cannot carry on with this kind of devastation every year," Escudero said.

The LDRRMF, or what used to be known as the local calamity fund, represents at least 5% of a city or municipal-

DOH reminds public to celebrate New Year with health standards

The Department of Health - Center for Health Development (DOH-CHD) in Bicol on Wednesday reminded the public to continue strictly observing the minimum public health standards (MPHS) even while celebrating the upcoming New Year's Day festivities.

In a statement, the DOH-Bicol said that although vaccines are effective in preventing severe and critical coronavirus disease 2019 (Covid-19) cases, that does not stop the virus from getting transmitted.

"Practicing the health standards, such as wearing of masks, sanitizing of hands, practicing physical distancing and staying in well-ventilated areas, is essential in preventing the spread of Covid-19," the DOH Bicol said. Similarly, vaccinated individuals experiencing any symptoms are advised to isolate and get tested to avoid infecting others.

As of December 29, 2021, the Bicol Region has no recorded case of the Covid-



19's Omicron variant.

The DOH-Bicol also called on local government units (LGUs) and other stakeholders to strengthen the implementation of the MPHS and the Prevent-Detect-Isolate-Treat-Reintegrate (PDITR) Strategy.

This is to prevent possible community transmission of any variant of Covid-19 while preparations are underway should the Omicron

variant enter Bicol. Telemedicine services are available for those experiencing mild symptoms of Covid-19.

This strategy would also ensure that hospital and Intensive Care Units (ICU) facilities, as well as supply of medicines and oxygen tanks are enough for severe and critical cases.

The DOH-Bicol also said the public is highly encouraged to get themselves vaccinated to be protected against severe forms of Covid-19 and avoid hospitalization.

Also, vaccinated individuals are encouraged to get their booster shots. Vaccination is critical for the protection of the public, especially senior citizens and those with comorbid conditions as they have the highest likelihood of needing hospital and intensive care unit facilities. (PNA)
