#### LRT Cavite Extension hits progress rate of 61%

The Department of Transportation said Thursday the Light Rail Transit Line-1 Cavite Extension Project is near completion after almost 20 years.

Transportation Secretary Arthur Tugade said the overall progress rate of the project reached 61.60 percent as of November 2021.

It said the LRT-1 Cavite Extension was first approved by the National Economic

# CHIZ URGES DOTR TO RECALL 'NO VAXX, NO RIDE' POLICY

Senatorial candidate and incumbent Sorsogon Gov. Chiz Escudero is urging the Department of Transportation (DOTr) to recall its policy banning unvaccinated individuals from riding public transport, calling the "no vaxx, no ride" directive discriminatory and without legal basis.

Beginning January 17, commuters who are not inoculated with COVID-19 vaccines are prohibited from to taking the public buses, taxis, jeepneys, boats and commercial planes to, from and within Metro Manila based on the DOTr directive, in a new attempt by the government to curb the spread of the highly transmissible Omicron variant. "This is simply wrong and discriminatory," Escudero said. "Public transport is a

# OCTA: Virus growth rate 'accelerating' in cities outside 'NCR Plus'

The growth rate of COVID-19 cases slowed down in Metro Manila and surrounding provinces, but the spread of virus continued to accelerate in other highly urbanized cities, OCTA Research said.

"While growth rates have slowed in NCR Plus, they are still accelerating in many highly urbanized cities outside NCR Plus," OCTA Research fellow David said, referring to Metro Manila and neighboring provinces of Bulacan, Cavite, Rizal and Cavite.

According to David, the capital region recorded a 10% growth rate of cases from January 12 to 18. Metro Manila's reproduction

"It is still accelerating in Batangas and Isabela. In Cebu, Pangasinan, Quezon, Iloilo, Camarines Sur, Davao del Sur and Negros Occidental, the surge is still in its early stages, but likely to be accelerating soon," he added.

David, however, pointed out that there is still uncertainty in the projections due to possible backlog and an overwhelmed testing system.

Based on data shared by David, Cavite registered a 258 percent one-week growth rate, while Rizal had 254 percent, and Bulacan posted 295 percent.

Cavite had an average of 2,399 new COVID-19 cases from January 8 to 14, while Rizal had 1,903, and Bulacan had 1,733. Health Secretary Francisco Duque III earlier said the Department

necessity and the vaccination status of any individual cannot and should not be used to deprive him or her of access to public transportation."

"The equal protection and due process clause of our Constitution dictates nothing less," according to Escudero, who is a lawyer.

Public transportation, just like other public utilities such as water, telecoms or power, "must offer its services to the public without any discrimination or classification because it goes against the very nature of what it is—a public transportation," he added.

The National Task Force against COVID-19 said that as January 13, over 54 million Filipinos have been fully vaccinated so far, representing 70 percent of the country's target population. It is eyeing to inoculate 77 million by the end of first quarter and 90 million by the end of second quarter. Individuals who have received their booster shots are still below

In 2020, Land Transportation Franchising and Regulatory Board Chair Martin Delgra told a Senate public hearing of the Committee on Public Services that the agency expected at least 2 million commuters to use public transportation in Metro Manila alone with the lifting of the strict quarantine classification at the time, down 30 percent from the usual number of public transport users.

Unless recalled, the DOTr may find itself facing legal trouble before the Supreme Court, similar to the vaccine mandate imposed on federal employees and workers of big companies in the United States which is now being challenged in courts.

On the first day of its implementation, more than 100 unvaccinated commuters have been barred from taking the public transportation, 1 according to news reports.

A husband and a father of two, Orendain says their lifestyle changed when he decided to be serious about his business. "Naranasan ko po na kapag pasko at bagong taon, talagang nakikipagsabayan ako na maghanda nang marami, ng bilog na prutas, minsan nangungutang pa ako sa 5-6 (During Christmas and New Year, I used to prepare a lot of food and round fruits. I sometimes even borrowed money)," Orendain shared.

"Pero ramdam ko po na ang buong taon po sa amin ay hindi maluwag. Mabigat dahil namomroblema ako sa ibabayad ko (But the rest of the year wasn't smooth. I felt burdened because I was worried about how to pay for the loan)." "Nitong natuto po kami, wala talaga kaming handa. Wala rin kaming bilog na prutas. Kasi sobra po kaming busy, no time po kami para mag-prepare (Now that we've learned our lesson, we didn't prepare a lot of food. We also don't have round fruits.

Because we were so busy, we had no rime to prepare)." Orendain said he used a part of his holiday earnings to pay for his previous loans while some were spent for home improvement. He also shared his blessings with his relatives and allotted a part to help homeless people in their community.

"Ngayon po, nag-oonline po kami kaya meron na po kaming kinikita kahit papaano. 'Yung isa naming product, 'yung tampipi, 'yun pong mas marami talagang nag-oorder sa amin. Meron na rin po kaming konting naipon at paikot-ikot po 'yung puhunan na naitulong sa amin," sabi ni Dela Cruz.

Para kay Robredo, kasabay ng mga programang ito ang pagkakaroon ng gobyernong tapat, maengganyo ang mga investor na mamuhunan at magnegosyo sa bansa.

"Kailangan talaga 'yung gobyerno maging tapat kasi pag tapat ang gobyerno, 'yung investors papasok. 'Yung investors, kung marami tayong mga na-lose na mga investors, lumipat sa Vietnam, lumipat sa kung saan-saan pa, kasi 'yung uncertainty ang laki. 'Pag mas maraming investors 'yung pumasok sa'tin, mas marami din ang trabaho," ayon kay Robredo.

subject property in Barangay Patungan, Maragondon, Cavite." "The area of the demolition incident that happened last January 13, 2022 is not a property of SM," the company said.

Militant fishers' group Pambansang Lakas ng Kilusang Mamalakaya ng Pilipinas (Pamalakaya) described Brgy. Patungan as a coastal community situated along Mt. Palay-Palay, a mountain range known for its famous peak called "Pico de Loro."

Pamalakaya claimed that the fishing community in Maragondon town has been reportedly sold by the Maria-Teresa Virata Realty Corp., a realty firm that first claimed the land, to the Manila Southcoast Development Corp. (MSDC), a subsidiary of SMIC. According to the Cavite Philippine National Police (PNP), the piece of land subject to Writ of Demolition ordered by the Naic Regional Trial Court is composed of four to five hectares in Brgy. Patungan with more or less 400 houses, 600 families and 2000 individuals, 289 cottages, 44 island Hopping Boats and 105 Fishing Boats. Cavite PNP said the land was

entitled to MTV Investment Properties Holding Corp. formerly known as MTV Realty Corp. Pamalakaya is calling on the Commission on Human Rights (CHR) to investigate the violent demolition that led to scores of injuries in Brgy. Patungan.

The Cavite PNP, meanwhile, said the "aggressive residents" fighting for their rights of land while having negotiation resulted in the injuries of five PNP personnel and three civilians who were part of the demolition team. Pamalakaya said that "human rights violations committed by around 400 policemen accompanied by about 500 demolition crew during the attempted demolition of their houses."

The Cavite PNP, however, said that the deployment team for security assistance composed of 296 Cavite PNP personnel, eight PNP Maritime, two from the Highway Patrol Group, three crews from the PNP Provincial Health Service Unit; six from Coast Guard; 30 from Philippine Marine Corps; and seven from Bureau of Fire Protection.—LDF, GMA News

and Development Authority on Aug. 25, 2000, and recieved a budget from Congress in 2007 for right-ofway acquisition.

It said after catching up on right-of-way acquisition and its free and clear certification, and addressing a number of unresolved issues and constraints, the department, along with the Light Rail Transit Authority

and Light Rail Manila Corp. started actual construction works. LRMC earlier said it was expecting the LRT Line 1 Cavite Extension project to start operations by the middle of 2024.

LRMC said Phase 1 of the 11.7-kilometer project was 60-percent complete, with girder now covering the entire stretch of Dr. Santos Station to Pacific Ave. near

Asiaworld Station. Phase 1 covers 7 kilometers including the Redemptorist Station, MIA Station, Asiaworld Station, Ninoy Aquino Station and Dr. Santos Station.

The remaining stations between Las Piñas and Niog are scheduled to become fully-operational by 2022.

Once completed, the extension is expected to reduce travel time between Baclaran

and Bacoor, Cavite to just 25 minutes, from 1 hour and 10 minutes and increase LRT-1's capacity from 500,000 to 800,000 passengers daily.

LRMC won the bidding for the project and took over the operation of LRT Line 1 on Sept. 12, 2015. LRT Line 1 runs from Baclaran in Pasay City to Munoz in Quezon

# Too early to think of 2022 growth target revisions: NEDA exec

It is still early to think of any revisions in the 2022 growth target even with the Alert Level 3 implementation in several parts of the country, a National Economic and Development Authority (NEDA) executive said Tuesday. While Alert Level 3 movement restriction has been raised until end-January 2022 in more than 80 areas around the country, including the National Capital Region (NCR), NEDA Undersecretary Rosamarie Edillon said the decision is partly made as a "balancing act" for health and economic aspects.

"With respect to the target for the year, it's still early days to be revising whether upwards or downwards because it's just January 18.

There are still a lot of developments that can happen, hopefully very positive developments on that," she said during the virtual presser hosted by the Presidential Communications Operations Office (PCOO) for the Task Group on Economic Recovery and National Employment Recovery Strategy (TGER-NERS).

The inter-agency Development Budget Coordination Committee has set a 7 to 9 percent growth target for this year and 6 to 7 percent for 2023-2024.

Authorities said Alert Level 3 in the NCR Plus, which covers the NCR and neighboring provinces of Rizal, Laguna, Cavite, and Bulacan, costs the economy

week. Edillon said latest figures on the impact of the Alert Level system on the economy are "tamer" compared to the effects of the enhanced community quarantine and the modified enhanced community quarantine. She said the improving vaccination rate in the country is a plus as it provides added protection of the population against the coronavirus disease 2019.

Edillon said the economy has experienced heightened movement restrictions in the past, thus, "we think we are now much better at managing these risks."

"...There's still enough time to catch up," she added.

#### SSS: COVID-hit members covered even if not hospitalized

The Social Security System (SSS) on Thursday assured members infected with COVID-19, particularly those who just stayed at home instead of a medical facility, that they can avail themselves of sickness benefits.

The state-run pension fund issued the statement to correct any impression that only those confined in hospitals were eligible.

Citing its rules, the SSS said "members who cannot work due to sickness or injury and are confined either in a hospital or at home for at least four days could avail of the sickness benefit." The benefit also covers overseas Filipino workers (OFWs), as well as self-employed and voluntary members of the SSS.

"COVID-19-infected members in home confinement can qualify if they have paid at least three monthly contributions within the last 12 months before the semester of sickness or injury and are confined either in a hospital or at home for at least four days," the SSS said. "For employed members, they should have used all their current company sick leave with pay and notified their employer about their sickness. Self-employed, voluntary, and OFW-members and those separated from employment must notify the SSS directly by filing a sickness benefit application," it added.

The SSS allows online filing of sickness benefit reimbursement applications via the My.SSS portal. Members can avail themselves of a maximum of 120 days' worth of sickness benefit during one calendar year.

The daily cash allowance to be paid to beneficiaries will amount to 90 percent of the computed average daily salary credit. To apply, those infected with COVID-19 must present a positive reverse transcription-polymerase chain reaction (RT-PCR) test or rapid antigen test done in a Department of Health-accredited facility.

The SSS will also accept the result of a Food and Drug Administration (FDA)-approved rapid antigen test kit. For those with non-FDA-approved rapid antigen test results, the SSS also requires them to submit copies of certificates of completion of quarantine, which must be issued and signed by a medical officer from their local government units or their barangay's health emergency response team. —Ben O. de Vera

#### Legarda calls for mandatory free mass testing, urges for the enactment of Better Normal Bill

With the recent surge of COVID-19 cases in the Philippines, three-term Senator and Deputy Speaker Loren Legarda once again called for mandatory free testing to help prevent the transmission of the virus.

Citing the two Bayanihan laws that embody the national government's pandemic response and recovery strategies, Legarda stated in a recent interview that there should already be sufficient and accessible COVID-19 testing centers in the country which shall be overseen by the Inter-agency Task Force on Emerging Infectious Diseases, in cooperation with the Department of Health (DOH), Department of the Interior and Local Government (DILG), Department of Labor and Employment (DOLE), and Department of Trade and Industry (DTI). These testing centers should provide free tests for the Filipinos.

Legarda also shared that, in her home province of Antique, they were able to establish a molecular laboratory, utilizing the budget of the provincial government, that can process COVID-19 RT-PCR tests. "Antiqueños now need not go to neighboring provinces of Iloilo or Aklan to do their RT-PCR tests and this minimizes the need for people to travel, thus mitigating the risk of people being exposed to the virus or even being infected," Legarda said.

As the author and sponsor of House Bill No. (HB) 6864, or the "Better Normal Bill", which she sponsored at the start of the pandemic yet, Legarda said the bill aims to strengthen the country's COVID-19 response by mandating local government units (LGUs) considered as "critical zones" for COVID-19 to put up testing centers and procure COVID-19 test kits and protective equipment necessary to conduct mass testing. The measure likewise provides for

the establishment of drive-thru testing centers, and other contactless modes of testing. Furthermore, the bill mandates the conduct of a nationwide testing drive in preparation for possible waves of infection surges in the coming months or years.

"Ang intensyon po ng probisyon na ito ay makapagbigay ng libreng testing sa ating mga mamamayan sa pamamagitan ng pagpapalawak ng ating testing centers at pag-procure ng test kits kaya tiniyak po nating maisama ito sa panukalang batas noong ipinasa natin ito sa Kongreso," Legarda said.
