The Bangko Sentral ng Pilipinas (BSP) said Monday the Monetary Board has approved USD3.32 billion worth of medium- to long-term (MLT) foreign borrowings in the fourth quarter of 2023.

The public sector's foreign borrowings from October to December 2023 jumped by 65.8 percent from the USD2 billion level in the same period in 2022. This lifted the total MLT foreign borrowings last year to USD14.49 billion, which consisted of 24 MLT borrowings —two

The external borrowings that were made last year aims to fund the national government's programs in infrastructure, agriculture, education, economic recovery and development, environment protection and climate resilience, and coronavirus disease 2019 (Covid-19) response.

A big chunk of the foreign borrowings in 2023 will finance the public sector's infrastructure projects, including transportation amounting to projects, USD4.07 billion.

The government borrowed USD4 billion from foreign sources for its general

financing USD3.07 billion for economic recovery and development, environmental protection and climate resilience projects and programs, and USD2.27 billion for Covid-19 pandemic response projects and programs.

Projects for agriculture and education sectors also respectively got USD880 million and USD210 million

requirements, from foreign borrowings.

"Under Section 20, Article VII of the 1987 Constitution of the Republic of the Philippines, prior approval of the Bangko Sentral ng Pilipinas, through its MB, is required for all foreign loans to be contracted or guaranteed by the Republic of the Philippines," the central bank said.

"The BSP promotes the

judicious use of the resources and ensures that external debt requirements are at manageable levels, to support external debt sustainability," it added.

Meanwhile, Finance Secretary Ralph Recto was sworn in on Monday as the government sector representative the to Monetary Board (MB), the BSP's highest policy-making body.

The oath-taking ceremony was administered by BSP Governor and MB Chair Eli Remolona Jr. at the BSP head office in Manila. The other MB members Bruce Tolentino, Anita Linda Aquino, Romeo Bernardo, Rosalia De Leon and Recto's predecessor, Benjamin Diokno.

Before his appointment to the DOF on Jan. 15, Recto was a senator for three terms (2001 to 2007 and 2010 to 2022) and held key positions that included Senate President Pro Tempore and Minority Leader.



Unlike access to the premises of the printer for purposes of guarding the same or witnessing the printing and distribution of the ballots and returns, there is no legal right to allow physical access to the technical hubs or data centers of the automated election system," the SC said. The SC added that the

poll body does not have a ministerial duty to allow access to its technical hubs, servers and data centers.

The court likewise said that the law does not mandate the Comelec to allow physical access to its hubs, servers, and data centers, adding that the constitutional right to information does not extend to physical access to said facilities and the right is subject to reasonable conditions and limitations.

plotted in the diagram or architecture may call into question the integrity of the elections," the court said.

"We hold therefore, that were it not for the mootness of the issue, the Comelec may be compelled via a writ of mandamus to disclose the complete transmission diagram and data/ communications network architecture of the VCMs," it added.

Nevertheless, the court said the request for Comelec to publicly disclose all details of the transmission router and all devices and equipment that will be used is "too broad and vague."

"Certainly, we cannot compel the Comelec to reveal all details, some of which may contain confidential information, which, if divulged, could pose serious security risks," the SC said. (PNA)

DOH improves healthcare, brings services closer to people



The Department of Health (DOH) continues to improve its mandate of bringing quality healthcare services to all Filipinos nationwide.

For the year 2023, the agency was busy on the establishment of healthcare facilities, especially in the provinces, that would provide state-of-the-art medical services.

It has been productive in bringing laboratory services to poor people in far-flung areas with the help of other government agencies.

On March 24, the Catheterization Laboratory (CathLab) at the Jose B. Lingad Memorial General Hospital in San Fer-

Since 2021, Herbosa reported that 71 LGUs have committed to integrate their local health systems. These were labeled as UHC Integration Sites which consist of 59 provinces and 12 highly-urbanized cities.

He added that the DOH has already engaged five UHC

nando City, Pampanga province opened to Central Luzon residents who need interventional cardiac and non-cardiac procedures under interventional radiology.

It was completed in 120 days through the Health Facilities Enhancement Program and in coordination with provincial and local government units.

Its funding was taken out of the PHP1-billion budget given to the hospital in 2013 for the provision of equipment and buildings.

Apart from cardiac procedures, the CathLab currently serves patients in the region who have different medical needs.

Meantime, the DOH launched the construction of the Clark Multi Specialty Medical Center on July 17 in collaboration with the Philippine Amusement and Gaming Corporation, the Clark Development Corporation, Pampanga local government units, and in partnership with the private sector like the Bloomberry Cultural Foundation, Inc.

Specialized departments, including heart, kidney, cancer, and pediatrics, are expected to open in the soon-to-rise medical center.

To ensure the facilities in the Eastern Visayas, DOH Secretary Ted Herbosa visited Biliran Provincial Hospital (BPH), DOH-Treatment and Rehabilitation Center-Dulag, Eastern Visayas Medical Center, and the Gov. Benjamin T. Romualdez General Hospital and Schistosomiasis Center on Oct. 26 to 27.

Herbosa checked on the construction of new facilities in some of these hospitals and their best practices, innovations,

The caravan, a project of First Lady Liza Araneta-Marcos, aims to provide free consultation, free x-ray, laboratory services and medicines to the provinces.

Previous "Lab for All" caravans were held every Tuesday in cities in the provinces of Batangas, Tarlac, and Pampanga, and in Baguio City.

The DOH also pushed for the creation of a council that will serve as a governing body which will oversee the implementation of the Universal Health Care (UHC) law, the estimated total of the national cost for the UHC, and the implementation of UHC at the local government level.

President Ferdinand R. Marcos Jr. has approved the plan last October.

Herbosa said the DOH will chair the council with the Department of the Interior and Local Government as its cochair.

"The council will police or monitor how LGUs or local health systems would be spending funds, income from Phil-Health, and how the other systems can be improved," he said.

The member agencies of the council include the Department of Information and Communications Technology, Department of Budget and Management, Department of Finance, Philippine Health Insurance Corporation, Philippine Regulation Commission, National Economic and Development Authority, Technical Education and Skills Development Authority, Commission on Higher Education and Department of Education. Integration Sites to become primary care provider network sandbox or trials or pilots and these are Baguio, Bataan, Quezon, Guimaras and South Cotabato as for 2023.

Herbosa told the Philippine News Agency on Monday that health officials are drafting the plan to modernize the DOH — a measure that would address inequity in the provision of primary healthcare services among Filipinos.

"Magtatayo tayo ng ambulatory primary care centers na kumpleto ang laboratoryo, kumpleto ang mga gamot, kumpleto ang mga imaging para 'yung mga tao hindi na magsiksikan sa mga malalaking ospital (We will build ambulatory primary care centers complete with laboratories, medicines, and imaging so that people need not flock to big hospitals)," he said. The creation of a national ambulatory and urgent care centers nationwide will ensure that the poor receives the same healthcare services much like individuals who go to modern hospitals, he added.

For 2024, the DOH also aims to increase the immunization coverage of children under five years old to 95 percent; lower stunting or under nutrition rate among young children from the current 27 percent to 14 percent; reduce maternal mortality deaths and teenage pregnancy; lower cases of tuberculosis and human immunodeficiency virus; and decrease cases of non-communicable diseases like hypertension, cardiovascular diseases, diabetes, and cancer.

"Also, road safety, dumarami ang namamatay (the number of deaths is increasing) due to accidents involving motorcycles because more people are learning to drive them," Herbosa said. (PNA)

Contract for Cavite bulk water supply project soon up for bidding

Preparations are underway to bid out the contract for the Cavite-wide Bulk Water Supply Project this year as the Department of Environment and Natural Resources



(DENR) turned over the water rights to the Cavite local government. In a text message to The STAR, DENR Undersecretary and Water Resources Management Office (WRMO) head Carlos Primo David said the water rights for the massive water project was assigned to the provincial government of Cavite in early December.

He said plans for the project should be drafted while competitive bidding should take place within the first quarter.

"The next step is to draw up a plan on how the water will be distributed to the three million plus residents equitably and efficiently. Cavite will bid out this province-wide project to a single developer. All this within the first quarter of 2024, hopefully," David said.

The DENR official said the Cavite-wide Bulk Water Supply Project is one of the biggest water projects in a decade.

This is also the second provincial-wide water supply program of the country next to the Bulacan Bulk Water Project, which was completed by Luzon Clean Water Development Corp., a joint venture of San Miguel Corp. and K-Water Resources Corp., in 2019.

The Cavite-wide Bulk Water Supply Project is among the major public-private partnership (PPP) projects worth P2 trillion the provincial government hopes to deliver over the next 10 years, Gov. Jonvic Remulla said earlier.

DENR Secretary Ma. Antonia Yulo-Loyzaga said the local government's role is critical in pursuing massive projects like this especially in ensuring water supply and security.

"It's really important that, although you're looking at private sector funding possibly, local governments need to take the lead here in terms of their own assessment of their needs and risks of climate change to their particular locality," the environment chief said.

Last March, President Marcos signed an executive order creating the WRMO to address the looming "water crisis" threatening the country.

An office under the DENR, the WRMO is mandated to formulate and ensure the implementation of an integrated water management plan.

The President had said its plans should include the construction of water impounding facilities to reduce flood damage and make effective use of water resources.



The Bureau of Customs (BOC) on Monday reported that it has surpassed its PHP901 billion collection target for 2023.

BOC spokesperson Assistant Commissioner Vincent Philip Maronilla, in a Bagong Pilipinas Ngayon briefing, said they have also recorded a collection surplus of more than PHP10 billion.

"Na-achieve po namin ito by – iyong ginawa po naming streamlining ng mga process namin and of course, ini-improve po namin iyong revenue efficiency namin, we tried to locate iyong mga loopholes namin (We have achieved this through streamlining our processes and of course, by improving our revenue collection efficiency. We tried to locate our loopholes) and we tried to plug it, through some scientific methods na amin pong pinagtulung-tulungan, (that we have collectively worked for), together with some private sector representatives like the Ateneo School of Government and iyong mga stakeholders po namin (our stakeholders)," he added.

Maronilla also said major ports contributed to achieving and eventually surpassing last year's target collection.

"Fifty percent of the collection of the Bureau of Customs, ano na kaagad ho iyon 'no, that's the Manila International Container Port which 30 percent po ng volume namin and about 30 percent of our target comes from. Dadagdag po diyan iyong Batangas Port, nasa mga bentesingko porsiyento po ng aming collection ay nanggagaling diyan. And, of course, the Port of Manila, which is mga around 18 to 20 percent nanggagaling naman po (Fifty percent of the collection of the Bureau of Customs automatically comes from the Manila International Container Port. This is where 30 percent of the volume and 30 percent of the target collection come from. In addition, we have the Batangas Port, where we get 25 percent of our collection. And of course, the Port of Manila, where around 18 to 20 percent of our collection comes from)," he said.

Other major ports that contributed to the high collection of the BOC include the Ports of Cebu, Davao and Cagayan de Oro, Subic, Clark, Ninoy Aquino International Aiport, Legazpi, Tacloban, Iloilo and San Fernando, according to Maronilla. Meanwhile, he said the BOC is confident of hitting its PHP1 trillion target collection for 2024.

"If we continue on our track to improve further 'yung revenue efficency namin at pag-improve ng aming (our revenue efficiency and the improvement of our) processes, mas maeenganyo na mag-negosyo ung mga negosyante at dumadagdag din ang mga investors natin na who are contributing dun sa rating (we can lure more entrepreneurs and investors who are contributing to our) imports and duties, by that, we are projecting to collect PHP1 trillion and I think, we can even surpass it," he added. Maronilla, meanwhile, said the digitalization of the bureau's processes is now at 99 percent. "May entities na di pa nila kayang mag-interlink sa system ng BOC. Tinutugunan po namin 'yan para makumpleto 'yung inter-linkage natin dyan. Ang goal po natin sa 2024, ngayong na-digitize na 'yung processes, is to integrate these processes para po isang cohesive na proseso ang gagawin nitong mga improvements na ito. (Some entities still cannot interlink their system with the BOC. We are working on that so that we can complete the inter-linkage process. For 2024, now that we have digitized the processes, our goal is to integrate these processes so that we can only have one cohesive process


