Lucio Tan firm, Chinese infra giant sole bidder for \$10B Cavite airport project

MANILA, Philippines — A Chinese state-owned company and Philippine Airlines owner Lucio Tan forged an alliance to transform a former Air Force base in Sangley Point, Cavite into an international gateway to decongest Manila's Ninoy Aquino International Airport (Naia).

China Communications Construction Co. Ltd. (CCCC), one of the country's biggest infrastructure firms, and partner MacroAsia Corp., a publicly-listed aviation services firm owned by Tan, were the sole bidders for the Cavite government's planned P500 billion Sangley Point International Airport.



submission, their joint venture proposal was deemed complete, subject to detailed evaluation by the PPP (Public Private Partnership) selection committee," Jesse Grepo, legal officer and secretary of the committee, said in a text message as the bid was opened Tuesday. Five other potential bidders, including Manuel V. Pangilinan's Metro Pacific Investments Corp. and Manuel Villar Jr.'s Prime Asset Ventures, did not submit proposals. With no challengers, the CCCC-MacroAsia consortium is poised to win the project, which was structured as a venture with the local government unit, meaning it will not need the approval of agencies such as the National Economic and Development Authority to proceed. Grepo said the review will likely last through next year with a potential awarding date on Jan. 15, 2020. A ceremonial ground breaking could also happen on the same month, should the consortium meet all technical and financial requirements, he said. MacroAsia officials did not respond to requests for comment on Tuesday. The Sangley Point International Airport is the Cavite government's response to congestion in Naia, which is located at a straight line distance of about 11-kilometers away. It will require the reclamation of over 1,400 hectares of land around the current Danilo Atienza Air Base, the formal name of the existing Sangley Airport.

Eventually, the facility will be turned into a massive air hub with four runways and terminals capable of handling 100 million passengers annually— three times the design limits of Naia. Some experts also believed Sangley's proximity to Naia meant certain limitations for simultaneous operations. In the Sangley project study, which was seen by the Inquirer, it was recommended that Naia focus operations on its main international runway. It acknowledged that some of Naia's existing approach and departure airspace routes "overlap" with the airspace required for similar key structures at the Sangley Airport. The Sangley Point International Airport has also drawn criticism for its close association with the Chinese government. In its project study, the airport plan was described as aligned with China's One Belt, One Road cross-borhabang kinondena ang uma

der infrastructure plan. "We see no problems with regard to national security," Grepo said. He added that the project contained no sovereign guarantees and the offer on the table has a

local partner, MacroAsia.

CCCC-MacroAsia was among seven groups that formally expressed their interest to bid by acquiring joint venture documents, which were issued last Oct. 11. The other companies were Metro Pacific, Prime Asset Ventures, and Philippine Airport Ground Support Solutions Inc. led by businessman Jefferson Cheng. The two other entities were Langham Properties Inc. and Mosveldtt Law Offices.

Some of the bidders sought more time but requests were turned down by the Cavite government, which extended the first deadline on Nov. 25 to Dec. 17 this year.

Earlier, the Cavite government said the first phase of the project could be opened as early as 2022 with a capacity of 25 million passengers annually. The current Sangley Airport is being readied by the Department of Transportation (DOTr) to handle general aviation and turboprop operations. The airport now has a 2,400-meter runway, a terminal for 160 passengers and an apron that can accommodate up to five turboprop planes.

The DOTr expects to be reimbursed for costs it incurred should the Cavite government's plan push through, Transportation secretary Arthur Tugade earlier said.

The Sangley Point International Airport is part of the DOTr's so-called multi gateway strategy to address congestion in Manila and nearby provinces. Other gateways in the pipeline include San Miguel Corp.'s New Manila International Airport in Bulacan province and the ongoing expansion of the Clark International Airport in Pampanga province. Naia itself is set to be upgraded via a 15-year proposal submitted by the Naia Consortium, a group of seven business groups that include Metro Pacific and another Tan-led firm called Asia Emerging Dragon. MacroAsia president and chief operating officer Joseph Chua said in an interview last month that both airports can operate simultaneously. "There is no conflict between Naia and Sangley. Although they are in close proximity, the aerodrome can be shared. It's just a matter of management," Chua said.

Cavite City-Lawton ferry service will be free until January 31

Ferry providers Seaborne Shipping Company Inc. and Shogun Ships Co. Inc. agree to serve passengers for free during the first month of operations

MANILA, Philippines – The Cavite-Metro Manila ferry service was launched on Sunday, December 8, with an announcement from Department of Transportation (DOTr) Secretary Arthur Tugade that Seaborne Shipping Company Inc. and Shogun Ships Co. Inc. have agreed to run the ferry service for free for the first month.

The Cavite City-Lawton ferry service will be transporting passengers for free until January 31, while the Cavite City-Cultural Center of the Philippines (CCP) Port will be providing free service until January 9.

After the maiden voyage of the MV Island Sabtang run by Shogun Ships, its chairman and chief executive officer Vicente Cordero Jr said that their free service will be extended to January 31, after a prodding from Tugade to extend it until Valentines' Day.

The ferry service is expected to cut travel time from 3-4 hours on land to a range of only 15 minutes to around

an hour by ferry, depending on the drop-off point.

"Makakatulong din ito para maibsan 'yung traffic congestion sa EDSA, [Metro Manila] (This will help ease traffic congestion along EDSA, Metro Manila)," Tugade said. Tugade also asked the Cavite City local government to provide increased security to control crowd movement.

The DOTr and Maritime Industry Authority (Marina) earlier announced two phases of the ferry operations, and when the service was launched, the routes that were first to be opened were Cavite City Hall to CCP Port and Cavite City Hall to Lawton Ferry Terminal. Finding the P160 to P200 fares too

high, Tugade said that the ferry service rates are still being negotiated. He wanted them to be in close range with the jeepney and bus fares. He also said that the operators may add 2 to 3 more boats, subject to navigational lanes. Tugade is considering adding routes from Sangley, Tanza, and Naic in Cavite to SM Mall of Asia in Pasay.

"For our members who have been availing of the salary loan since 2011, especially for employed members, it is not a new thing for them as they already have the option to apply for this privilege through their My.SSS account or through any SSS branch nationwide," Ignacio added. As stated in SSS Circular 2019-014 and approved by the Social Security Commission (SSC), the policy-making body in SSS, all members who wish

to avail of the salary loan are now required to register on the My.SSS online facility and submit their application online. "Our members need not visit the physical branch just to file their loan application. All they have to do is register on the My.SSS facility if they are not registered yet and select the salary loan application. For self-employed, voluntary and Overseas Filipino Workers (OFWs), the processing of the loan starts right after the submission of the application while for employed members, their employer must certify the loan application through My.SSS facility for the loan to be processed," Ignacio explained.

Ignacio said once the loan application was approved, the member will immediately receive a confirmation text and email from SSS notifying him of the status of his application.

At present, the salary loan proceeds will be released to the member thru check but as soon as the new system of the pension fund is in place by mid-December, the loan proceeds will be credited to their UMID-ATM with EMV capability or to their nominated savings account. "The salary loan is one of our most popular programs in SSS that is why we have decided to enhance its features, allowing our members to maximize their time doing other things while waiting for their loan approval without the hassle of queuing in SSS branches," Ignacio said.

"They also need not worry about the inconvenience of encashing their checks once their loan is approved. All they have to do is to withdraw their loan proceeds at any automated teller machine f at their convenience," she added.

Based on available reports, more than 1.46 million members availed of the salary loan from January to September 2019 with P29.98 billion worth of loans released to member-borrowers

The salary loan is the most availed loan program of the SSS. Under the program, members may borrow up to twice the average of their 12 latest posted monthly salary credits. It is payable in 24

monthly installments with an interest rate of 10 percent per annum based on its diminishing principal balance.

To qualify for a salary loan, the member must be under 65 years old at the time of application, has not been granted any final benefit such as permanent disability, retirement or death, and has not been disqualified due to fraud committed against the SSS. In addition, the employer of an employed member-borrower must be updated in the payment of contribution and loan remittances.
