The Intellectual Property Office of the Philippines' (IPOPHL) has established its 15th Intellectual Property (IP) Satellite Office (IPSO) in Calabarzon to help increase IP protection activities in the most populous region of the country.

"IPSOs are at the forefront of bringing our primary services within the reach of regions in the country. The objective of our newly opened IPSO Calabarzon is to raise the use and awareness of the IP system among innovators, creators and businesses in the region," Director General Rowel Barba said. Calabarzon, particularly the provinces of Cavite and Laguna, are driven by high-tech manufacturing industries.

As of 2020, there are a total of 139,363 micro, small and medium enterprises (MSMEs) in the region, making the area a prime spot for potential users of the IP system.

The region also houses diverse research and development (R&D) sources, with five state universities and colleges and five Innovation and Technology

Support Offices (ITSOs), making it a potential hotbed for developing IP innovations "We also want to promote IP awareness and understanding to our higher education institutions (HEIs)," Barba added. As an industrial hub for manufacturing, agriculture and tourism, IPSO Calamba also aims to raise awareness on the adverse effects of counterfeiting and piracy. It is also seen to fastrack part-

nerships with local policy makers to promote collaborations in establishing local IP initiatives. According to the Philippine Statistics Authority, Calabarzon is the fastest growing region in 2021 with a 7.6 percent growth in 2021. This growth led to Calabarzon accounting for 14.7 percent of total gross domestic product (GDP), the second largest share among regions. As the first activity of the new IPSO in the locality, the IP Field Operations Unit (IP-FOU) will conduct a capacity-building program for the DTI Calamba staff on July 6.

The one-day training aims to "empower our DTI IP advocates to foster a collaborative relationship with the stakeholders," Barba said. "While we expand our reach to more key strategic areas, making our services available to those in need of IP rights aid, we also want to

receive insight about the experiences of local advocates. In turn, we want to raise their knowledge on how to better serve the IP needs of their communities," Barba added. IPSO Calamba is located at the 4th floor of Marcelita building, DTI 4A Regional Office, Barangay Real, Calamba City, Laguna. Cavite opens swiss challenge << P1

Jr. told BusinessWorld in a phone message on Tuesday, when asked for an update on the project.

Cavite has been pushing for a Sangley Point International Airport as an alternative to the Ninoy Aquino International Airport (NAIA), the Philippines' main gateway, as demand for air transport is expected to increase in the next 30 to 40 years.

Sangley Point is in Cavite City, along a peninsula that juts out into Manila Bay. The peninsula's southwest-to-northeast orientation encloses two smaller bays — Cañacao Bay opposite the airstrip and Bacoor Bay closer to the Luzon mainland. The airstrip was first built in 1951 by the US Navy. Sangley Point is currently operated by the National Government as a supplemental runway to NAIA.

The Cavite government said in an announcement on its website that the competitive challenge process will test the technical and commercial soundness of the unsolicited proposal and the strength of the financial and technical qualifications presented by the SPIA consortium, which enjoys original proponent status with the right to match any challenge.

The request for proposals (RFP) document package includes an information memorandum, instructions to challengers, and a draft joint venture and development deal. The documents are available for purchase between July 4 and Aug. 18.

"Any interested party must register and submit a written expression of intent, sign the prescribed non-disclosure agreement, and pay the non-refundable participation fee of P1 million on or before the last day of registration and purchase of the RFP," the province said.

On Aug. 17, or "at least 30 working days after the first publication and RFP release, if there are no challengers, PPP-SC (the public-private partnership selection committee) can proceed to issue the notice of award in favor

If proposals are submitted, the committee will issue a notice of award to the original proponent by Sept. 28 if the challenges are deemed uncompetitive.

The selected party becomes a joint venture partner of the province and is expected to provide equity investment, debt financing, and credit enhancements.

It will also perform the engineering, procurement, and construction, including the operation and maintenance services for the land airport development components of the project.

Among the roles of the Cavite government in the project are supporting all applications for obtaining the necessary project approvals, consents, permits, and licenses from the relevant government authorities and grant exclusive, long-term land use rights over the project land in favor of the joint

cial government of Davao del Norte. The provincial government of Davao del Norte is designated to earmark the funds needed for the creation of the Panabo City District Hospital. Under RA 11873, the Lamidan Community Hospital in Don Marcelino, Davao Occidental will be established and supervised by the Davao Occidental government. RA 11874 was also signed for the establishment of a community hospital, which will be known as the Nuing Community Hospital, in the municipality of Jose Abad Santos in Davao Occidental province. The community hospital will be under the direct supervision of the Davao Occidental government, which is also directed to provide the budget needed for its creation.

RA 11876 also establishes the Isaac Tolentino Memorial Medical Center, a Level III general hospital in Tagaytay City, Cavite which will be managed by the city government of Tagaytay and developed into a medical facility that leads and specializes in sports and rehabilitation medicine.

RA 11878 directs the establishment of the Ospital ng Meycauayan in Meycauayan City, Bulacan which will be under the direct control and supervision of the city government of Meycauayan.

Under RA 11886, a children's hospital will be established in Liloan, Cebu, which will be known as the Liloan Children's Hospital.

The Liloan Children's Hospital will specialize in children's health care services from prenatal to pediatric care and nutrition counseling services, immunization, and training classes on children's health for parents. The hospital, which will be known as the Iloilo City Hospital (ICH), will be located in the city of Iloilo and under the direct control and supervision of the Iloilo City government, according to RA 11891.

Around PHP500 million will be appropriated for the capital outlay of the ICH, which will be included in the budget of the Department of Health (DOH) under the 2023 General Appropriations Act. The Iloilo City government will provide the funding for the operation and maintenance of the ICH.

Duterte likewise inked RA 11892, establishing a geriatric medical center in Kalibo, Aklan which will be known as the Aklan Geriatric Medical Center.

The Aklan government is tasked to provide the necessary funds for the establishment of the Aklan Geriatric Medical Center, while the Health secretary is directed to include the support for the facility's capital outlay requirements in the department's subsidy program.

Under the laws, any future increase in bed capacity, health care facilities, service capability, and human resource complement will be based on the hospital de-

VP Sara tells Cavite grads: Serve, protect our country

DASMARIÑAS CITY, Cavite: Vice President and concurrent Education Secretary Sara Duterte-Carpio appealed to new graduates of the Emilio Aguinaldo College here to "serve, protect and love our motherland" during the school's 49th commencement exercises on Thursday morning, July 7, 2022.

"As you move forward to reach the goals you have charted for yourselves, may you constantly be reminded that as citizens, you have a duty to our country," Duterte-Carpio, the guest of honor and speaker, said.

Duterte-Carpio recognized the effects of the Covid-19 pandemic on education.

But the pandemic, according to her, will be overcome by the government's commitment to ensuring educational continuity and quality amid challenges.

"The pandemic is no match for the collective resolve of the Philippine government and all education stakeholders in our country, who have ensured that Filipino learners continue to have access to education," Duterte-Carpio said.

As the college is named after late former president Emilio Aguinaldo, she said she hopes that the graduates will reflect on the acts of heroism and bravery of the Philippines' first and youngest president.

"You are brave. We are all brave. Filipinos are brave. Mahal natin ang Pilipinas. Patuloy natin itong mahalin (We love the Philippines. Let us continue loving our country)," Duterte-Carpio added.

"Just like all other Filipino heroes, President Aguinaldo chose to love our country. And choosing to love a country is an act of bravery," she said.

2,300 Calabarzon schools reopen for face-to-face classes

More schools in the Calabarzon region are welcoming back their students following the continuous implementation of the "progressive expansion" phase of face-to-face classes.

The Department of Education (DepEd) Region 4-A said it had given the green light to 2,344 public schools and 24 private schools to hold limited face-to-face classes. These schools have passed the standards set under the memorandum order jointly issued by the DepEd and the Department of Health (DOH) for the safe reopening of schools. Among that have reopened for the limited face-to-face classes include schools from major cities of Antipolo, Bacoor, Batangas, Biñan, Cabuyao, Calamba, Dasmariñas, Lipa, Lucena, Sta. Rosa.

Some schools from other localities, such as General Trias City and Imus City in Cavite; San Pablo City, Laguna; Tanuan City, Batangas; and Tayabas, Quezon, have also resumed in-person classes after passing the government guidelines.

More schools are expected to reopen in the coming months, as the DepEd 4-A advised its Schools Division Offices to expedite their evaluation and validation for the compliance of the remaining schools and submit their recommendations.

The national government is slowly reopening schools in the country following the successful pilot implementation of face-to-face classes in basic education last year. — Patricia Bermudez, PIA 4A (with reports from DepEd IV-A)
