Covid-19 positivity rate in some areas now over 10%

An infectious diseases expert on Monday said Covid-19 cases have started to rise as positivity rates recorded in some areas are now above 10 percent.

In a televised public briefing Monday, Dr. Rontgene Solante said this is higher than the 5 percent threshold recommended by the World Health Organization. Positivity rate is the percentage of Covid-19 tests performed which turned out positive in a certain area or region.

"Yes, I think, this is starting now, 'yung positivity rate natin, 'yung mga newly-infected individuals based on that positivity rate ay nag-umpisa nang tumaas (our positivity rate, the newly-infected individuals, based on the positivity rate, are increasing)," he said. "We're above the 10 percent now especially in the National Capital Region (NCR) and we would expect this uptick of the cases to be a bit in the next three to four weeks, maybe."

As of July 9, the OCTA Research Group said NCR's positivity rate increased from 8.3 percent to 10.9 percent.

It added that positivity rates were over 10 percent in Aklan at 26.9 percent; Antique, 17.8 percent; Batangas, 11.3 percent; Capiz, 18.8 percent; Cavite, 14.9 percent; Iloilo, 11 percent; Isabela, 10.3 percent; Laguna, 18.2 percent; Nueva Ecija, 14 percent; Pampanga, 16.5 percent; Rizal, 16.6 percent; and Tarlac, 16.7 percent.

"Mataas ang hawaan nitong mga bagong variants na nakikita rin sa (The infections brought about by the new variants are high as also seen in the) Philippine Genome Center Surveillance like the BA.5 and the BA.4," Solante said.

Meanwhile, OCTA Research Group fellow Dr. Guido David said growth rates are also rising in some areas like the NCR, Region 4-A (Calabarzon), Central Luzon and Western Visayas.

"Yung sa NCR, we're not expecting na tataas pa ito ng masyadong mataas kasi bumababa na ang growth rate sa NCR. Nasa 31 percent na lang (We're not expecting the growth rate in NCR to go up any higher because it has already gone down to only 31 percent," he said. "So, hopefully, malapit na 'yung peak ng cases sa NCR, pero hindi pa natin masasabi 'yan sa ibang regions sa Pilipinas (the peak of cases in NCR is already near but we can't say that for other parts of the Philippines)."

David noted that the healthcare utilization rate (HCUR) in many areas being monitored nationwide remains below 50 percent which is considered low risk.

The NCR's HCUR is 28.4 percent; Aklan, 8.6 percent; Baguio City, 14.2 percent; Batangas, 35 percent; Bohol 63.6 percent; Cavite, 29.2 percent; Cebu City, 39.6 percent; Davao City, 26.3 percent; Guimaras, 44.6 percent; Iloilo 45.5 percent; Iloilo City, 40.1 percent; Laguna, 28.3 percent; Lucena, 44.2 percent; and Rizal 38.9 percent. CHED lifts ban on new nursing program, welcomes HEIs application



Higher Education Institutions (HEIs) may submit their application starting July 14 to reopen new nursing programs, as the Commission on Higher Education (CHED) announced the lifting of a decade-long moratorium on Wednesday.

In a virtual presser, CHED Chairperson Prospero "Popoy" De Vera III said they came up with the decision on Tuesday following their comprehensive assessment initiated during the height of the coronavirus disease (Covid-19) pandemic.

"Yesterday, the Commission en banc after a very thorough review and study of the moratorium on nursing, decided to lift the moratorium on nursing, based on an exhaustive discussion," he said.

De Vera said the CHED has carefully considered the supply and demand of nurses according to the United Nations Sustainable Development Goals (UN SDGs).

As of now, a total number of 201,265 job positions for nurses must be filled nationwide, implying a huge gap between the UN SDGs ideal number of 300,470 nurses, far higher than the actual number of nurses in the Philippines, of around 90,205.

But despite criticisms from several lawmakers and stakeholders, the CHED defended the timing of the lifting, saying they have to address issues that have caused the moratorium in the first place.

De Vera recalled issues such as the oversupply of graduates with around 200,000 unemployed nursing graduates; gradual decline of the performance of nursing education graduates in the Nurse Licensure Examinations (NLE); proliferation of HEIs offering BS Nursing Programs, some barely reaching the standard passing rate of 30 percent; and worst, students paying for hospitals just to be trained, due to a lack of affiliations in base hospitals.

"If you immediately lift it, you might go back to the same situation before 2011, and that situation is of crisis proportions at that time, so we have to be very careful about lifting the moratorium, and we must ensure that the problems encountered before, will not happen now," he said.

Moreover, De Vera noted that the CHED will now allow Department of Health (DOH) Level 2 accredited hospitals to be affiliated as base hospitals or training facilities for students.

"We are being more flexible in the opening of new programs by allowing Level 2 DOH accredited hospitals that can become the training hospitals of HEIs that have nursing programs, because of the need for more nursing students and graduates," he said.

But the CHED clarified they will be strict in considering these applications to ensure the problems encountered before the moratorium will not happen again, as well as to supply an adequate number of licensed nurses, especially in the regions in need of more Nursing HEIs.

These include MIMAROPA (Mindoro, Marinduque, Romblon, Palawan), Eastern Visayas, CARAGA, BARMM (Bangsamoro Autonomous Region in Muslim Mindanao), CAR, and SOCCSKSARGEN, which are all under Code Red, meaning in urgent need of nurses.

"We will not prioritize. We are lifting the moratorium in all areas, but the color-coding will alert the universities that when they apply for the new nursing programs the probability that the nursing programs will be approved is higher in the areas where there is really a need. For example, there are areas where we lack base hospitals for them to train. So unless they have base hospitals, we cannot allow them to open nursing programs because their students will not have a place to train,"

Classified under Code Yellow or High Level are CALA-BARZON (Cavite, Laguna, Batangas, Rizal, Quezon), Western Visayas, Bicol Region, Davao Region, Cagayan Valley, and Central Luzon, while the rest remains under Code Green or with a low-level demand.

In 2011, the CHED imposed a moratorium on new nursing programs for HEIs. Since then, several HEIs which can't attain at least a 30 percent passing rate for the NLE for three consecutive years were shut down, which eventually lead to the increase in passing rate which is not at 58.06 percent for the year 2021. DepEd eyes Nov. 2 start of mandatory in-person classes

The Department of Education (DepEd) said Tuesday that mandatory classes for all public and private schools nationwide will start by November 2, to ensure educational recovery in the country.

In a virtual press briefing, DepEd Undersecretary Epimaco Densing III said schools will be given options of in-person, blended, or full-distance learning only until October 31. But after this, all enrolled students will be required to attend face-to-face classes, under DepEd Order (DO) 034, series of 2022.

"This is mandatory, they are all required to go to school and the mandate is really to eventually go face-to-face. Everybody who's enrolled should abide by the Department Order, parents are also encouraged to ensure that their students go to school. Again, we're trying to do some educational recovery," he said.

Densing said the DO will be generally applied, regardless of the alert level status.

"Regardless of the alert level, we will move or go on with the face-to-face classes. However, we will now leave it to the Interagency Task Force for the Management of Infectious diseases, that if there is such a surge, and the Department of Health would eventually recommend that we go to a, that we cease to do the face-to-face class because of a surge, we will just follow, the decision of the IATF," he said.

But some parents expressed skepticism over the "mandatory" approach considering the possible surge of infections. Like, Jeanet Bares, a 46-year-old mother of six kids in Cavite.

"What if 'yung city kung saan nakatira ay nagpanukala na tataas 'yung Alert Level 2, or 3, or 4. Hindi mo naman mapapayagan palabasin ang mga bata sa isang lugar na tumataas naman ang Covid-19 cases. Hindi rin, dahil hindi pa 100 percent vaccinated ang ilan sa mga kababayan natin, mas mabuti na mag-set nang maayos na protocol na ipatutupad para maging maayos at safe ang lahat," she told the Philippine News Agency.

(What if the city where the [learners] are residing imposed the heightening of alert level status to 2, 3, or 4, you cannot just let kids go out despite the increasing Covid-19 cases. I'm also not in favor since some of our fellows are not 100 percent vaccinated, it's better to impose an appropriate protocol where all will be in order and safe.)

However, Maricel Estoque, a 43-year-old mom, said this move will be helpful to her three children, given the long halt of their in-person learning setup.

"Mas okay sa akin na maibalik na ang face-to-face class, kasi honestly for the past two years wala talaga natutunan ang mga bata, dahil walang formal and proper learning. Especially mga grade schoolers and not all parents ay may kakayahan or may time na maturuan ang mga bata. Unlike 'yung everyday na papasok sila sa school na teacher ang magturo sa kanila which is sila talaga ang may ability na ituro ang mga lesson sa bawat subject," she told the PNA.

(For me, it's better to get back to face-to-face class[es], because honestly for the past two years, the children barely learn a thing, because there's no formal and proper learning. Especially for

grade-schoolers and not all parents are capable or able in time to teach their children. Unlike the setup [kids] will go to school every day where the teachers will be the one teaching them, having the ability to discuss every lesson in every subject.)

Moreover, the DepEd said it would no longer demand additional requirements from schools before they could resume with a five-day in-person class setup.

"We would like to note that there will be no inspections, tools, or any additional requirements to reopen schools, and to implement five-day in-person classes which will be required, except for the compliance with the usual pre-pandemic regulatory permit and licenses, as required by law or ordinances," Densing said.

He also assured that the regional offices will be provided with the funds needed to ensure the safe reopening of face-to-face classes, but it will be up to the regional offices to set strategies for the capacity of learners per classroom.

"We have directed our regional directors to determine and to ensure there is social distancing within the classroom. I believe the capacity of the rooms really varies, there are rooms that have seat capacity, there are rooms that are in, 30s, or 20s, and then we leave it to the determination of the regional directors just to ensure social distancing within the classroom," he said.

On Monday, the DepEd released DO 034, stating that the 203 days of Academic Year 2022-2023 for public schools will begin on August 22, 2022 (Monday) and will end on July 7, 2023.

Meanwhile, the schedule of official enrollment for all levels starts on July 25 until August 22. (PNA)
