MWAP President Mary Ann Castillo said they will attend the public consultation with other minimum wage earner workers in the region to reiterate their petition on the minimum wage

She also appealed to RTWPB IV-A to approve their petition which would help workers meet their families' needs given the prevailing family living wage.

"Sana aprubahan na ng RTWPB ang aming petisyon dahil hindi lamang ito basta lang ginawa naming yung amount na ito, actually dapat nasa family living wage kasi kung talagang titingnan masyado nang mababa ang minimum wage," Castillo said. She said the wage increase would help maintain vibrant economic opportunities in the region and generate more jobs as workers would not need to migrate to other areas to access better employment opportunities.

"Sana pakinggan ng RTWPB ang aming petisyon dahil nakikita naman na madaming manggagawa na nandito sa CALABARZON para hindi na pumupunta sa ibang bayan o bansa para lang humanap nang trabaho kasi nandito na yung mga economic zones, so sana tingnan nila 'yon," she added.

Meanwhile, Soriano said the Department of Agriculture, Department of Energy, and the Bureau of Internal Revenue will also join the wage hike consultations.

Other public consultations are set in Quezon on July 18; Cavite (July 21); Rizal (July 26); and Laguna (July 31). Soriano said after the public consultations, the wage board would hold a deliberation and decide on the wage hike adjustment.

Soriano called for active public participation during the series of consultations.

"Inaasahan po namin ang inyong active participation pagdating dito sa ating gagawing talakayan on minimum wage issue sapagakat ito naman po talaga ay dapat din nating pag-usapan hindi lang po basta sa kapakanan ng ating workers para din naman po sa kapakanan ng ating employers," he added.

The last wage adjustment in the region was approved in 2022, which ranges from P350 to P470 depending on the workers' category.

The prevailing minimum wage is at P470 for non-agricultural workers; P429 for agricultural workers; and P350 in retail and service establishments with not more than 10 workers. (AM, PIA4A)

PBBM launches green lanes for ease of doing business to boost FDIs

President Ferdinand R. Marcos Jr. expressed on Thursday his unwavering confidence in the potential of Green Lanes for Strategic Investments to significantly enhance foreign direct investments (FDI) in the Philippines.

The President's remarks came during the official launch and covenant signing of Executive Order (EO) No. 18, which creates Green Lanes in government offices to facilitate the processes in materializing investments.

"I am confident that the Green Lanes will pave the way for the realization of many pledges that we have had—including those that I have personally received whilst abroad—ensuring that they will bear fruit for our people and our nation," President Marcos said during the event held in at Sofitel in Pasay City.

The President said EO 18 is the result of continuing consultations with the business sector, stressing its importance to strengthen market competition and reduce barriers to invest-

"We gave this a particular priority because upon listening to our prospective investors, this was one of the areas where they felt we could do better and would improve the investment climate in the Philippines and that is why we have now undertaken this measure under EO 18," he said.

Issued on 23 February 2023, EO 18 is part of the Marcos administration's eight-point agenda, which mandates all government offices, including the local government units (LGUs), to expedite the processes involved in the issuance of permits, licenses, and certifications required to implement in-

The policy also directs the Board of Investments' One-Stop Action Center as a Single Point of Entry further ensuring efficiency and ease of doing business in the country.

"It is, indeed, long overdue to have reforms that will not only attract more investments into the country, but will also create an environment conducive to business growth and development," Marcos said.

The President also highlighted the introduction of e-Invest, an online platform that expedites the submission and processing of investment applications. This platform grants Provisional Permits to Operate, allowing investors to commence operations while awaiting full approval.

The Department of Trade and Industry (DTI) said that around US\$88 million of investment pledges from the President's foreign trips are expected to materialize this year, generating 17,800 direct employment.

This is out of the Php3.5 trillion worth of investment leads from various countries that include Singapore, Indonesia, Japan, China, Thailand, the US and Europe.

DTI Secretary Alfredo Pascual also announced during the launch that Sun Asia Energy is the first investor with a certificate of endorsement for green lanes. SunAsia Energy will set up floating solar panel on Laguna Lake to produce 1.3 GW of power. PND
