ucation institutions (HEIs) to offer nursing courses. It is really about time, especially with the lessons learned from our handling of the COVID-19 pandemic," Escudero pointed out.

"Malaking hamon noong kasagsagan ng pandemya ang kakulangan natin sa mga health workers, kabilang na ang ating mga nurses. We are still in a pandemic and we will be needing more medical workers. That is why we have to start rebuilding our workforce now so we don't have to go through the same harrowing experience should another health crisis comes," he added.

Last Thursday, the HEIs were allowed to submit their applications to CHEd following Chairman de Vera's announcement on July 13 that the institution has decided en banc to lift the ban after a "very thorough review based on an exhaustive discussion."

It will be recalled that in 2011, during the administration of President Benigno C. Aquino III, the CHEd imposed the moratorium due to, among others, the oversupply of nursing graduates with over 200,000 unemployed nurses.

"This moratorium which was imposed in 2011 has been reviewed at the height of the pandemic when there were calls to lift the moratorium on nursing because of the perceived lack of nurses especially at the height of COVID," said De Vera on Wednesday.

Aside from the perceived lack of healthcare workers, the Commission lifted the ban due to unequal distribution of HEIs offering nursing programs across the country's regions, like the Caraga Administrative Region where only three private HEIs offer nursing out of the 333 total HEIs across the country.

Escudero said he intends to look at the current state of the country's higher education when he assumes the chairmanship of the Committee on Higher, Technical and Vocational Education when the 19th Congress

formally opens on July 25.

In the 17th Congress, the senator sponsored Republic Act 10931, or the Universal Access to Quality Tertiary Education Act, that allowed free tuition and other school fees in state universities and colleges, local universities and colleges accredited and recognized by the Commission on Higher Education, and state-run technical-vocational institutions.

This year's theme, 'Sambayanang Pilipino, Nagkakaisa Tungo sa Katatagan at Maunlad na Kinabukasan, anchors on President Ferdinand Marcos Jr.'s call for uniactions and decisions in disaster resilience.

"Itong disaster resilience ay isa sa mga development indicator na tinitingnan sa international framework ng Development Sustainable Goals, gayundin sa Philippine Development Plan," Reyes said.

As Secretariat of the Calabarzon Regional Disaster Risk Reduction Management Council (RDRRMC), the OCD Calabarzon lined up various activities in the national and regional levels, starting with a kick-off ceremony last July 1.

The OCD Calabarzon also launched a webinar series focusing on Disaster Prevention and Mitigation, Climate Change Adaptation, Smart and Resilient Urban Cities, and Risk Financing, that local Disaster Risk Reduction Management Offices, organizations, and the private sector can watch for free via Facebook.

Among the activities lined up for this month, the OCD Calabarzon also launched a webinar on inclusive disaster response for Persons With Disabilities (PWD). #### **PETITION**

PETITIONER, by counsel, to this Honorable Court, respectfully aver:

#### **FACTS OF THE CASE:**

- 1. Petitioner is a Filipino, of legal age, with current residential address at Block 18, Lot 34, Oak Street, Lancaster Village, Phase 2, Alapan II-A, Imus City, Cavite, 4103 evidenced by his Barangay "Certificate of Residency" for at least six (6) months prior to the filing of the instant petition, his utility billings, showing his correct and current address, sketch plan duly authenticated by petitioner, Google map showing his address location, "Affidavit" of petitioner's Counsel certifying that he himself verified former's address and that it is his true and current residence, and other proof of petitioner's residency at his afore-stated address, all hereto attached as Annexes "A" series and made an integral part hereof;
- 2. Respondent DOREEN KOSASI is of legal age, an Indonesian national, with known address sometime in 2013 by herein petitioner at Pekanbaro, Indonesia, and last known Philippine address at Felizana Subdivision 1, Daang Hari, Molino V, Bacoor, Cavite as last seen in August 11, 2014, thus service of summons by publication is hereby submitted as proper in the instant case:
- 3. Sometime in 2011, petitioner's sister, Ms. Maricel Be-Ionio was working as Executive Sales Representative in a company in Singapore, and who had a lesbian relationship with her live-in partner in the person of the respondent DO-REEN KOSASI, who was also working as a quality control personnel in a Singapore.
- 4. Herein petitioner was invited to visit the lesbian couple in Singapore and possibly find a job there;
- 5. For herein petitioner to be able to stay and work in Singapore, the only legal means is to simulate a marriage between herein petitioner and respondent, but not to live together as husband and wife under one roof.
- 6. The simulated marriage was without a marriage license but somehow they had a simulated certificate, a copy of the is hereto attached as Annex "B", but the understanding was that these were all for Singaporean immigration status purposes only so plaintiff will not be deported to the Philippines beyond 14 days as a tourist.
- 7. Sometime in the middle of 2014, when petitioner's sister Maricel, decided to go back to the Philippines, while herein petitioner was already gainfully employed in Singapore, while the lesbian couple decided be live together in the Philippines;
- 8. The lesbian couple then lived and resided at Felizana Subdivision 1, Daang Hari Road, Molino V, Bacoor, Cavite.
- 9. However their relationship did not last, and petitioner's sister Maricel went to the United States of America to find a new job and abandoned her lesbian partner in the Philippines and since then respondent Doreen Kosasi in nowhere to be located by herein petitioner.
- 10. When herein petitioner came back to the Philippines. he realized, his simulated marriage was registered by the respondent, per PSA certificate Annex "C" hereof, so he attempted to locate defendant's whereabouts when she was nowhere to be found at her last known address at Felizana Subdivision 1, Daang Hari Road, Molino V, Bacoor, Cavite.
- 11. In the year 2020, petitioner published in the newspaper of general circulation, the "Manila Bulletin" attempting

to locale the whereabouts of the respondent, a copy of the publications dated March 14, 20, and 27, 2020 as well the Manager's "Affidavit of Publication" dated July 24, 2020 are respectively attached hereto as Annexes "D" series;

- 12. Petitioner through counsel, in fact searched for expert opinion, even from the Center for National Mental Health regarding the respondent's PERSONALITY STRUCTURE, based on her sexual orientation, actuations and attitudes and discovered that the root cause of her psychological incapacity to enter into marriage with a man, was genetics and environment commencing from her childhood deeply ingrained, continuing up to present and incurable in nature;
- 13. Parties have not accumulated any property that may be considered communal or conjugal in nature even under the regime of absolute community as they never lived together as husband and wife under one roof;
- 14. When the parties entered into a contract of marriage in Singapore, there never was the essential element of 'consent' freely given by either party to live as husband a wife, because it was all simulated for the plaintiff to secure a gainful employment in that foreign country, consequently, and they did not have a "marriage license", another essential element in this marital union.

#### STATEMENT OF THE RELEVANT LAW & JURISPRUDENCE:

- 15. Consequently, by the reason of this continuing, clinically identifiable and incurable psychological incapacity of the respondent, present but not evident at the time of her marriage to the petitioner, the marriage entered into by the parties is null and void from the very beginning and the petitioner is entitled to a declaration of nullity of his marriage to the respondent under Art. 36 of the New Family Code.
- 16. As marriage is a special contract, their terms and conditions are not merely subject to the stipulations of the contracting parties but are governed by law as the New Family Code provides for the essential (Art 2) as well as formal (Art. 3) requisites for the validity of marriage and the absence of any of the essential or formal requisites shall render the marriage void ab initio, except as stated in Article 35 of the New
- 17. A marriage license shall be issued by the local civil registrar of the city or municipality where either contracting party habitually resides, except in marriages where no license is required. (Republic v. Dayot 573 Phil. 553,569 (2008)
- 18. Under the New Family Code, specifically Art. 45 states that a marriage may be annulled for any of the following causes, existing at the time of the marriage:
- X x x (3) That the consent of either party was obtained by fraud, unless such party afterwards, with full knowledge of the facts constituting the fraud, freely cohabited with the other as husband and wife;
- (4) That the consent of either party was obtained by force, intimidation or undue influence, unless the same having disappeared or ceased, such party thereafter freely cohabited with the other as husband and wife;
- (5) That either party was physically incapable of consummating the marriage with the other, and such incapacity continues and appears to be incurable; x x x x
- 19. Furthermore, under Art. 35, the following marriages shall be void from the beginning:
- $x \times x \times x(3)$  Those solemnized without license, except those covered the preceding Chapter;
- 20. In Art. 2 it says that no marriage shall be valid, unless these essential requisites are present:
- X x x (2) Consent freely given in the presence of a solemnizing officer. While Art. 3 provides the formal requisites of marriage namely:
- x x x x(2) A valid marriage license except in the cases provided for in Chapter 2 of this Title; and x x x x
- 21. In the case of REPUBLIC OF THE PHILIPPINES, Petitioner, vs. JOSE A. DAYOT, Respondent, the Supreme Court declared, (3rd Div G.R. No. 175581, March 28, 2008) as penned by Justice CHICO-NAZARIO, that the Civil Code makes it clear that a marriage performed without the corresponding marriage license is void, this being nothing more than the legitimate consequence flowing from the fact that the license is the essence of the marriage contract. This is in stark contrast to the old Marriage Law, whereby the absence of a marriage license did not make the marriage void. The rationale for the compulsory character of a marriage license under the Civil Code is that it is the authority granted by the State to the contracting parties, after the proper government official has inquired into their capacity to contract marriage.
- In accordance with Section 6 Rule 7 [2019 AMEND-MENTS TO THE 1997 RULES OF CIVIL PROCEDURE (A.M. NO. 19-10-20-SC)] petitioner further state that:
- 22. Petitioner and his witness will testify and corroborate his testimony on the simulation of the marriage contract, lack of consent to a real marriage, lack of marriage license, absence of a single minute of cohabitation, and the psychological incapacity of the respondent to enter into a contract of marriage at the time of its celebration;
- 23. Psychologist Visitacion Revita will also testify on the clinical aspect of herein disability which is incurable permanent as she clinically diagnosed with her recommendation that the marriage of the parties be declared void ab initio, among others.
- 24. Herein witnesses hereby attached their respective judicial affidavits and the documentary and object evidence in support of the allegations contained in the pleading;
- 25. That this pleading is not filed to harass cause unnecessary delay, or needlessly increase the cost of litigation; and
- 26. The factual allegations herein have evidentiary support or, if specifically so identified, will likewise have evidentiary support after a reasonable opportunity for discovery or during trial.

#### **PRAYER**

WHEREFORE, premises considered, it is respectfully prayed that judgment be rendered declaring that the marriage contracted by the herein parties to be void ab intio in accordance with Art. 35 and 36 of the New Family Code. Other relief just and equitable under the premises are likewise prayed for.

# Region I invention contest winners share experiences in Tekno Presyensya radio program



The Department of Science and Technology Region I (DOST-I), together with DZAG Radyo Pilipinas Agoo, featured the National Invention Contest and Exhibits (NICE) winners on their weekly radio program titled Tekno Presyensya: Syensya ken Teknolohiya para kadagiti Umili, last 7 July 2022.

The program's first segment showcased the accomplishments of the regional and provincial S&T offices in the areas of Kabuhayan, Kaayusan, Kalusugan, and Kinabukasan.

On the other hand, Eilleen Fernando of the DOST- Technology Application and Promotion Institute (DOST-TAPI) gave a general description of NICE, its categories, and how it differs from the biennial Regional Invention Contest and Exhibits (RICE).

As a testimonial to the importance of the contest, Prof. Zaldy Fernandez of

Mariano Marcos State University (MMSU), who won the UNLAD AWARD for Outstanding Utility Model, shared his experience with the development of his Multi-Fuel Dryer.

The term "multi-fuel dryer" refers, broadly speaking, to dryer equipment or machines that use a variety of fuels, including wood, charcoal, sawdust, rice hulls, maize stalks, sugarcane stalks, coconut shells, and the like. The aforementioned tool is used to dry fish, fruits, cereals, leaves (including malunggay and tobacco leaves), garments, and baked goods. Although it is built, constructed, and manufactured as a dryer, it can also serve as an oven and/or a multi-fuel dryer to process various materials via heat convection.

On the other hand, Charissa de Vera, a faculty researcher at the Pangasinan State University (PSU) discussed their team's winning

entry under the Creative Research Category which won 3rd place. Their winning entry titled, "Optimization of Mung bean milk-based Mango Beverage", is a lactose-free, milk-based drink derived from a blend of mungbean and mango.

According to the researcher, the team did not innovate the products on the first try; rather, they underwent several trials and mistakes to polish and achieve the greatest output possible.

Both guests also shared their difficult journeys and revealed the secrets of their success including determination, devotion, commitment, and compassion.

During the program, DOST Region I hailed the contest winners for their innovativeness and creativity lead and encouraged budding inventors to first participate in RICE next year, and if their entries win, they can aim for national recognition under NICE in 2024.

# CALAX Silang Interchange to open before 2022 ends
