### **Bailen RHU** reports town's Zero **Active Case**

GEN. EMILIO AGUI-NALDO-BAILEN, Cavite Jul 20 (PIA) -- The Rural Health Unit (RHU) here reported the town remained without an Active COVID-19 case as of yesterday.

The town reached the Zero Active case status on July 15, 2020 after Patient#5 tested negative with the RT-PCR (Real Time-Polymerase Chain Reaction) test and discharged from the De La Salle Medical Center.

The COVID-19 cumulative report as of yesterday showed 5 - Confirmed cases, 0 - Active cases, 2 - Probable cases, 95 - Suspect cases, and 71 tested negative.

AM Oreta and China Harbour welcome the partnership with CIC and the PRA.

"We are happy to work with CIC and the PRA in helping the Philippine economy by means of faster and convenient land travel," said Mr. Chu.

Likewise, Mr. Santos of AM Oreta shared the same insight saying, "This collaboration will alleviate the plight of the motoring public by easing vehicular movement in several key economic areas." Public Works & Highways Sec. Mark Villar; Parañaque City Mayor Edwin D. Olivarez; Parañaque City First and Second District Representatives Eric D. Olivarez and Joy Tambunting; Atty. Janilo Rubiato, PRA General Manager, and Mr. Rodrigo E. Franco, President of Metro Pacific Tollways Corporation (MPTC) were among the VIPs in attendance in the event.

The Cavitex C5 Link Expressway is a 7.70 kilometer dual three-lane expressway that runs from R-1 Parañaque Toll Plaza to C-5 Road in Taguig with Segment 2, a 1.9 kilometer expressway that will run from R-1 Expressway to Sucat Interchange while Segment 3A-2 is the 1.6 kilometer expressway that will run from Merville to RSG Subdivision in Parañaque.

These segments are expected to be completed by the second quarter of 2022 and anticipated to reduce travel time to Makati and Taguig cities from the cities of Parañaque, Las Piñas, and Cavite province by 30 minutes, and play a huge role in economic development.

DPWH Sec. Mark Villar said, "These projects will decongest EDSA and Sales Road in Pasay City by about 50,000 vehicles per day, and connect major business districts in Taguig and Makati to Parañaque, Las Piñas, and Cavite."

"Continuing with BBB (Build, Build, Build) activities will help spur economic growth to get us back on track from the effects of the pandemic," Villar added.

MPTC officials Mr. Franco and Mr. Bontia highlighted the significant benefit the completion of these projects will bring to the economy and to the country as well. Mr. Franco said, "These new segments will play a huge role in our national recovery, as we continue to seek ways to help the Filipino people cushion the impact of COVID-19." Similarly, Mr. Bontia shared, "Once operational, Segments 2 and 3A-2 of CAVITEX C5 Link Expressway will help provide fast, safe, and efficient movement of people and goods, and create at least 1,000 new jobs in construction, operations and maintenance." # PH already in line for **COVID-19 vaccine** Romualdez

Philippine Ambassador to the United States Jose Romualdez said the government is already in talks with pharmaceutical different companies and drug laboratories regarding the procurement of a vaccine against COVID-19.

To this end, Romualdez said they already initiated talks with Pfizer, Johnson and Johnson, and Moderna.

"We are lining up once it's available for export. At

least we are already there," Romualdez said on Tuesday during a Laging Handa brief-

"They'll mass produce this and try to produce as many as possible because this is a full cooperation of all countries bonding together," he added.

Last June, US Defense Secretary Mark Esper reportedly promised his Filipino counterpart, Delfin Lorenzana, of Washington's

willingness to share their vaccine once available. On Tuesday, the Chinese Embassy in Manila assured that China will give priority to the Philippines once its own COVID-19 vaccine is ready.

"When the COVID-19 vaccine is developed and put into use, China will give priority to providing it to the Philippines, as a global public good," Chinese Ambassador to Manila Huang Xilian said in a statement.

being the lead implementor of the SAP 2, the agency is exhausting all means to ensure that the digital and manual distribution of the second wave of subsidies to 17 million beneficiaries, including the "waitlisted" recipients will be completed by July 31.

(We admitted that there have been challenges in the implementation of the second tranche of SAP. We would like to inform that we had transition from the first tranche wherein we tasked, we asked the assistance of the local government units to distribute the cash aid. If we look at it, in terms of workforce, personnel, the local government can possibly tap many personnel.)

In the second tranche, DSWD leads the distribution of the aid, with the adoption of innovative solutions through the help of our financial service providers, Bautista said.

However, he said the adoption of the DSWD to this new innovation is not that fast. Nevertheless, the agency is trying to expeditiously distribute the second tranche of SAP, he assured.

Last June 30, the DSWD signed a memorandum of agreement (MOA) with the Land Bank of the Philippines (LBP) and six FSPs identified by the Bangko Sentral Pilipinas (BSP)- GCash, RCBC, Robinsons Bank, PayMaya, Starpay, and Unionbank for the digital payment of SAP

Bautista said for those geographically isolated and disadvantaged areas (GI-DAs), conflict-affected areas, and those areas where FSPs do not have payout partners, the distribution of the financial assistance will be completed "not beyond" August

He noted that based on the DSWD's July 20 SAP monitoring data, the DSWD has distributed P24.4 billion worth of emergency cash aid to over 3.5 million families or 20.5 percent of the 17 million beneficiaries targeted by the

Among those who already received the SAP 2 grants are 1.3 million beneficiaries of Pantawid Pamilyang Pilipino Program (4Ps), 1.1 million non-4Ps households and over 1.1 million "waitlisted" beneficiaries.

Bautista appealed to the public to continuously have faith in the government amid the delayed distribution of

The 11 areas covered by the SAP 2 distribution are Benguet; Pangasinan; Region III (except Aurora Province); National Capital Region (NCR); Region IV-A (CAL-ABARZON); Albay Province; Iloilo; Bacolod City; Cebu Province; Zamboanga City; and Davao City.

A total of two hundred thirty-seven farmer beneficiaries were recorded during the event.
