Atty. Khervy B. Reyes, Officer-In-Charge of PCLE-DO, welcomed everyone and expressed his gratitude to all the individuals who took part in the said program. In his opening message, Mr. Alvin S. Mojica, Provincial Administrator for Community Affairs shared that the program was initiated by the Provincial Government through PCLEDO as a response to the impacts of the pandemic and to help the affected sector.

The program proper was divided into two sessions - the first one was the discussion and sharing of insights regarding financial, digitalization, modernization and

adaptation of businesses. Ms. Alda Lou Cabrera, RCBC Senior Relationship Manager, propagated the concept of digitalization through RCBC's Diskartech program and how it can help businesses especially in the new normal. According to Ms. Cabrera, digital transformation drives financial inclusion and financial inclusion, in return, fuels digital transformation.

Subsequently, Ms. Mary Grace Pagtalunan and Mr. Dennis Chua, Sales Executives of Jyosna, introduced business process automation that would help cooperatives save time, reduce cost of operation, reduce human error, make the work more flexible and be more profitable. Ms. Pagtalunan emphasized the need to adapt to the changes.

Mr. Dennis G. Magbatoc, AVP/Regional Head of PLDT enterprise, underscored the importance of technology in business ventures and the need to adopt new ways of engagements. On the other hand, Ms. Melissa Lim, Marketing Officer of Metro South Cooperative Bank, tackled payment checking account, while Mr. Frederick Gatchalian, Cooperative Lending Department Head, presented the Loans and Financing services that they offer including Term Loan, Revolving Credit Line, Back-to-Back, and the MSCB Modernized Jeepney Fleet Financing that will be launched soon.

On the second part of the program, Mr. Joey Espiritu, owner of 621 Food Chow, Tent King and Manang A's Catering, shared the story behind the success of his businesses and how they got back on track after being affected by the pandemic.

Then, Ms. Katrina Sunglao, Business Specialist of Nutri Asia, presented the Negosyo Center Packages like pizza, takoyaki and burger that could be a starter for aspiring entrepreneurs. Same goes with Mr. Kevin Hernandez, Sales Specialist of Oleo Fats, who showcased the business products and concepts that they are offering for a start-up business.

Highlight of the event was the talk by Mr. Jorge Noel Y. Wieneke, Immediate Past President of Association of Filipino Franchisers, Inc., who stressed the importance of franchising and imparted that the concept of a franchise should be accepted by the market. He imparted the SBA principle - see clearly, believe in oneself and act on it in order to achieve the dream. Afterwards, Mr. Jaypee Morales, AFFI President, alongside with Mr. Nico Manquil and Mr. Mike Gamez talked about their experiences in franchising.

Duterte orders << P1

The dissolution order was contained in a memorandum signed by Executive Secretary Salvador C. Medialdea on June 23, ending the corporate life of First Cavite Industrial Estate, Inc., (FCIEI), which was registered with the Securities and Exchange Commission in 1990.

The estate was originally a joint venture of the National Development Co. (NDC) and partners. NDC became the sole owner in 1999.

"After completion of the development of the NDC property, which served as the FCIEI's sole industrial estate project, the Board of Directors of the NDC deferred the dissolution of FCIEI considering that it may be used to develop another property of the NDC," according to the memorandum.

The abolition of the company was recommended given that the intention for the FCIEI to undertake another development project did not materialize, the memorandum read. "[It] was approved in principle in 2015, with the condition that the FCIEI's liabilities, particularly to the Philippine Economic Zone Authority (PEZA), are settled."

It said that through a Memorandum of Agreement

dated March 7, 2016, the FCIEI and PEZA agreed on the partial settlement of the former's obligations to the latter.

The Governance Commission for Government-Owned or -Controlled Corporations (GCG) recommended the abolition of the FCIEI after determining that "its original purpose is no longer relevant to the State and it is no longer achieving the objectives and purposes for which it was originally designed and implemented," according to the memorandum.

The GCG added that the FCIEI was not cost efficient and is involved in an activity "best carried out by the private sector."

"The assets of the FCIEI shall be liquidated to settle the outstanding liabilities of the corporation," according to the memorandum. "The remaining assets and/or liabilities of the FCIEI shall be assumed by its parent company, the NDC."

In the memorandum, Mr. Duterte ordered the creation of a technical working group to oversee the settling of liabilities, liquidate of its assets, and assist in the winding-up of its corporate affairs. — Kyle Aristophere T. Atienza
