# **CCCC** to bid anew for Sangley airport

State-owned China Communications Construction Co. Ltd. (CCCC) has again expressed its interest in developing the Sangley Point International Airport (SPIA) project in Cavite after earlier losing the airport deal which was awarded to the company and its local partner MacroAsia Corp.

Cavite Gov. Jonvic Remulla said four companies have bought the bid documents for the SPIA: CCCC, Metro Pacific Investments

Corp. (MPIC), Philippine Airport Ground Support Solutions Inc. (PAGSS) and Mosveldtt Law Office.

Both MPIC and PAGSS were among the companies that purchased bid documents for the SPIA project during its first auction in 2019, but did not submit an actual bid.

This time around, MPIC chairman Manuel V. Pangilinan earlier told The STAR that the group is "interested in principle," but still has no commitments at the moment

CCCC and partner MacroAsia won the first bidding for the SPIA project, submitting the sole bid.

The airport deal awarded to the consortium, however, was terminated in January

due to the various deficiencies of the submission of requirements to conclude the joint venture agreement, prompting the provincial government of Cavite to start anew with its search for a

It is unclear if CCCC will still partner with MacroAsia should it decide to submit an offer.

CCCC had a 60 percent stake in the earlier consortium while MacroAsia held the minority 40 percent.

The STAR earlier reported that the provincial government of Cavite has finetuned a legal qualification requirement to address national security concerns in its search for a new partner for



la, Nueva Vizcaya, Quirino, Batangas, Quezon, Ilagan City, General Santos City, Sultan Kudarat, Sarangani, Cotabato, South Cotabato, and Cotabato City until July

Meanwhile, Duterte also placed Cagayan, Apayao, Bataan, Lucena City, Puerto Princesa, Naga City, Iloilo City, Iloilo, Negros Oriental, Zambaogan del Sur, Zamboanga del Norte, Cagayan de City, Dumagat Islands, and Surigao del Sur under stricter modified enhanced community quarantine (MECQ) from July 1 to 31.

Davao Oriental, Davao Occidental, Davao de Oro, Davao del Sur, and Davao del Norte are also under MECQ but only up to July 15.

The rest of the country will be placed under modified GCQ.

Presidential Spokesperson Harry Roque said gyms/ fitness centers at 40 percent capacity and other indoor sports courts at 50 percent Metro Manila, Rizal and Bulacan but not in other areas of NCR Plus like Laguna and Cavite. He said 40 percent capacity for historical sites and museums will also be allowed in the NCR Plus areas except in Laguna and Cavite.

The non-contact sports are allowed in GCQ and MGCQ areas while individual outdoor exercises are allowed within the general areas of their residence in MECQ places. Roque said outdoor dining (Al fresco) with 50 percent capacity will be allowed in GCQ and

capacity will be allowed in MGCQ but not in MECQ

He added that indoor sports courts and venues as well as indoor tourist attractions can operate up to 50 percent capacity GCQ areas but should be closed in MECQ places as well as in Laguna and Cavite.

Duterte reminded the public to strictly observe social distancing as well as the wearing of face masks and face shields outside their homes to prevent the spread of Covid-19 particularly the more infectious Delta variants. (PNA)

# **DENR** executive officers, Cavite Local Chiefs << P1

dersecretary for Enforcement Benito T. De Leon, DENR CALABARZON Regional Executive Director Nilo B. Tamoria, Provincial Environment and Natural Resources Officer (PENRO) of Cavite Ronita A. Unlayao, Cavite Governor Juanito Victor Remulla, and the Local Chief Executives on Thursday, June 25, 2021, at the Tanza Oasis Hotel and Resort, Tanza, Cavite. According to Secretary Cimatu, two (2) main problems in the province are the Solid Waste Management (SWM) and the water quality of the rivers. "The number one problem of the province when it comes to the environment is solid waste", Governor Juanito Victor Remulla emphasized. He disclosed that 21 out of 23 Local Government Units (LGUs) in Cavite do not have the capacity to put up their own solid waste facilities because of limitations of land area in the Province. Governor

Remulla pleaded to the DENR to put a national imposition for Provinces to establish their own sanitary and better managed landfill in the province. "50% of our solid waste, which is approximately 2,000 tons a day, goes to the rivers," added Governor Remulla.

DENR Usec Antiporda shared that they aim to implement a total solid waste management solution, where sanitary landfills, composting and recycling facilities, and residual diversion shall be established. With proper segregation we can effectively reduce our generated waste. He added that about 70% of our total wastes generated are biodegradable, while the other 20% are recyclables. USec Antiporda also shared their Strategic Mitigation Plan for downstream and upstream rivers in Cavite. They are targeting to install 30-meters victory trash traps to be installed

in downstream rivers, while PET bottles with wire mesh trash traps will be installed for the upstream rivers. "I am now appealing to all the concerned LGUs to strictly implement and enforce the RA 9003 (Ecological Solid Waste Management Act of 2000). Likewise, to also address the water quality issues of the bay, we encourage the LGUs to check environmental compliances of industries within your respective area of responsibilities."

Antiporda is also the Head of the Cavite Cluster Taskforce and Manila Bay Anti-Pollution Taskforce. In relation to the water quality of the rivers in Cavite, DENR CALA-BARZON Regional Executive Director Nilo B. Tamoria disclosed that multiple sampling stations were established in Cavite to closely monitor its water quality. "Kinukumpleto po natin ang Geographic Information System ng buong cavite para makita ang mga

kasalukuyang sitwasyon ng bawat river system para sa kaukulang estratehiya na pagtutulungan ng pambansa at lokal na pamahalaan", he added. Mayor of Mendez, Atty. Fredderick A. Vida emphasized that the business sector should ensure sustainable packaging so as to minimize their contribution to wastes from single use plastics. The DENR has already proposed the Extended Producers Responsibility (EPR) to the legislative body.

According to USec Antiporda, with the EPR, manufacturers shall take the full responsibility for collecting and retrieving all the waste generated from their products. Secretary Cimatu proceeded to inspect various river systems including Maragondon River and the adjacent coastal areas. Participants underwent an RT-PCR antigen test prior to the conduct of the event. The IATF protocol was strictly observed throughout the meeting.

the SPIA project. The Cavite government is now requiring that its joint venture partner should be Philippine majority-owned and controlled, whether it be a single entity or a consortium.

If a consortium, the Philippine corporation should at least own and control 51 percent of the equity or voting interest.

The interested company or consortium should also have a net worth of at least \$1.6 billion or about P80 billion as part of the financial qualification requirement.

For the technical qualification requirement, the firm or consortium should have successfully built in the last 20 years at least one international airport development project with a minimum handling capacity of 12.5 million passengers per annum and at least one land reclamation development project.

The technical qualification requirement can be met either by the company itself, the members constituting the consortium, any of their affiliates or their nominated contractors.

The winning joint venture partner will be responsible for co-developing the airport project together with the province of Cavite, as well as provide the necessary equity investment, debt financing and credit enhancements.

# Quarantine status in July still subject to LGUs' appeal: Palace

Local government units (LGUs) still have until Monday night to appeal the quarantine classifications that will be imposed within their jurisdictions beginning July, Malacañang said on Tuesday.

"Ito po ay subject to appeal pa hanggang mamayang gabi po. Yung mga LGU na gustong mag-apela ay pupuwede po (The new quarantine status is still subject to appeal until tonight. LGUs who want to make appeal can do so)," Presidential Spokesperson Harry Roque said in an online press briefing.

This, after President Rodrigo Duterte announced in a pre-recorded Talk to the People on Monday night the recommended community quarantine classifications for the month of July.

Duterte said stricter modified enhanced community quarantine (MECQ) will be imposed in Cagayan, Apayao, Bataan, Lucena City, Puerto Princesa, Nagay City, Iloilo City, Iloilo, Negros Oriental, Zamboanga del Sur, Zamboanga del Norte, Cagayan de Oro City, the entire Davao region, Butuan City, Dinagat Islands, and Surigao del Sur until July 15.

On the other hand, general community quarantine (GCQ) "with some restrictions" in Metro Manila, Rizal, and Bulacan, and GCQ "with heightened restrictions" in Laguna and Cavite will be until July 15.

Baguio City, Ifugao, City of Santiago, Isabela, Nueva Viz-



caya, Quirino, Batangas, Quezon, Guimaras, Aklan, Bacolod City, Negros Occidental, Antique, Capiz, Zamboanga Sibugay, City of Zamboanga, Iligan City, General Santos City, Sultan Kudarat, Sarangani, Cotabato, South Cotabato, Agusan del Norte, Surigao del Norte, Agusan del Sur, and Cotabato City will be placed under GCQ for the whole month of July.

The rest of the country will remain under the least restrictive modified GCQ (MGCQ).

Roque said Duterte will not hold a second Talk to the People this week to announce the final quarantine classification in July.

He said members of the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF-EID)
